Medibank ordinary shares equivalent to any dividends that would have been received during the relevant deferral period if Medibank ordinary shares were held instead of the relevant performance rights. On exercise of those performance rights an additional 16,458 ordinary shares were provided to holders, of which the following were provided to KMP: David Koczkar (3,703 ordinary shares); Milosh Milisavljevic (1,897 ordinary shares); Mark Rogers (2,221 ordinary shares) and Robert Read (1,373 ordinary shares).
