Synertec Secures \$45.5m Major Engineering Services Contract with Australian Government Agency

Melbourne, Australia: Technology design, development and engineering growth company, Synertec Corporation Limited (ASX: SOP, “Synertec” or “the Company”) is pleased to announce it has been awarded a significant engineering services contract by an Australian Government agency (“the Agency”), whose identity is withheld at this time.

Highlights

- **Synertec has been awarded a significant engineering services contract by an Australian Government agency, whose identity is withheld at this time**
- **Contract value is \$45.5m over an 8 year program, with a majority of works occurring over the first 26 months**
- **Scope covers design development, detailed design and documentation deliverables, along with construction and commissioning support**
- **The project will not require material project related capital expenditure by Synertec**
- **Award is transformational for Synertec and provides revenue visibility through to FY35**

The contract encompasses the delivery of engineering services from design development through to detailed design and the preparation of Issued for Construction (IFC) documentation, supporting the Agency’s program of critical infrastructure works. Synertec will provide construction and commissioning support following the completion of design.

The contract value is \$45.5m with a majority of the works occurring over an initial 26 month term.

This award significantly strengthens Synertec’s engineering business and reinforces the Company’s position as a trusted partner to government sector clients for the delivery of critical infrastructure engineering services. It reflects Synertec’s ongoing commitment to supporting the design and delivery of critical infrastructure through advanced, reliable and technically excellent engineering solutions, and further strengthens the Company’s presence in the government and public infrastructure sector.

FY27 Revenue Guidance Update

Synertec is currently evaluating the impact of this contract on its FY27 revenue guidance. The assessment is being undertaken as part of the project mobilisation process, including confirmation of delivery schedules, resource profiles, commercial arrangements and revenue recognition milestones. The Company will provide an update to the market at the earliest opportunity once this review has been completed and sufficient certainty exists regarding the project execution profile.

Synertec's Managing Director, Mr. Michael Carroll, said:

"We are delighted to have been selected to contribute to this important program of works. This award is testament to the skill, ingenuity and professionalism of our engineering team, and reflects the confidence our government sector clients continue to place in Synertec to deliver mission critical, complex, infrastructure projects that will benefit all Australians for generations to come. We look forward to working closely with the Agency to deliver a world class outcome."
