(2) VALDOR GLOBAL FZCO, a company registered at Unit No: 3O-01-1389, Jewellery & Gemplex 3, Plot No: DMCC-PH2-J&GPlexS, Jewellery & Gemplex, Dubai, United Arab Emirates ("Valdor")

each a "party" and together the "parties"

Definitions

"Company" means Intelligent Monitoring Group Limited ACN 060 774 227

"Company Securities" means fully paid ordinary shares in the Company.

Background

- A. Each party holds Company Securities for investment purposes. The parties are separately owned, but their investment activities are administered in common.
- B. Investment decisions in respect of the Company Securities held by each party are, and have at all material times been, made by the same persons.
- C. The parties have had an understanding between them, not reduced to writing, as to the exercise of voting rights attaching to securities held by each of them. This agreement records that understanding in writing insofar as it relates to Company Securities. It does not alter its substance.

The parties agree as follows

- 1. Voting
 - 1.1 Each party shall exercise the voting rights attaching to Company Securities held by it in the same manner as the other party exercises the voting rights attaching to Company Securities held by it.
- 2. Investment decisions
 - 2.1 Investment decisions in respect of the Company Securities held by each party are made by the same persons.
- 3. Scope of obligations
 - 3.1 Nothing in this agreement obliges either party to acquire, hold or dispose of any Company Securities or any other security.
 - 3.2 Nothing in this agreement confers on either party any right in respect of Company Securities held by the other, or any power to exercise or control the exercise of a right to vote attached to Company Securities held by the other.

3.3 This agreement relates only to the manner in which each party exercises the voting rights attaching to Company Securities held by it.

3.4 Subject to clause 1.1, each party retains all rights attaching to Company Securities held by it.

4. Duration and termination

4.1 This agreement takes effect on the date written above and continues until terminated.

4.2 Either party may terminate by written notice to the other. Termination has no retrospective effect.

5. Disclosure

5.1 The parties acknowledge that this agreement is required to be disclosed to securities exchanges and regulators, and that it will be published.

5.2 Each party will promptly provide the other with any information reasonably required for the purpose of any such disclosure.

6. No partnership or agency

6.1 Nothing in this agreement constitutes a partnership between the parties or makes either the agent of the other.

7. Entire agreement

7.1 This agreement contains the whole of the arrangements between the parties as to the exercise of voting rights attaching to Company Securities.

8. Variation

8.1 No variation of this agreement is effective unless in writing and signed by both parties.

9. Governing law and jurisdiction

9.1 This agreement is governed by the laws of the Republic Cyprus.

9.2 The courts of the Republic of Cyprus have exclusive jurisdiction.
