New Activated Probiotics launches for H1 FY27

- *Biome* will launch two new products in H1 FY27: *Biome Daily Probiotic 60* and *Biome Daily Kids Probiotic 60*, two-month formats of *the Company's* two highest volume products
- Both are clinically supported daily probiotics for gastrointestinal symptoms, the side effects of antibiotics and winter immune support, microencapsulated so five times more live bacteria reach the gut^{2,3}
- *Biome Daily* (30) is the number one probiotic product in Australian pharmacy by both units and value, and *Biome Daily Kids* (30) is the number one immune health and kids probiotic, based on IQVIA pharmacy scan data¹
- 14 of the top 20 probiotic products in Australian pharmacy are 60 or 90 packs (IQVIA). *Biome Daily* and *Biome Daily Kids* reached number one in 30 packs alone, and *the Company's* modelling indicates new sales are expected to run well ahead of any substitution from the 30 packs
- Supplied through *the Company's* existing pharmacy wholesalers and practitioner channel from H1 FY27, spreading demand across more SKUs and de-risking supply of *the Company's* largest lines
- The new products will be *Biome's* first Australian-made products, manufactured under its onshore manufacturing agreement with Specialty Probiotics Australia (refer ASX announcement 3 June 2026)

Microbiome health company **Biome Australia Limited** (ASX: BIO) ('**Biome**' or '**the Company**') is pleased to announce two new products for launch in H1 FY27: *Biome Daily Probiotic 60* and *Biome Daily Kids Probiotic 60*, two-month formats of the two highest volume products in its *Activated Probiotics* range.

Clinically Studied Probiotic Medicines

Biome Daily Probiotic is a six strain, 9 billion live bacteria capsule for adults, formulated for digestive and immune health. Its HEAL9 and 8700:2 strain combination has been studied in randomised, double-blind, placebo-controlled trials in more than 1,400 adults and shown to reduce the incidence, duration and severity of common colds.² *Biome Daily Kids Probiotic* is a five strain, 10 billion live bacteria vanilla flavoured sachet for children from two years, formulated to support immune function, reduce the occurrence and duration of common colds and maintain healthy gut bacteria during antibiotic use, and includes *Lactobacillus rhamnosus* GG, one of the most studied strains in children. Both use *Activated Probiotics'* microencapsulation technology, which protects the bacteria through the stomach so that five times more reach the gut alive than uncoated probiotics.³ *Biome Daily* sits in digestive probiotics, the largest segment of the pharmacy probiotic category, and *Biome Daily Kids* leads the immunity segment.¹

Building on two number one products

Independent IQVIA pharmacy scan data ranks *Biome Daily* as the number one probiotic product in Australian pharmacy by both units and value, and *Biome Daily Kids* as the number one immune health and kids probiotic.¹ Both reached those positions with a 30 pack alone, against brands whose core lines are 60 and 90 packs. The same data shows 14 of the top 20 probiotic products by value are 60 or 90 packs, and three of the six 30 packs in the top 20 are *Biome's* own.¹ The new products bring *the Company's* two category leaders into the format that leads the category.

Commercial rationale

Probiotics work through consistent daily use. A two-month supply supports adherence and retention, gives pharmacists and practitioners a simpler recommendation for regular users, and lifts transaction value for pharmacy partners. Pricing has been set to retain existing customers as they move to the larger format.

Both new products will be supplied through *the Company's* existing community pharmacy wholesalers and the practitioner channel during the first half of FY27. They also de-risk *the Company's* two largest lines. Demand that currently sits on a single SKU for each product will be spread across two, reducing the impact of any out of stock at wholesaler or retailer level. The format is structurally more efficient for *Biome*, with one carton, one label and one freight movement covering two months of supply, which supports *the*

Company's stated objective of lifting gross margin as manufacturing moves onshore under its agreement with Specialty Probiotics Australia (refer ASX announcement 3 June 2026).

The Company has modelled the interaction between the formats across a range of scenarios. In each, growth in new sales is expected to run well ahead of any substitution from the 30 packs. No revenue guidance is provided for the new products.

Managing Director commentary

Biome Australia Founder and Managing Director, Blair Vega Norfolk, said:

"Our probiotics are backed by clinical trials, but a trial result only becomes a health outcome if people take the product every day for long enough to get the benefit. The most common reason they stop is running out. A two-month pack helps patients stay on the product, and gives the pharmacists and practitioners who support them a simpler recommendation.

The data shows how much room there is to grow. Biome Daily and Biome Daily Kids became the number one probiotics in Australian pharmacy in a 30 pack, against brands whose core lines are 60s and 90s. Fourteen of the top twenty products in the category are larger formats. Until now we have left that part to everyone else.

That's why this may be the most exciting launch we've done. Patients stay on the product longer, practitioners get an easier recommendation, and the category has already told us it wants the format. These will also be Biome's first Australian-made products."
