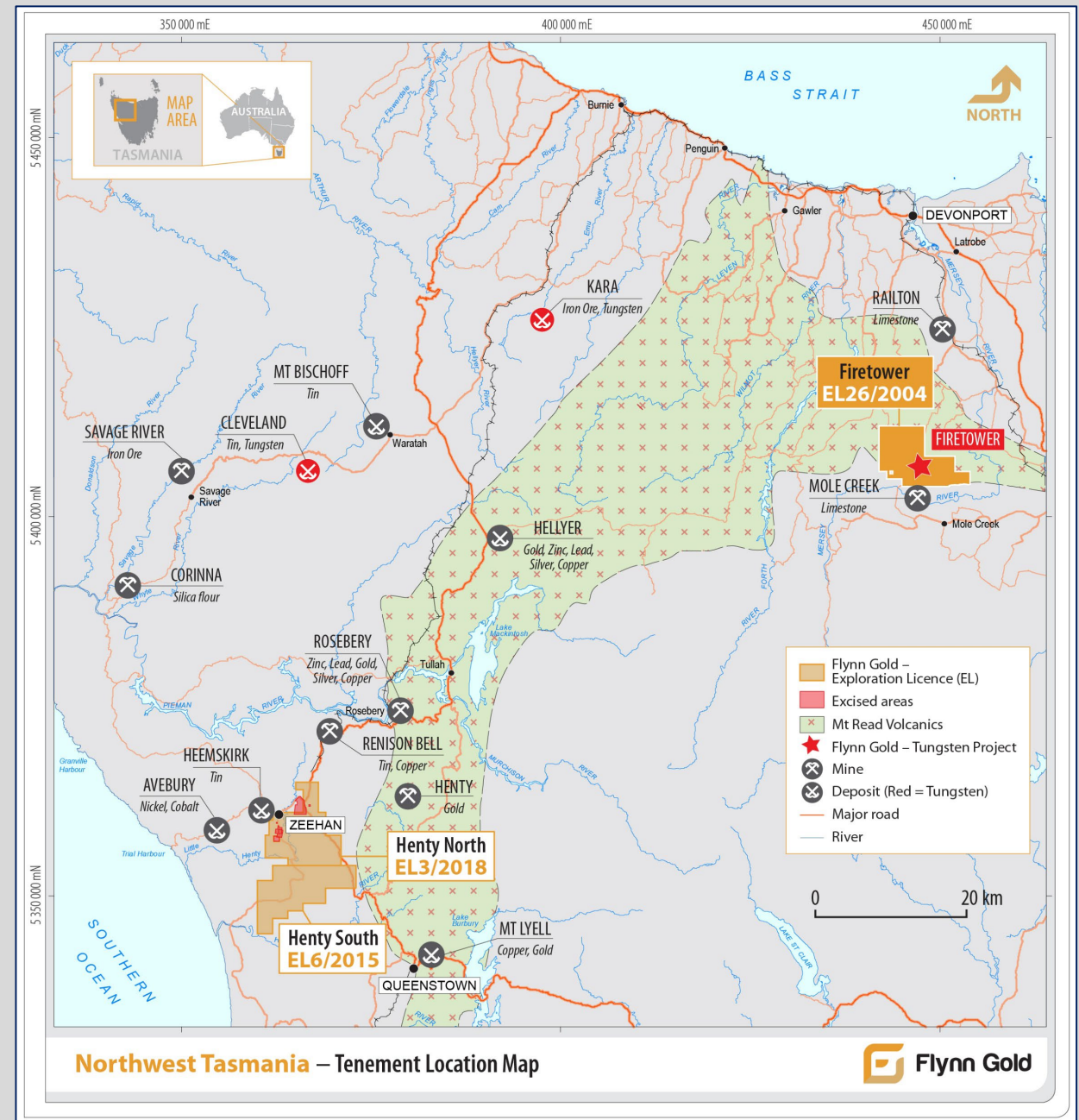
Project located in the prolific **Mount Read Volcanics Sequence**

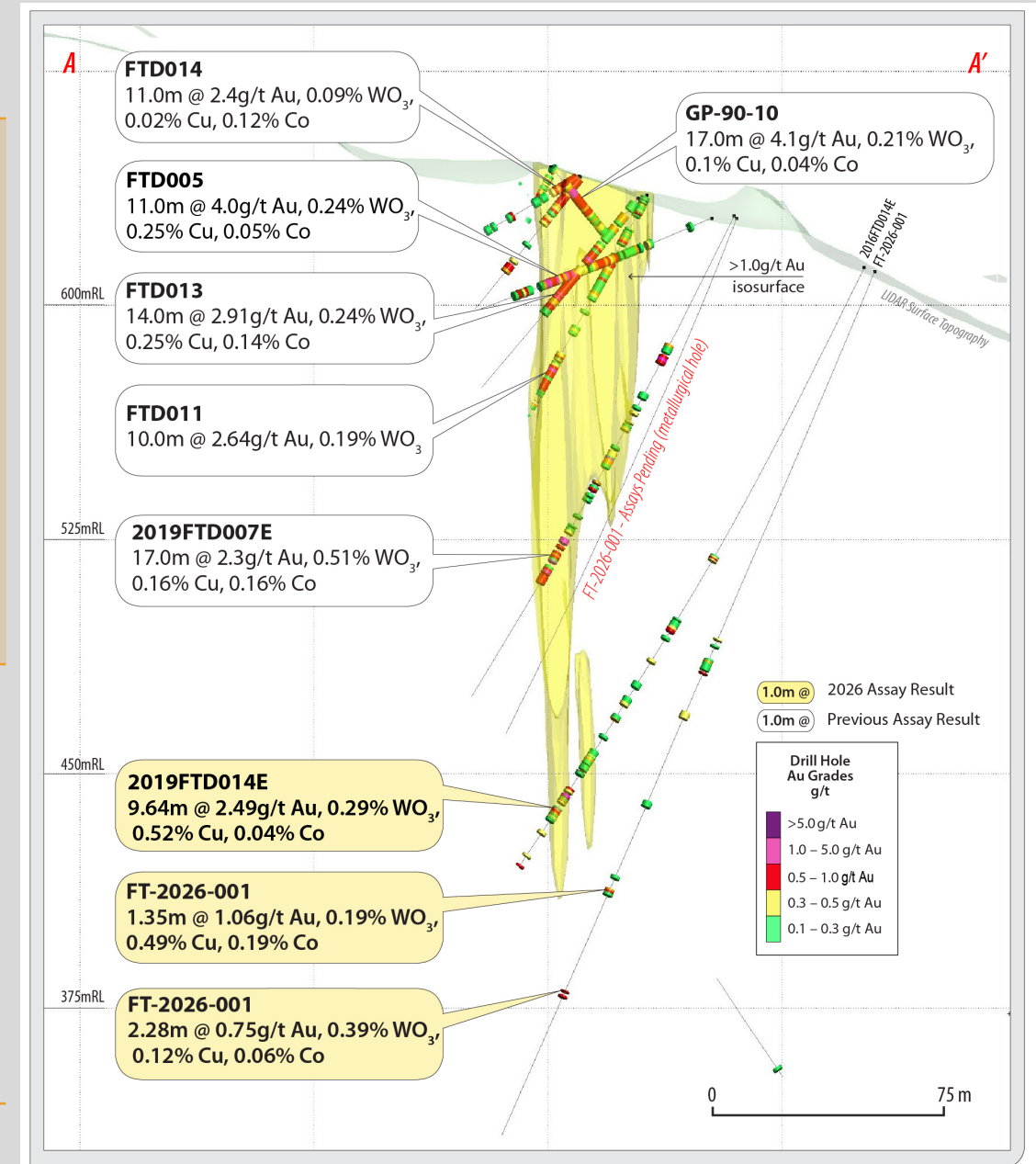

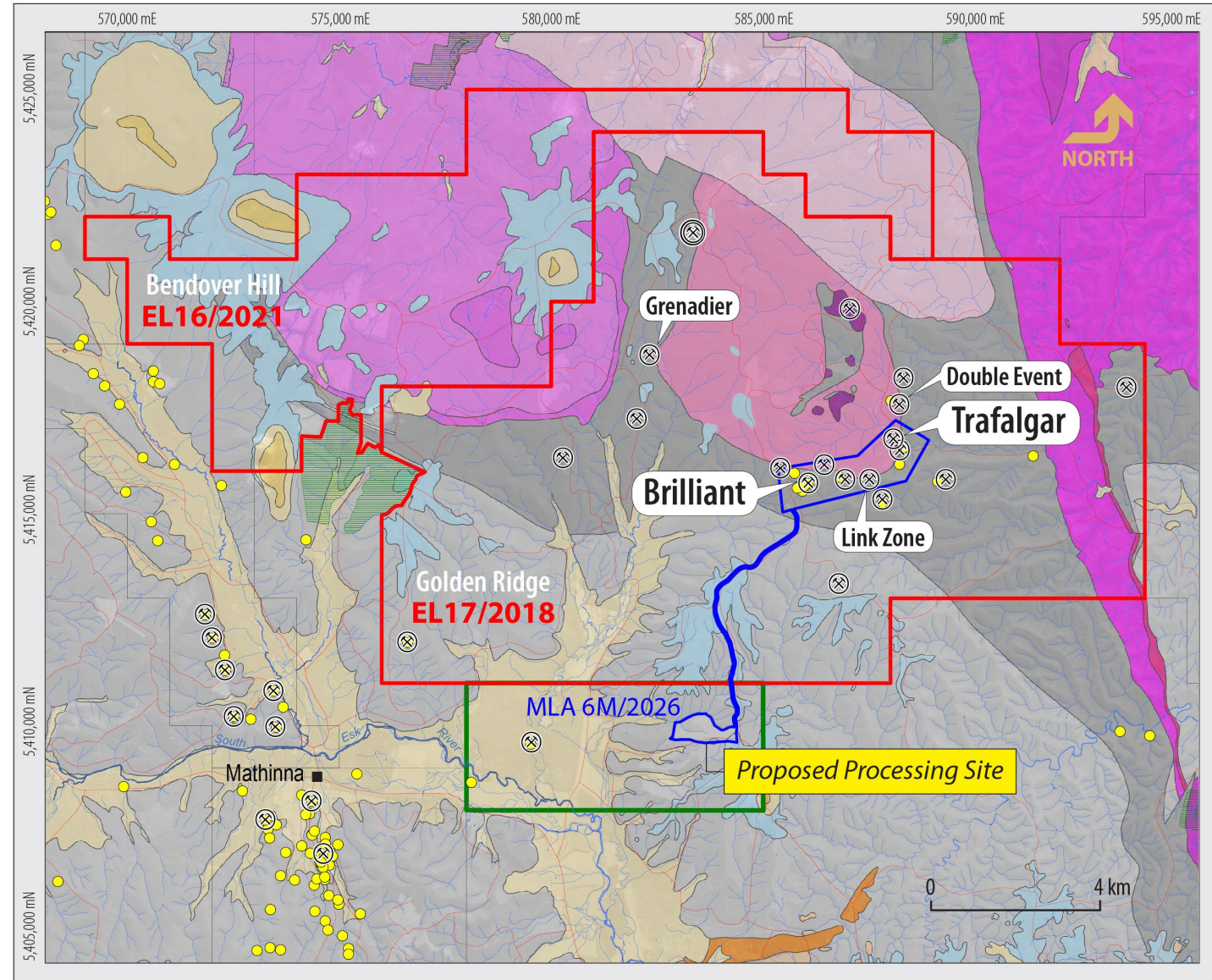
Golden Ridge is an **Intrusion-Related Gold System** – IRGS renown globally for hosting large gold deposits

9-kilometre mineralised contact zone identified to date along margins of the Golden Ridge Granodiorite

2024 Exploration Target based on high-grade vein model only –
lower grade gold zones excluded but gold price now ~US\$4,400/oz

Mining Lease Application (MLA) lodged over Brilliant – Trafalgar Prospects in June 2026

MLA includes **Proposed Processing Site** on 70 ha of cleared land –
potential long term **Gold Processing Hub** for NE Tasmania

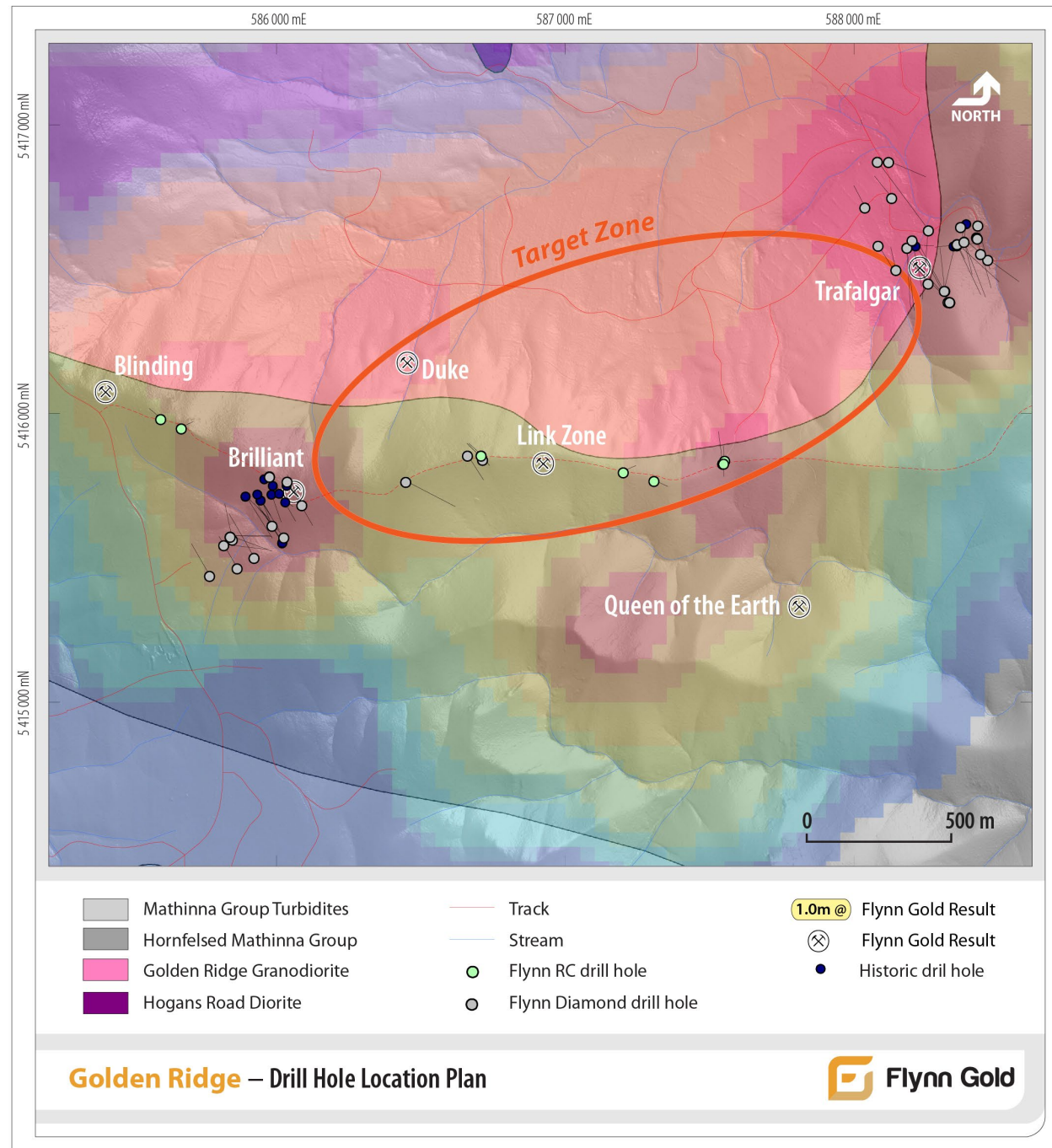
Growing the Exploration Target

Drilling at Trafalgar demonstrates that the **Granodiorite contact zone** is **highly mineralised**

Drilling between Brilliant and Trafalgar Prospects is very limited but with some **encouraging gold intersections reported** to date

Drilling in largely untested **Target Zone** will be a priority to grow the exploration target and mineral resources

Drilling underway at the Brilliant prospect with 21 holes for 2,500m approved

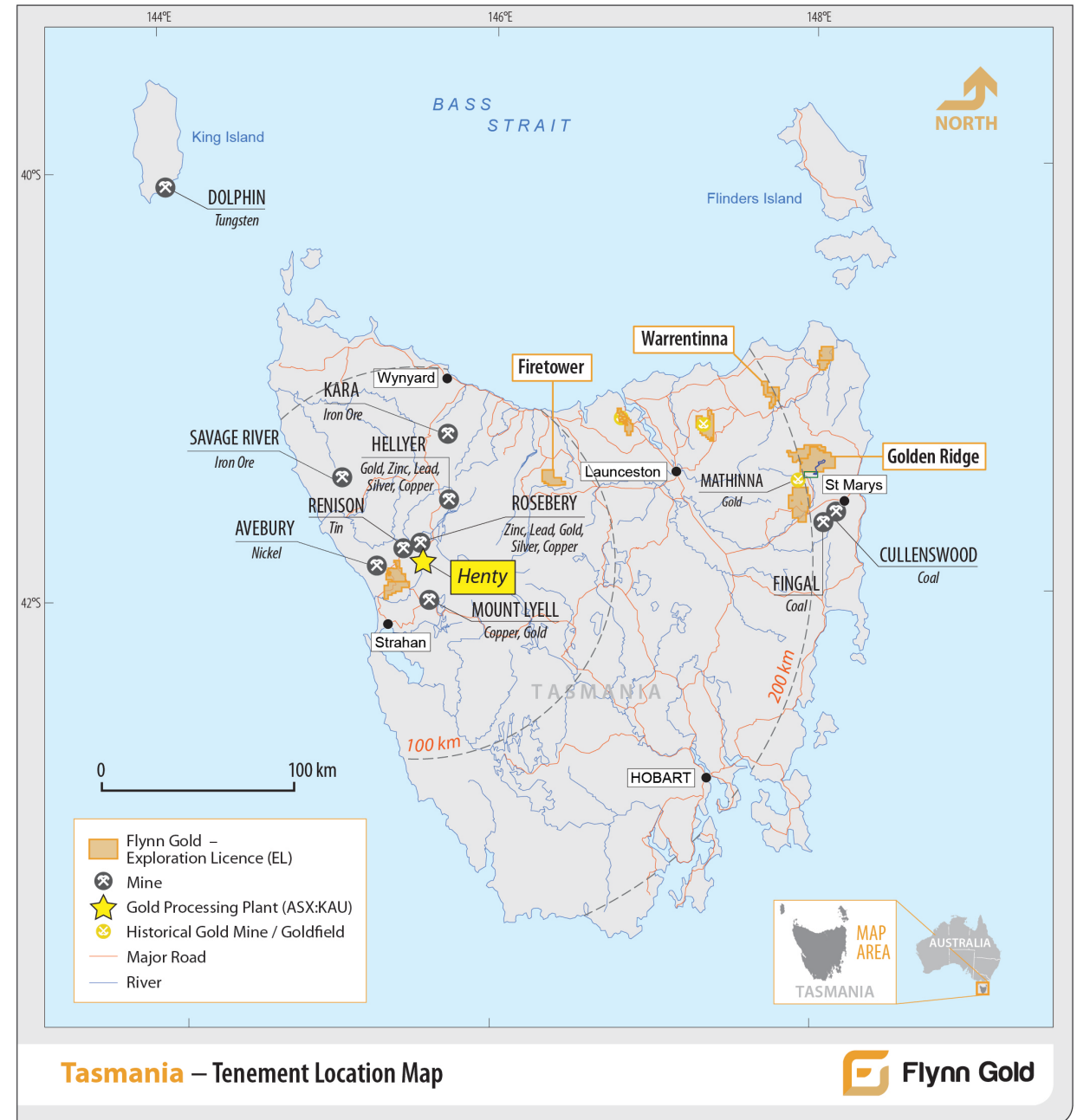
Ore Purchase Agreement

Non-binding Ore Purchase Agreement executed with Henty Gold Mine provides an opportunity for a low-capex production pathway

Agreement establishes the framework and terms under which Henty Gold Mine may buy ore or concentrates supplied by Flynn Gold for processing through its gold processing facility
