On 11 September 2026, Celsius Resources Limited ("**Celsius**" or the "**Company**") (+**ASX, AIM:CLA**) issued a total of 2,457,285 fully paid ordinary shares, pursuant to Resolution 2 to the Notice of General Meeting lodged with ASX on 7 August 2026.
