Notification under section 708A(5)(e) of the Corporations Act 2001 ("the Act")

On Friday, 11 September 2026, Elevate Uranium Ltd (ASX:EL8) ("the Company") issued 910,890 fully paid ordinary shares on conversion of 910,890, 2025 short term employee incentive rights. The issue of these shares was disclosed in an Appendix 2A released to the Australian Securities Exchange ("ASX") on the same date.

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the securities noted above will fall within the exemption in section 708A(5) of the Act.

- (b) that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
 - (i) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (ii) the rights and liabilities attaching to the Shares.
