



GENUS AWARDED VICTORIAN BESS PROJECT FOR BIRDWOOD

HIGHLIGHTS:

- **Genus awarded contract to deliver a 400 MW / 1.86 GWh Battery Energy Storage System (BESS) in Victoria for a leading renewable energy investment manager**
- **Construction is scheduled for completion by late 2028**
- **Contract value is approximately \$160 million**

GenusPlus Group Limited (ASX: GNP) ("Genus") is pleased to announce that it has been awarded a contract to deliver a 400 MW / 1.86 GWh Battery Energy Storage System (BESS) in Victoria for Birdwood Energy Reserve ("Birdwood") in Victoria.

The project is located at Wodonga in Victoria and represents a significant addition to Genus' growing portfolio of large-scale renewable energy and energy storage infrastructure projects.

Construction is scheduled for completion in late 2028. The contract value is approximately \$160 million.

Under the contract, Genus will deliver the Balance of Plant works including civil, structural and electrical infrastructure, high-voltage connection assets, communications and control systems, and testing and commissioning, leveraging its extensive capabilities across engineering, procurement, construction, high-voltage infrastructure.

The project further strengthens Genus' position as a leading provider of critical energy infrastructure and builds on the Group's established capability in delivering large-scale battery energy storage projects across Australia.

GenusPlus Group Managing Director David Riches said:

"This project is another significant milestone for Genus and demonstrates the strength of our capabilities in delivering the critical infrastructure required to support Australia's energy transition."

"At 400 MW / 1.86 GWh, this is a substantial battery project that will play an important role in storing renewable energy and making it available when it is needed most."
