Montaka Global Investments aims to invest in high-quality global companies that are well-positioned to benefit from major long-term industry trends and are priced below what we believe they are worth. The Fund seeks to achieve long-term capital growth, and outperform the MSCI World Index over a rolling 5-year period, net of fees.

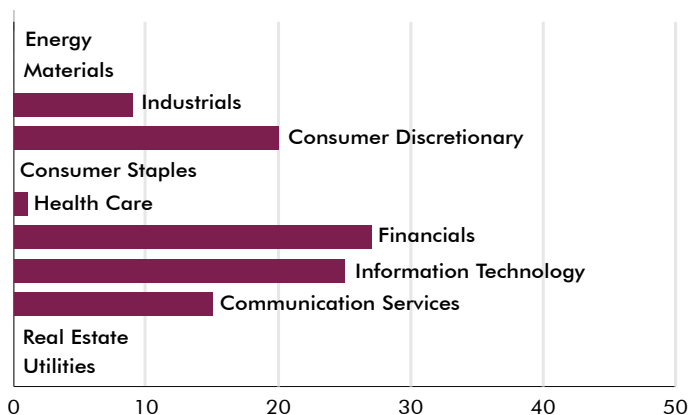

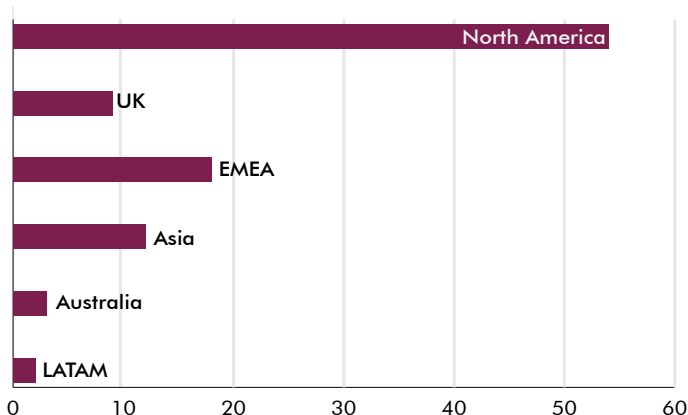
