The fair value of the Options has been estimated using a Black-Scholes option pricing model. The key assumptions applied are as follows: share price at date of issue \$0.150; exercise price \$0.200; expiry date 31 December 2027 (term of 1.30 years); risk-free rate 4.20% per annum; and historical volatility 94.8% per annum (based on weekly returns over the post-consolidation period 1 April 2025 to 8 September 2026, annualised using active trading weeks). On this basis, the fair value of each Option is estimated at \$0.0515
