Hydrix Secures Multi-Year A\$0.625M Remote Cardiac Monitoring Contract with National Heart Centre Singapore

Hydrix Limited (ASX: HYD) is pleased to announce that its wholly owned subsidiary, Hydrix Medical Pty Ltd, has secured a multi-year contract with the National Heart Centre Singapore (NHCS) for the deployment of the Implicity™ cloud-based remote cardiac monitoring platform.

Highlights

- Multi-year contract with National Heart Centre Singapore (NHCS), one of Asia's leading cardiac hospitals
- Estimated contract value of approximately A\$0.625 million over three years, subject to patient volumes monitored under the platform
- Annual recurring revenue approximately A\$0.21 million over the agreed three-year term
- Establishes NHCS as a key reference customer to support further expansion opportunities

Under the agreement, NHCS will implement the Implicity platform to assist in the remote monitoring of patients with Cardiac Implantable Electronic Devices (CIEDs), including pacemakers, implantable cardioverter defibrillators (ICDs) and cardiac resynchronisation therapy devices.

The platform aggregates and standardises data from all major device manufacturers into a single interface, improving workflow efficiency for clinicians and supporting earlier intervention through advanced analytics.

Implementation of the platform is expected to commence shortly, with cloud deployment being delivered by Implicity and Hydrix Medical. Revenue flows to Hydrix upon implementation. Pricing and patient numbers are commercial-in-confidence.
