PRINCIPAL ACTIVITIES

The principal activity of the Group during the financial year was mineral exploration for gold, lithium and rare earth elements.

There were no significant changes in the nature of the Group's principal activities during the financial year.

OPERATING RESULTS

The Company reported a net loss of \$3,177,508 for the year ended 30 June 2026 (30 June 2025: \$2,279,302)

DIVIDENDS PAID OR RECOMMENDED

The directors do not recommend the payment of a dividend and no amount has been paid or declared by way of a dividend to the date of this report.

REVIEW OF OPERATIONS

During the year ended 30 June 2026, OzAurum Resources Ltd advanced its Mulgabbie North Gold Project from feasibility study activities toward construction and near-term heap leach development. Work completed during the year included substantial RC grade control drilling, metallurgical testwork, permitting, engineering design, heritage and archaeological surveys, acquisition and refurbishment of heap leach plant, and commencement of civil works at site.

The Company's principal focus remained the staged development of Mulgabbie North, with Stage 1 works progressing at the James open pit and Stage 2 and 3 planning focused on a larger heap leach operation. By year end, the project had moved from study and permitting into early construction, with civil works underway and refurbishment of the heap leach agglomeration plant nearing completion.

At the Patricia Gold Project, the Company continued planning exploration at Heysen's Find, where a Programme of Work has been granted by the Western Australian Department of Mines, Petroleum and Exploration to

undertake RC drilling over approved targets associated with high-grade gold rock chip samples and a newly identified shear zone.

In Brazil, OzAurum advanced exploration of the Salitre Niobium and Rare Earth Element Project within the Alto Paranaba Magmatic Province. The Company completed a small ground magnetometer survey on a 50m by 25m grid over the Target 1 niobium soil anomaly, and commenced collation of the data for geophysical interpretation.

The Company also strengthened its funding position through a strategic placement to Forrestania Resources Limited, raising A\$4.0968 million (before costs) through the issue of 56,900,000 shares at A\$0.072 per share. Placement proceeds are being directed primarily toward advancing heap leach feasibility and development activities at the James Stage 1 Open Pit.

MULGABBIE NORTH GOLD PROJECT

Mulgabbie North Feasibility

During the year, the Company progressed the Mulgabbie North Heap Leach Feasibility Study through drilling, metallurgical testwork, permitting, engineering design, environmental submissions and commencement of Stage 1 development activities. The work completed increased confidence in the proposed Stage 1 open pit and larger Stage 2 and 3 heap leach development pathway.

The heap leach development pathway advanced materially, with Stage 1 approvals and early works progressing in parallel with Stage 2 and 3 design, permitting and scheduling activities. The Company's development strategy is based on a staged, low-capital-cost heap leach operation designed to deliver near-term production and provide a platform for future expansion.

Drilling activities during the year included RC programs at the James, Ben and Cross Fault prospects, the December 2025 James Stage 1 grade control program, metallurgical diamond drilling, and a major April 2026 Paleochannel grade control RC program. Together, this work confirmed shallow high-grade mineralisation within the Stage 1 James pit area and demonstrated continuity of high-grade mineralisation across the Paleochannel Project, supporting mine scheduling, economic modelling and the Company's heap leach development strategy.

Column heap leach testwork undertaken at ALS Metallurgy, Balcatta, continued to demonstrate strong metallurgical performance from Mulgabbie North ores. Testing during the year included Column 1 using James Stage 1 oxide/upper saprolite ore from diamond hole MNODH 019, Column 2 using lower saprolite/transition ore from diamond hole MNODH 020, and Column 3 using Paleochannel ore from diamond hole MNODH 022.

Strategic Development Pathway: Design & Site Layout

Stage 1 is being progressed as a metallurgical trial with an initial two-cell heap leach operation using the refurbished agglomeration plant and site infrastructure to support campaign mining, crushing, screening, agglomeration and heap leach processing. This approach is intended to minimise upfront capital requirements while enabling the Company to fully understand the heap leaching characteristics of the oxide material and to establish operating capability at Mulgabbie North.

The Company has received Environmental Approval under the Small Mining Operation Policy from the Western Australian Department of Mines, Petroleum and Exploration for Stage 1 open pit mining and heap leach operations. The Company has also received the required approval from the Department of Mines, Petroleum and Exploration to commence Stage 1 open pit mining under the Mining Operator Notification process. The Dangerous Goods Licence application has been lodged with the Department, after which the Company expects to apply to the Western Australian Department of Health for the required Poisons Permit.

For Stage 2 and 3, design work has been based on a larger heap leach facility comprising 32 cells, located on M28/240. Open pit optimisations, pit crest outlines and heap leach cell sequencing have been advanced to support a potential expanded mining and processing operation.

Stage 2 permitting work during the year included geotechnical pit slope design parameters, waste rock characterisation, open pit optimisation, larger heap leach design requirements and site layout planning. The expanded site layout includes provision for waste dumps and supporting infrastructure for a larger open pit mining operation utilising a 120 tonne mining fleet.

The Company also completed heritage and archaeological surveys over the Stage 2 and 3 areas under the guidance and with the endorsement of Senior Wongatha Elders. These workstreams form part of the requirements to lodge the Mining Development and Closure Proposal with the Western Australian Department of Mines, Petroleum and Exploration for Stage 2 environmental permitting.

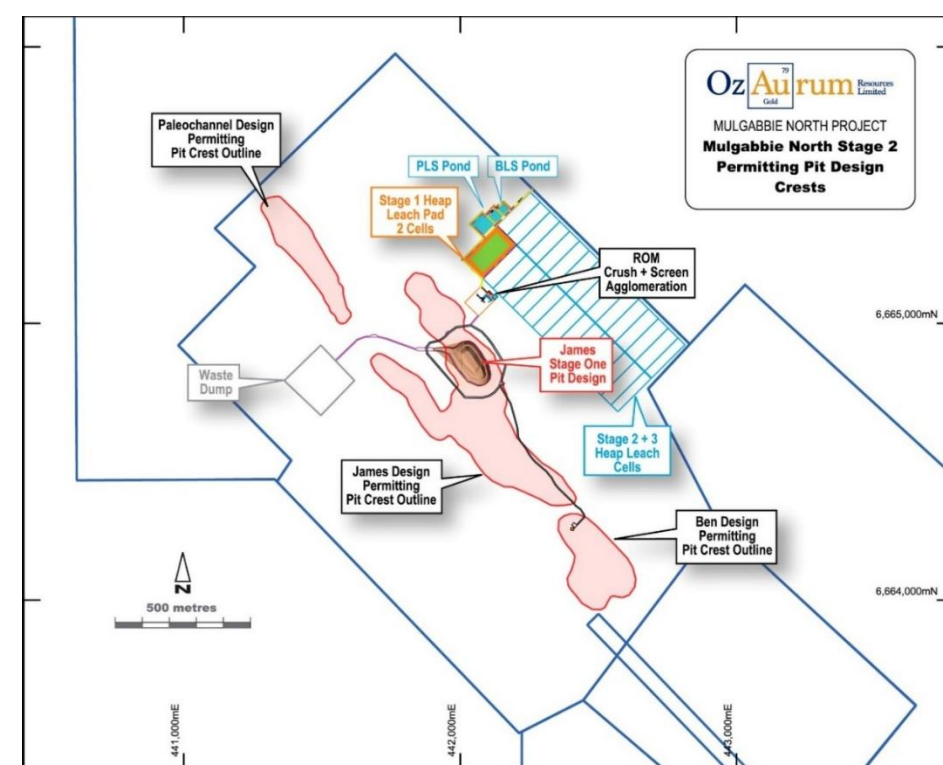


Figure 1: Stage 2 Design Permitting Pit Crest Outlines

James Stage 1 Pit Design Drilling

In October 2025, OZM drilled five RC holes, each 54m deep, at the James Prospect, as first pass nominal grade control drill pattern (8m x 5m). All holes intersected consistent high-grade gold mineralisation¹. The drilling aimed to determine whether high-grade mineralisation previously intersected had continuity and widths within an open pit mine design (already completed) that could potentially be mined via a Stage 1 open pit and heap leach operation.

In December 2025, a 91-hole grade control drilling program was completed, along with one diamond drill hole (MNODH019, 50m). The grade control program results (MNORC 286 – 376) intersected consistent shallow high grade gold mineralisation². These holes confirmed continuity and width of high-grade mineralisation within the open pit mine design, supporting the planned Stage 1 open pit and heap leach operation. In addition, high-grade gold mineralisation extends beneath the proposed Stage 1 Pit Design and has been intersected in several drill holes.

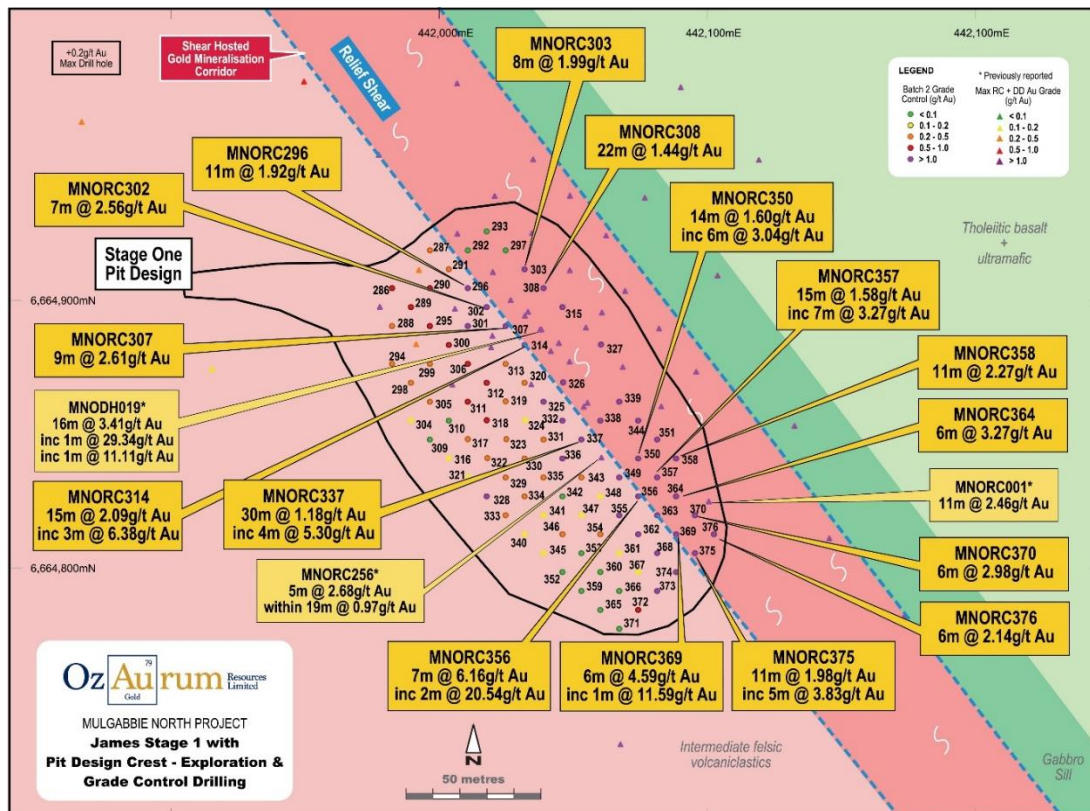


Figure 2: James RC grade control drill hole location

Diamond hole MNODH 019 intersected **16m @ 3.41g/t Au** (from 19m), including exceptional high-grade intervals **1m @ 29.34 g/t Au** (from 22m) and **1m @ 11.11 g/t Au** (from 26m), validating grade tenor within the Stage 1 pit. Samples from MNODH019 were also used for metallurgical testwork.

Paleochannel Grade Control Drilling

In April 2026, the Company completed a 435-hole, 15,646m RC grade control drilling program focused on the Mulgabbie North Paleochannel³. Five batches of significant drilling results were released during the June quarter. The program confirmed consistent, shallow, high-grade gold mineralisation across the full drilling area and provided the drilling density required to support mine planning, scheduling and economic modelling for the Stage 2 heap leach feasibility study.

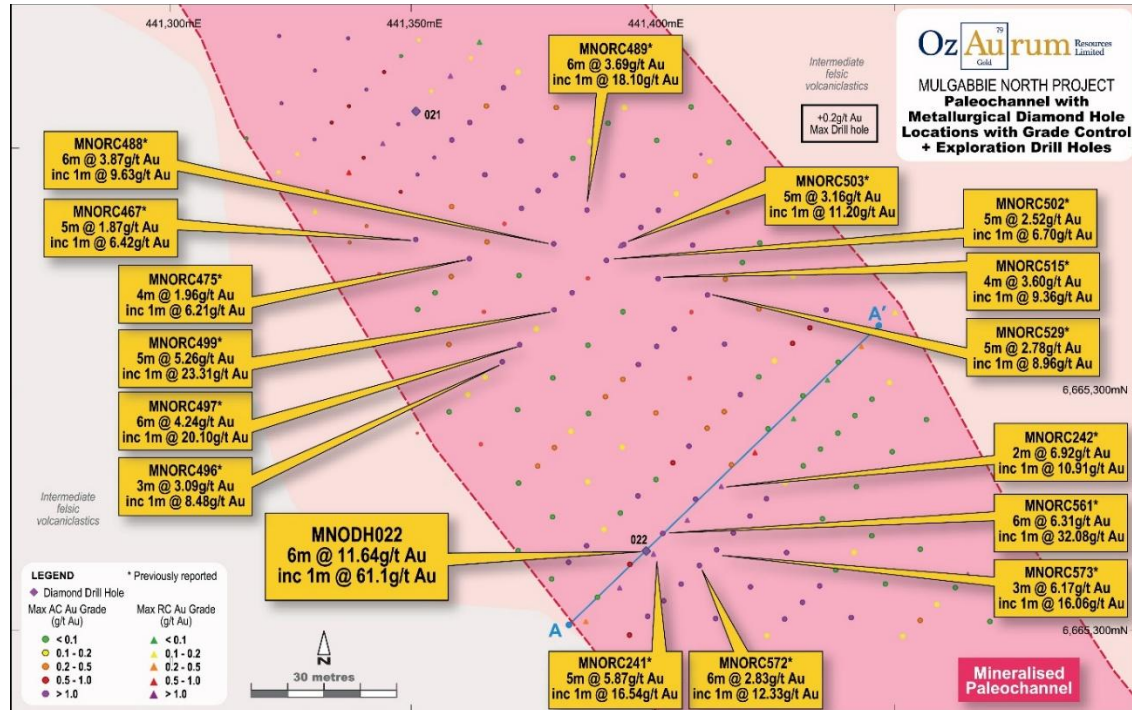


Figure 3: Paleochannel RC grade control drill hole location and metallurgical diamond hole

Diamond hole MNODH 022, drilled for metallurgical testwork on Paleochannel ore, intersected **6m @ 11.64 g/t Au** from 22m, including **1m @ 61.10 g/t Au** from 22m. Samples from MNODH 022 were used in ongoing column leach testwork, further linking the drilling program to the Company's heap leach development workstreams.

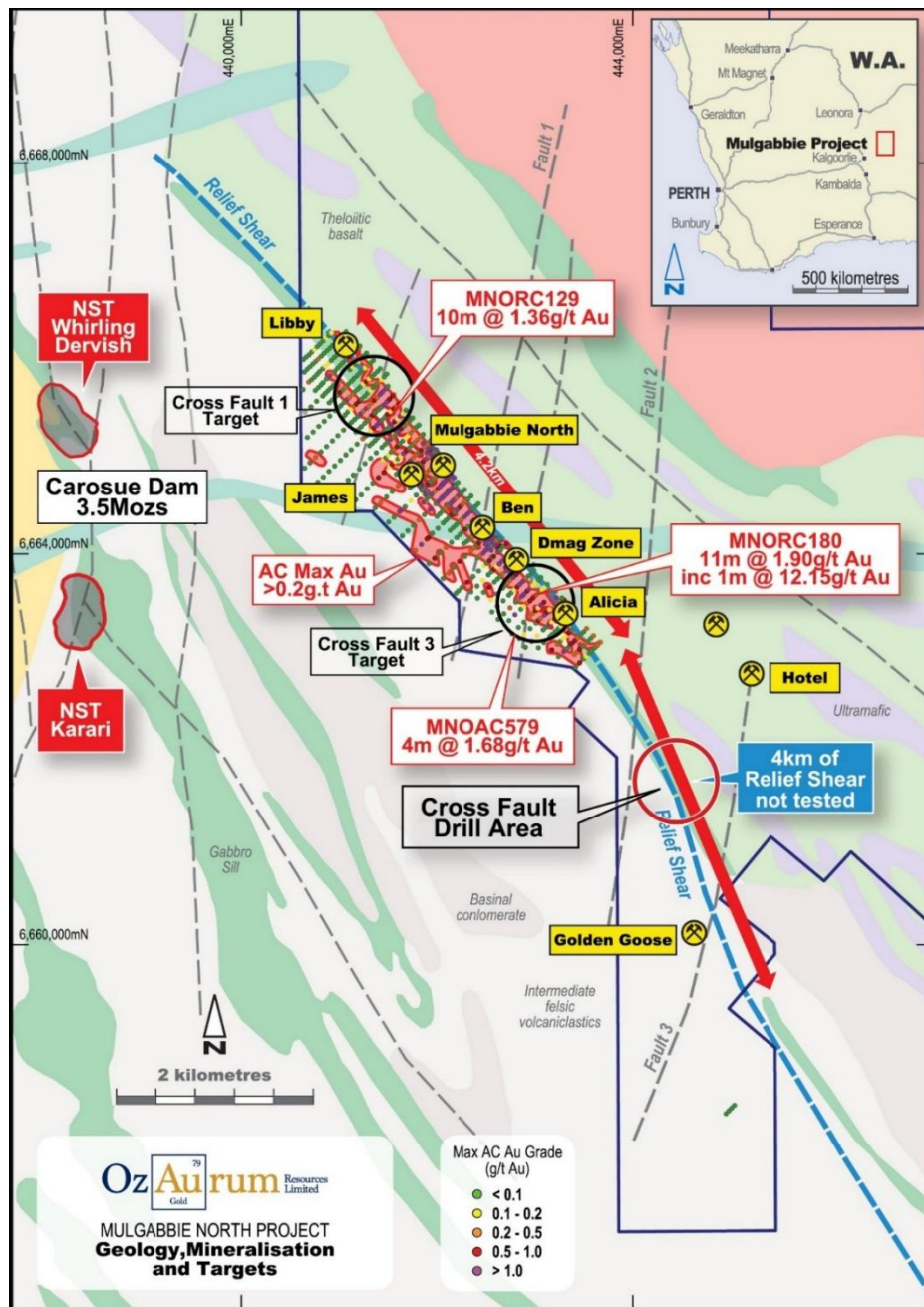


Figure 4: Mulgabbie North Gold Project Relief Shear Gold Mineralisation Corridor.

Percolation Testwork

In October, the Company reported the results of 55 percolation tests from the James Prospect. Of these, 34 tests achieved an average flow rate of 59,900L/hr/m², exceeding the flowrate benchmark required for successful agglomerated heap leach performance. Cement dosage varied from 5-20 kg/t and Lime addition varied between 0-10 kg/t⁴.

This testwork provided OZM with increased confidence in its understanding of the hydraulic characteristics of the James and Paleochannel ores. The results support progression to the next stage of metallurgical assessment - column testwork - to determine gold recoveries and key design factors.

Column Testwork

Column 1 was finalised during the year and achieved greater than 90% gold recovery from shallow oxide/upper saprolite ore crushed to -12mm. The head grade for Column 1 was 2.51 g/t Au, with 60% of gold recovered in seven days and 80% recovered in 14 days. Cyanide consumption was low at 0.45 kg/t.

Column 2, using lower saprolite/transition gold ore from diamond hole MNODH 020 between 34m and 44m downhole and crushed to -12mm, was also finalised during the year. This test achieved 82% gold recovery at a head grade of 1.35 g/t Au, with 60% of gold recovered in seven days and 80% recovered in 14 days. Cyanide consumption was very low at 0.21 kg/t. Testwork also indicated that crushing to -8mm could potentially increase laboratory recovery to approximately 88%, and the Company intends to crush to -8mm when operations commence.⁵

Column 3, using Paleochannel gold ore from diamond hole MNODH 022 between 21m and 29m downhole and crushed to -12mm, remained underway at year end. Preliminary results indicated greater than 60% gold recovery after 21 days and greater than 75% recovery after 39 days of leaching. These results provide further support for the heap leach amenability of Paleochannel ore and the Company's broader low-capital-cost processing strategy.

The Competent Person cautions that the metallurgical results relating to MNODH 022 are preliminary only and have yet to be confirmed by further analysis, which will be reported in due course. The Competent Person considers these results to be indicative, but not an absolute measure, of metallurgical recovery under the laboratory conditions described in OZM's ASX Release of 16 September 2025.

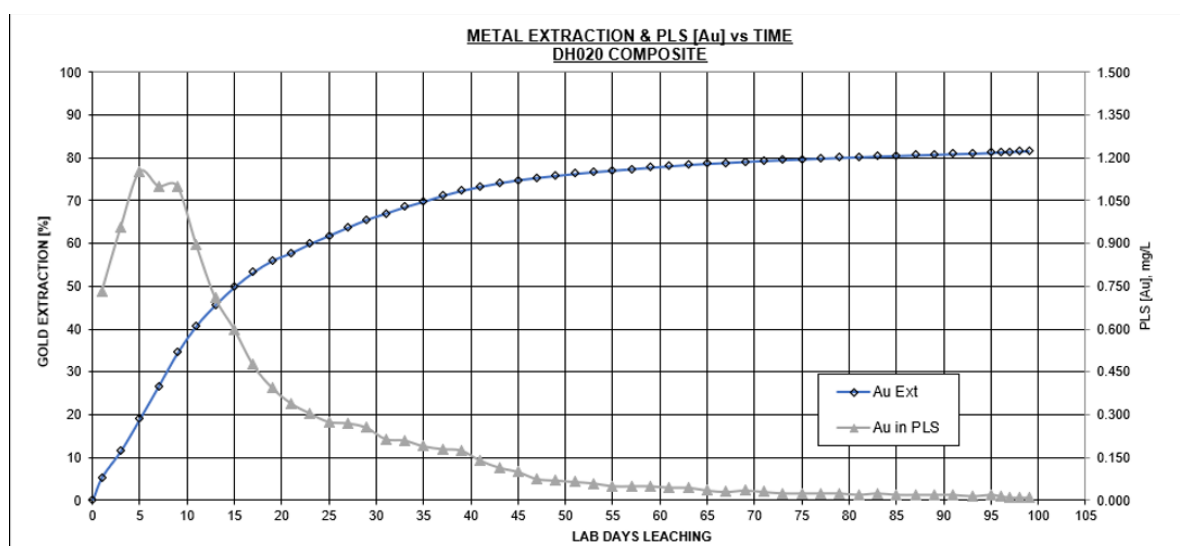


Figure 5: MNODH 020 Gold recovered in solution (g/t Au) vs time, in days

Heap Leach Agglomeration Plant

In January 2026, the Company acquired the Bullabulling heap leach agglomeration plant, including the agglomerator drum originally designed by Randall Pyper of Kappes Cassiday for the Marvel Loch Heap Leach Project. The Marvel Loch operation processed approximately 2,500 tonnes per day and achieved an average gold recovery of 80% over the life of the project, with the first 80,000 tonnes of agglomerated ore recovering 90% of contained gold.

The plant was subsequently used at the Nifty Copper trial heap leach project before being relocated to the Bullabulling gold project. At Bullabulling, heap leach operations mined and produced 2.64 million tonnes at 1.14 g/t Au for 96,000 ounces.

The agglomeration plant operated at 100 tonnes per hour, or approximately 1,000 tonnes per day, which is considered suitable for the Mulgabbie North Stage 1, 2 and 3 development pathway. At this throughput rate, the plant has the potential to support an annual processing rate of approximately 350,000 tonnes per annum operating on day shift only.

The Stage 1 heap leach design for Mulgabbie North is comparable to the Nifty Copper trial heap leach configuration where the plant previously operated successfully. OzAurum considers the plant fit-for-purpose for Mulgabbie North ores and well suited to produce agglomerate material consistent with the Company's percolation testwork results.

OzAurum engaged Polaris Engineering Services to refurbish the heap leach agglomeration plant. Polaris' capability, competitive cost estimate and delivery track record provided the Company with increased confidence that refurbishment work could be completed efficiently while maintaining a low capital cost development strategy and reducing execution risk.

During refurbishment, engineered design changes were made to the agglomeration drum so it can be set at different operating angles, consistent with the original Kappes Cassiday design. This provides operational flexibility to process different ore types and produce the best possible agglomerate. Additional engineering work was also required to upgrade the heap leach plant to current Australian safety standards.

Major components modified and refurbished included the feed bin, agglomerator drum, feed conveyor and main discharge conveyor. Polaris Engineering Services completed dry commissioning of the feed bin, feed conveyor, agglomeration drum and main discharge conveyor. The lime and cement silo system was approximately 95% complete at year end, with delays experienced in the delivery of new silo conveyors from the supplier.

Concrete pouring for the plant foundations at Mulgabbie North was delayed by approximately three weeks due to unseasonably high rainfall on site but was completed before year end. Plant items were expected to begin delivery to site shortly, marking a further step in the transition from study and refurbishment to site installation and development.

PATRICIA GOLD PROJECT

The Patricia Gold Project is located approximately 150 km northeast of Kalgoorlie in the Eastern Goldfields of WA, within a typical greenstone belt geological setting within the prolific Archaean Yilgarn Craton.

The Company has identified new targets for RC drilling north and south of the Patricia open pit and down dip of previously reported high grade intersections. OZM continues to plan drilling at Heysen's Find, which will be undertaken once approvals are received.

Heysen's Find

Heysen's Find is situated on 100% owned Exploration Licence E31/1186. Several rock chip samples returned high-grade gold from quartz vein stockwork and quartz veins associated with a recently identified shear zone⁶. High gold grades extend for over 250m along strike, exposed in two costeans and two shallow prospecting shafts (<5m deep) including;

The high grade gold samples all show abundant gossan boxwork textures after sulphides, most likely pyrite, indicating mineralisation at depth in fresh rock.

The host rock is unidentified due to its highly altered nature. Outcropping dolerite occurs on the immediate western and eastern contacts of the shear zone, extending for 1km along strike to the north. The shear zone foliation is striking 330° and dips near vertical with quartz vein stockwork and quartz veins showing the same orientation.

Heysen's Find Planned Exploration

Geological mapping and additional rock chip sampling will be undertaken at Heysen's Find and along the 7.5km Patricia shear.

Heritage and archaeological studies have been completed for part of E31/1186. A Section 18 Application lodged over the whole of E31/1186 at Heysen's Find has been refused. However, OZM has been granted approval to drill on an area covering the Heysen's Find rockchip samples and drill targets. The approved area extends 1km to the north along strike.

A Programme of Work (POW) has been granted by the DMPE to undertake exploration drilling of these targets and OZM plans to undertake an RC drilling program at Heysen's Find.

BRAZIL

Catalao and Salitre Niobium + REE Projects

The Salitre and Catalao Niobium REE Projects were identified as prospective areas for carbonatite intrusion-related niobium mineralisation and are situated within the Alto Paranaba Magmatic Province (APMP). The APMP hosts 97% of worldwide niobium production, all from carbonatite intrusions.

The Salitre Project is adjacent to the Salitre and Serra Negra carbonatite complexes that host significant niobium and phosphate Mineral Resources. Open pit mining and processing at the Salitre carbonatite produces phosphate, which in turn hosts niobium and rare earth minerals.

Brazil Magnetometer Survey

The Company owned ground magnetometer was delivered to Brazil in late 2025 and a field trial and training has been undertaken with the Brazil General Manager. A small survey on a 50m x 25m grid has been undertaken over

the same area as the Niobium soil sampling⁷. The Company is currently collating the data which will then be sent to a geophysicist for interpretation.

OzAurum advises that this survey does not provide a high precision survey as the magnetometer does not have diurnal correction. In the opinion of the experienced operator, the results will be suitable to detect any significant magnetic response.

Niobium mineralisation at the Brazil Catalao II carbonatite has a distinguishable magnetic response that is characterised by three areas (Morro do Padre, Boa Vista, and Marcos) dominated by dyke swarms of tetraferriphlogopite phoscorites and carbonatites cutting through fenitized Precambrian metavolcano-sedimentary rocks⁸. The Boa Vista open pit mine is currently being mined for Niobium.

CORPORATE

On 30 January 2026, the Company announced that it had completed capital raising of \$4,096,800 (before costs) through the placement of 56,900,000 shares in OzAurum at a price of \$0.072 per share to Forrestania Resources Limited. Shares were issued on 2 February 2026.

During the 2024 year, OzAurum entered into an agreement with Line Hydrogen Pty Ltd and BIM Metals Pty Ltd (together LHBM) to complete the Mulgabbie North Heap Leach Feasibility Study, which will be fully funded by LHBM. Line Hydrogen Pty Ltd was placed into voluntary administration on 12 August 2025. OzAurum subsequently entered into a Deed of Release with Line Hydrogen (Australia) Pty Ltd (Administrator Appointed). The Deed released both parties from the obligations of the Mulgabbie North Feasibility Agreement (announced on 12 September 2025) at no cost to either Party.

The Company held a General Meeting ("GM") on 15 April 2026 at which the placement to Forrestania was ratified. At the GM the Company also approved the issue of 4,100,000 Shares to VM Drilling Pty Ltd (or its nominee/s) at an issue price of \$0.11 per Share for the payment for drilling services provided. The Shares were issued on 25 June 2026.

Business Strategies and Prospects

OzAurum's business model is aimed at generating value from the discovery of economic quantities of mineralisation and resources. It involves identifying projects aligned to OzAurum's strategy, then developing project specific exploration programs designed to quantify a project's mineral potential.

An important part of the OzAurum's proposed model is to assess exploration results on an ongoing basis against the current exploration strategies, other projects, funding options and other opportunities.

OzAurum's activities have inherent risk and the Board is unable to provide certainty of the expected results of these activities or that any or all of these likely activities will be achieved. The material business risks faced by OzAurum that could influence future prospects, and how the risk is managed, are outlined below.

Exploration and Development Risk

Mineral exploration, by its nature, is a high-risk endeavour and consequently, there can be no assurance that exploration of the Group's existing projects, or any other projects that may be acquired in the future, will result in discovery of an economic mineral deposit. Should a discovery be made, there is no guarantee that it will be commercially viable.

The development of mineral projects would follow only if favourable exploration results are obtained. There are still development and operational risks to overcome before a commercial mine can be established. A variety of factors, both geological and market related, can cause a technical discovery to be uneconomic.

Future Capital Requirements

The ability of the Group to continue as a going concern is dependent on securing additional funding through debt or equity issues or partial sale of its mineral properties as and when the need to raise working capital arises, to continue to fund its operational activities.

Management believe there are sufficient funds to meet the Group's working capital requirements as at the date of this report. Subsequent to period end the Group expects to receive additional funds through debt or equity issues.

Native Title and Aboriginal Heritage

The Group's activities in Australia are subject to Commonwealth and State legislation relating to native title and sites of significance to Aboriginal custom and tradition. There is significant uncertainty associated with native title and Aboriginal heritage issues in Australia and this may impact on the Company's future plans. The Directors will closely monitor the potential effect of native title claims or heritage sites involving the Group's projects.

Environmental Risks

The operations and activities of the Group are subject to State and Federal laws and regulations concerning the environment. As with most exploration projects and mining operations, the Group's activities have an impact on the environment. The Group conducts its activities in compliance with all environmental laws.

Climate Change

The Directors recognise that there are a number of risks related to climate change which may affect the Group, including but not limited to:

- the changes which may occur to the climate of the area in which the Group's projects are situated which cannot be predicted;
- changes in governmental policy in response to climate change could adversely impact the value of the Group's assets, its business strategy and/or the costs of its operations; and
- climate change may have an impact on the operations of participants in the mining industry.

General Economic Conditions

General macro-economic conditions such as inflation, currency fluctuation, interest rates, supply and demand and industrial disruption may each have an adverse impact on operating costs, commodity prices and stock market processes. The Groups future possible revenues and Share price can be affected by these factors, which are beyond the control of the Group and its Directors.

Notes to the Consolidated Financial Statements

for the year ended 30 June 2026

1. CORPORATE INFORMATION

The consolidated financial report of OzAurum Resources Limited ("OzAurum") for the year ended 30 June 2026 was authorised for issue in accordance with a resolution of the directors on 21 September 2026 and covers OzAurum Resources Limited as an individual entity as well as the Consolidated Entity consisting of OzAurum Resources Limited and its subsidiaries as required by the Corporations Act 2001.

The consolidated financial report is presented in the Australian currency.

OzAurum Resources Limited is a company limited by shares incorporated in Australia whose shares are publicly traded on the Australian Stock Exchange.

2. SUMMARY OF MATERIAL ACCOUNT POLICIES

The material accounting policies adopted in the preparation of the financial report are set out below. These policies have been consistently applied to all periods presented unless otherwise stated. The financial report includes financial statements of the consolidated entity consisting of OzAurum Resources Limited and its subsidiary (referred to as "the Group").

(a) Basis of Preparation

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards, other authoritative pronouncements of the Australian Accounting Standards Board and Interpretations and the *Corporations Act 2001*. OzAurum Resources Limited is a for-profit entity for the purpose of preparing the financial statements.

Compliance with IFRS

Australian Accounting Standards include Australian Equivalents to International Financial Reporting Standards (AIFRS). Compliance with AIFRS ensures that the financial report complies with International Financial Reporting Standards (IFRS).

Historical cost convention

These financial statements have been prepared under the historical cost convention.

Critical accounting estimates

The preparation of financial statements in conformity with AIFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the Group's accounting policies. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in Note 3.

(b) Going Concern

The Group has incurred a net loss after tax for the year ended 30 June 2026 of \$3,177,508 (2025: \$2,279,302) and incurred net cash outflows from operating activities of \$2,667,197 (2025: \$1,817,877). At 30 June 2026, the Group had current assets of \$2,326,863 (2025: \$2,030,332).

The ability of the Group to continue as a going concern is dependent on securing additional funding through debt or equity issues or partial sale of its mineral properties as and when the need to raise working capital arises, to continue to fund its operational activities.

These conditions indicate a material uncertainty that may cast a significant doubt about the Group's ability to continue as a going concern and, therefore, that it may be unable to realise its assets and discharge its liabilities in the normal course of business.

Management believe there are sufficient funds to meet the Group's working capital requirements as at the date of this report. Subsequent to period end the Group expects to receive additional funds through debt or equity issues.

The financial statements have been prepared on the basis that the Group is a going concern, which contemplates the continuity of normal business activity, realisation of assets and settlement of liabilities in the normal course of business for the following reasons:

- The Group has a proven history of successfully raising capital.
- The Directors believe that there is sufficient cash available for the Group to continue operating until it can raise sufficient further capital to fund its ongoing activities.
- The fact that future exploration and evaluation expenditures are generally discretionary in nature and may be slowed or suspended as part of the management of the Group's working capital and other forecast commitments.

Should the Group not be able to continue as a going concern, it may be required to realise its assets and discharge its liabilities other than in the ordinary course of business, and at amounts that differ from those stated in the financial statements and that the financial report does not include any adjustments relating to the recoverability and classification of recorded asset amounts or liabilities that might be necessary should the Group not continue as a going concern.

(c) Basis of Consolidation

Subsidiaries

The consolidated financial statements comprise the financial statements of OzAurum Resources Limited and its subsidiaries at 30 June each year ("the Group"). Subsidiaries are all entities (including structured entities) over which the group has control. The group controls an entity when the group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the group. They are deconsolidated from the date that control ceases. The financial statements of subsidiaries are prepared for the same reporting period as the parent, using consistent accounting policies.

All intercompany balances and transactions, including unrealised profits arising from intragroup transactions have been eliminated. Unrealised losses are also eliminated unless costs cannot be recovered.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the statement of profit or loss and other comprehensive income, statement of changes in equity and statement of financial position respectively.

Subsidiaries are accounted for in the parent entity's financial statements at cost.

(d) Income Tax

The income tax expense for the year is the tax payable on the current period's taxable income based on the national income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences between the tax base of assets and liabilities and their carrying amounts in the financial statements, and to unused tax losses.

(e) Impairment of Non-Financial Assets

At each reporting date the Group assesses whether there is any indication that individual assets are impaired. Where impairment indicators exist, recoverable amount is determined and impairment losses are recognised in the statement of profit or loss and other comprehensive income where the asset's carrying value exceeds its recoverable amount. Recoverable amount is the higher of an asset's fair value less costs to sell and value in use.

For the purpose of assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

Where it is not possible to estimate recoverable amount for an individual asset, recoverable amount is determined for the cash-generating unit to which the asset belongs.

(f) Exploration, Evaluation and Development Expenditure

Exploration and evaluation costs including costs of studies, exploratory drilling, trenching and sampling and associated activities and an allocation of depreciation and amortisation of assets used in exploration and evaluation activities along with those for general and administrative costs are expensed in the period they are incurred. Acquisition costs of acquiring the tenements are capitalised until the viability of the area of interest is determined. Those acquisition costs are carried forward when the following conditions are satisfied:

- (i) the rights to tenure of the area of interest are current; and
- (ii) at least one of the following conditions is also met:
 - a) the exploration and evaluation expenditures are expected to be recouped through successful development and exploration of the area of interest, or alternatively, by its sale; or
 - b) exploration and evaluation activities in the area of interest have not at the reporting date reached a stage which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves, and active and significant operations in, or in relation to, the area of interest are continuing.

Exploration and evaluation assets are assessed for impairment when facts and circumstances suggest that the carrying amount of an exploration and evaluation asset may exceed its recoverable amount. The recoverable amount of the exploration and evaluation asset (for the cash generating unit(s) to which it has been allocated being no larger than the relevant area of interest) is estimated to determine the extent of the impairment loss (if any). Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in previous years.

Where a decision has been made to proceed with development in respect of a particular area of interest, the relevant exploration and evaluation asset is tested for impairment and the balance is then reclassified to development.

(g) Property, Plant and Equipment

All property, plant and equipment is stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation on other assets is calculated on a straight-line basis over the estimated useful life of the asset as follows:

- Vehicles	3 – 5 years
- Furniture, fittings and equipment	3 – 8 years
- Software	1 – 4 years
- Plant and equipment	10 – 15 years

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each reporting date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2(e)).

Gains and losses on disposals are calculated as the difference between the net disposal proceeds and the asset's carrying amount and are included in the statement of profit or loss and other comprehensive income in the year that the item is derecognised.

(h) Right-of-Use Asset and Lease Liability***Measurement and recognition of leases as a lessee***

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Group depreciates the right-of-use asset on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Group also assesses the right-of-use asset for impairment when such indicators exist.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments. When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

(i) Earnings Per Share***Basic earnings per share***

Basic earnings per share is calculated by dividing the net loss attributable to equity holders of the Group, excluding any costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year.

Diluted earnings per share

Earnings used to calculate diluted earnings per share are calculated by adjusting the basic earnings by the after-tax effect of dividends and interest associated with dilutive potential ordinary shares. The weighted average number of shares used is adjusted for the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

(j) New and Amended Accounting Standards and Interpretations

The Group applied relevant new standards and amendments, which are effective for annual years beginning on or after 1 July 2025. The Group has not early adopted any other standard, interpretation or amendment that has been issued but is not yet effective.

(k) Standards Issued but not yet Effective

The Australian Accounting Standards and Interpretations that are issued or amended, but not yet effective, up to the date of issuance of the Group's financial statements have not been early adopted by the Group for the annual reporting period ended 30 June 2026. The Group has not yet fully assessed the impact of these new or amended Accounting Standards and Interpretations.

AASB 18 Presentation and Disclosure of Financial Statements is not yet effective but may have a material impact on the financial statements of the Group in the future. This standard will replace AASB 101 Presentation of Financial Statements. Whilst many of the requirements will remain consistent, the new standard will have impacts on the presentation of the Statement of Profit and Loss and consequential impacts on the Statement of Cash Flows. It will also require the disclosure of non-AASB management performance measures and may impact the

level of aggregation and disaggregation throughout the primary financial statements and the notes.

AASB 18 applies for periods beginning on or after 1 January 2027 and will be applied retrospectively. The Group is still currently assessing the impact that AASB 18 will have on the Group.

There are no other new standards or amendments that are expected to have a material impact on the Group.

3. ACCOUNTING ESTIMATES AND JUDGMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances. There are no estimates, assumptions or judgments that are expected to have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, except for the following:

Exploration and Evaluation Assets

Acquisition costs in respect of each identifiable area of interest. These costs are carried forward in respect of an area that has not, at reporting date, reached a stage which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves. The future recoverability of exploration and evaluation expenditure is dependent on a number of factors, including whether the Group decides to exploit the related tenement itself, or if not, whether it successfully recovers the related exploration and evaluation assets through sale. Factors that could impact the future recoverability include the level of reserves and resources, future technological changes, which could impact the cost of mining and changes to commodity prices.

Share Based Payments

The Group measures the cost of equity-settled transactions with other parties by reference to the fair value of the goods or services received. Where the fair value of the goods or services cannot be reliably determined, or where the goods or services cannot be identified, the Group measures the cost of the transaction by reference to the fair value of the equity instruments granted. The fair value is determined by using either the quoted market price (if available) or the Black-Scholes model taking into account the terms and conditions upon which the instruments were granted. The accounting estimates and assumptions relating to equity-settled share-based payments would have no impact on the carrying amounts of assets and liabilities within the next annual reporting period but may impact profit or loss and equity.

4. SEGMENT REPORTING

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. The chief operating decision maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Board of Directors.

OzAurum Resources Limited operates in the mineral exploration industry in Australia and Brazil.

Given the nature of the Group, its size and current operations, management does not treat any part of the Group as a separate operating segment. The Group's management operate the business as a whole without any special responsibilities for any separately identifiable segments of the business.

Geographic Information

The Groups revenues and expenditure reported in the financial statements derive from the Groups country of domicile (Australia) and Brazil based on the location of the Group's exploration projects.

22. FINANCIAL RISK MANAGEMENT

(a) General objectives, policies and processes

In common with all other businesses, the Group is exposed to risks that arise from its use of financial instruments. This note describes the Group's objectives, policies and processes for managing those risks and the methods used to measure them. Further quantitative information in respect of these risks is presented throughout these financial statements.

The Group's principal financial instruments comprise cash and short term deposits. The main purpose of the financial instruments is to earn the maximum amount of interest at a low risk to the Group. The Group also has other financial instruments such as other debtors and creditors which arise directly from its operations. For the current financial year, it has been the Group's policy not to trade in financial instruments

The main risks arising from the Group's financial instruments are interest rate risk, liquidity risk and credit risk. There have been no substantive changes in the Group's exposure to financial instrument risks, its objectives, policies and processes for managing those risks or the methods used to measure them during the period unless otherwise stated in this note.

All loans to subsidiary companies are eliminated on consolidation and therefore do not expose the group to credit risk.

The Board has overall responsibility for the determination of the Group's risk management objectives and policies. The Groups' risk management policies and objectives are designed to minimise the potential impacts of these risks on the results of the Group where such impacts may be material.

The overall objective of the Board is to set policies that seek to reduce risk as far as possible without unduly affecting the Group's competitiveness and flexibility. Further details regarding these policies are set out below:

(b) Market Risk

Market risk arises from the use of interest bearing financial instruments. It is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in interest rates (interest rate risk).

Interest rate risk

The Group is exposed to movements in market interest rates on short term deposits. The Directors monitor the Group's cash position relative to the expected cash requirements. Where appropriate, surplus funds are placed on deposit earning higher interest. The Group does not have short or long term debt, and therefore this risk is minimal. The Group's exposure to interest rate risk and the effective weighted average interest rate for each class of financial assets and financial liabilities is set out in the following table:

(c) Credit Risk

Credit risk is managed on a group basis. Credit risk arises mainly from cash and cash equivalents, and deposits with banks and financial institutions. For banks and financial institutions, only independently rated parties with a minimum rating of 'A' are accepted.

The Group does not have any significant credit risk exposure to any single counterparty or any group of counterparties having similar characteristics. The carrying amount of financial assets recorded in the financial statements, net of any provisions for losses, represents the Group's maximum exposure to credit risk. As at 30 June 2026, the group held cash at bank with financial institutions with an S&P rating of AA-.

The Group does not consider there to be any material credit risk owing to the nature of the financial assets held.

(d) Liquidity risk

Liquidity risk is the risk that the Group may encounter difficulties raising funds to meet commitments associated with financial instruments, e.g. borrowing repayments. The Group actively manages its operating cash flows and the availability of funding so as to ensure that all refinancing, repayment and funding needs are met. As part of its overall prudent liquidity management, the Group maintains sufficient levels of cash to meet its working capital requirements. The Group does not have any overdraft, loans or borrowings facilities from financial institutions as at reporting date.

Maturity analysis for financial liabilities

Financial liabilities of the Group include trade and other payables, employee entitlements and lease liabilities. As at 30 June 2026 trade payables and employee entitlements are contractually due within 60 days. The lease liability is in relation to the premises occupied by the Group. See note 18 for details.

(e) Fair Values

The carrying value less impairment provision of trade receivables and payables are assumed to approximate their fair values due to their short-term nature. The same applies to the carrying value of cash and cash equivalents.

(f) Foreign exchange risk

The Group transacts in Australian dollars and Brazilian real and does not participate in the use of derivative financial instruments. Minor exposure to foreign exchange transactions occur from the Group's transaction in other jurisdictions arising from variations in the Australian exchange rate. The impact of these foreign exchange rate differences are not material, therefore the Group considers there is no material foreign exchange risk present.

In order to achieve continuing improvement in Board performance, all Directors are encouraged to undergo continual professional development. Specifically, Directors are provided with the resources and training to address skills gaps where they are identified.

Principle 3: Act ethically and responsibly

Recommendation 3.1
