The grant of STIP Deferred Share Rights (DSRs) related to the FY26 STIP award.

The Board determined that a zero outcome was appropriate for the CEO/MD and his Executive Leadership Team in respect of FY26 STIP, however DSRs were allocated to other eligible participants. The DSRs have a grant date of 15 September 2026. The number of DSRs granted has been determined by dividing the pre-tax dollar value of 30% of the awarded FY26 STIP by \$2.0413 being the volume weighted average price (VWAP) as noted above.

The DSRs will vest at the completion of the deferral period (ending 15 September 2027) at which point they will convert to an equivalent number of ordinary shares of Inghams Group Limited (excluding any DSRs that are lapsed or forfeited).
