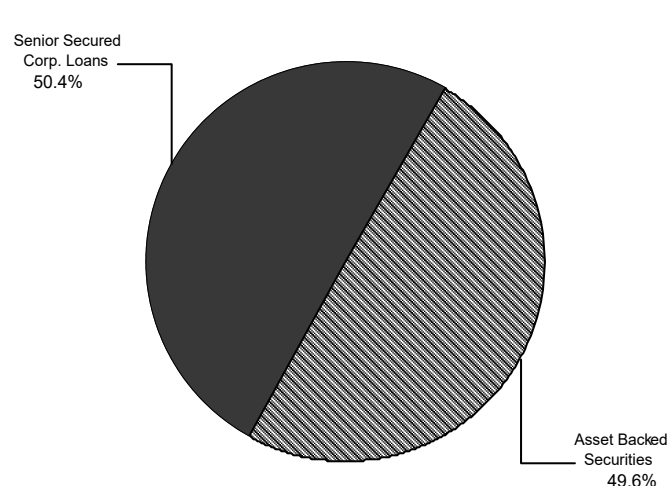

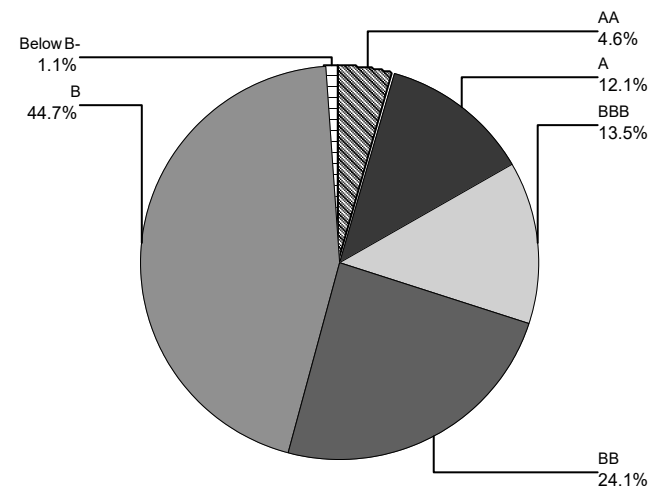

Overall Portfolio Review and Deal Pipeline

Thank you for your investment in the Revolution Private Credit Income Trust (ASX: REV) (the 'Trust'). The objective of the Trust is to achieve a return of the RBA Official Cash Rate plus 4% p.a. (after fees and before tax) with low volatility and with the benefit of having security over the underlying assets. As of 31 August 2026, the Trust net yield to maturity is 8.68% (in AUD terms).

The Trust is fully deployed and invested in the Revolution Private Debt Fund II (the Underlying Fund), as of 31 August 2026. The Underlying Fund held a total of 59 loans as at 31 August 2026, with an average expected life of the portfolio being 1.4 years. The credit spread of the portfolio stands at 483 basis points above the BBSW benchmark rate. The average internal credit rating of the portfolio is BB.

During portfolio construction, Revolution maintained strong credit discipline based on relative value across the three key focus areas of the Underlying Fund being: Australian and New Zealand Senior Secured Corporate Loans, Asset Backed Securities, and Real Estate loans.

Update on the Quarterly Buy-Back (Information pertains to Q3 2026):

Due to current market demand and liquidity for REV units, and given that trading has remained within a narrow band proximate to Net Asset Value (NAV), the Responsible Entity in conjunction with the Manager has determined that proceeding with the scheduled quarterly buyback on or around 30 September would not be in the best interests of unitholders.

Since 1 July 2026, REV units have traded in a range of A\$1.995 to A\$2.020, within an average price of A\$1.9976 per unit, indicating stable pricing and minimal deviation from the NAV. Given these conditions the Responsible Entity together with the Manager considers it appropriate to defer the current quarterly buyback.

Definition of Terms:

Yield to Maturity - is the total return (before fees and expenses) anticipated on the portfolio if the holdings were held until their maturity.

Credit Spread - is the spread over the swap rate.

Interest Rate Duration - is a systematic risk or volatility measure for bonds. It measures the bond portfolio's sensitivity to changes in interest rates.

Weighted Average Credit Rating - is a measure of internal credit risk. It refers to the weighted average of all the internal credit ratings in the portfolio.
