Takeover offer by A2MP Investments FZCO in relation to Canyon Resources Limited – Offer lapsed and notice of change of interests of substantial holder

We act for A2MP Investments FZCO (**A2MP**) in connection with its off-market takeover bid for all of the ordinary shares in Canyon Resources Limited (ACN 140 087 261) (**Canyon**) that A2MP does not already own or control (**Offer**) under the Bidder's Statement dated 29 July 2026 (**Bidder's Statement**).

A2MP confirms that the Offer period closed at 7.00pm (Sydney time) on 21 September 2026. As one or more of the defeating conditions to the Offer were not waived or satisfied at that time, the Offer lapsed.

The acceptances of Canyon shareholders who accepted the Offer have become void as a consequence of the Offer lapsing and those shareholders will be free to deal with their Canyon shares as they see fit.

Attached is a Form 604 notice of change of interests of substantial holder in relation to A2MP's holding in Canyon. The notice is lodged by A2MP in consequence of its Offer and to comply with section 671B(1)(c) of the *Corporations Act 2001* (Cth). A copy of the attached notice will be provided to Canyon today.
