

GENUS AWARDED CONTRACT AS PART OF THE PARRON FARM PROJECT

HIGHLIGHTS:

- Genus awarded Design and Construct Contract by Atmos Renewables for works associated with the Parron Maam Marang Farm
- Contract includes the 330kV terminal, 330kV transmission lines and associated ancillary works
- Total contract value at approximately \$135 million
- Works expected to be completed in 2028

Infrastructure construction, maintenance and service provider GenusPlus Group Ltd (ASX: GNP) (**Genus**, or **the Company**) is pleased to announce that it has been awarded a Design and Construct contract (**Contract**) by Atmos Renewables to deliver a 330kV Terminal, 330kV Transmission Lines Works and associated ancillary works within the 330kV Parron Maam Marang Farm Substation. Work under the Construction Phase is subject to customary conditions precedent, including Atmos Renewables achieving project financial close, executing Connection Agreements, and the issuance of the Notice to Proceed. The work is scheduled for completion in 2028.

The Contract is part of the overall 470MW Parron Maam Marang Farm Project (**Project**) and is located in Badgingarra in Western Australia. Genus has performed some preliminary early works at the Project, including detailed design, procurement of long-lead items and bulk earthworks, with the total contract value for the Contract, including the early works, having a value of circa \$135 million.

Genus Managing Director, David Riches, said Genus is very pleased to be working with Atmos on the delivery of this wind farm connection in Western Australia. The Project is supported through the Federal Government's flagship Capacity Investment Scheme (CIS) as the state prepares to exit coal-fired power by 2030.

"Genus has worked closely with Atmos and is pleased to have been selected by Atmos Renewables to deliver this important package of electrical infrastructure works for the Parron Maam Marang Farm. This Contract builds on our relationship with Atmos continuing on from the Merredin BESS Project. It is a strong endorsement of our delivery performance and the resilience of our customer relationships, reinforcing our position as a trusted long-term partner. We look forward to again working closely with Atmos and bringing our extensive transmission and energy
