Directors' Report

30 June 2026

The directors present their report, together with the financial statements, on the consolidated entity (referred to hereafter as the 'consolidated entity') consisting of US1 Critical Minerals Limited (formerly Gladiator Resources Limited) (referred to hereafter as the 'Company' or 'parent entity') and the entities it controlled at the end of, or during, the year ended 30 June 2026.

Principal activities

The continuing principal activity of the consolidated entity during the financial year was the acquisition, exploration and development of uranium tenements.

Dividends

There were no dividends paid, recommended or declared during the current or previous financial year.

Operating and financial review

United States critical minerals tenements

In August 2025, the Company entered into an agreement with Apex USA Resources LLC (Apex) with the objective of identifying and developing potentially promising Rare Earth Elements tenements (Tenements) in the USA (Apex Agreement).

Under the Apex Agreement, and following shareholder approval at the November 2025 Annual General Meeting, in January 2026 the Company issued 200 million Apex Options with a strike price of \$0.012 and expiring 30 September 2027, which will vest upon the following milestones being achieved:

- On the pegging of tenements prospective for REE in the US, 110 million Apex Options will vest. The milestone will be satisfied once Apex has successfully identified and secured the relevant land package by lodging and having accepted applications for exploration or mining rights over the area and the beneficial ownership interest in the tenements is held by the Company. Apex is to complete all necessary steps to obtain granted tenure in good standing, in accordance with the applicable US state or federal regulations.
- On receiving confirmation that REE exist on the tenements 90 million Apex Options will vest. The milestone will be satisfied once Apex undertakes initial reconnaissance and sampling to confirm the presence of REE mineralisation within the pegged tenure, as confirmed by an assay report prepared by an independent laboratory demonstrating material extracted from the tenement containing a grade of at least 1% TREO.

The Company advanced \$193,000 to Apex being the funds required to meet the costs of pegging the tenements and associated costs. These funds were then transferred into bank accounts in the name of Southern Cross Exploration and Multitask Management for pegging of the nominated claims of land. For the year ended 30 June 2026, the directors have fully impaired this expenditure.

The land package, in Music Valley California USA, has been identified with pegging undertaken on 252 claims of land. However, at this stage, the beneficial ownership interest in the tenements is not yet held by the Company.

The Company also understands that assay work has been undertaken on samples taken from the land package, but it has not yet received the assay reports.

By late October 2025, it became evident that there was an unresolved dispute between the principals of Apex as to whether to honour their commitments to Apex and ultimately to the Company. As a consequence, the Company and Apex commenced proceedings in the Federal Court against Mr Stephen Baghdadi, one of the Apex principals, and Dateline Resources Ltd (Dateline) to protect its position in relation to the Apex Agreement.

Mr Baghdadi and Dateline, including Dateline's subsidiaries, have provided an undertaking to the Court not to take any action to encumber, sell, transfer, dispose of or otherwise disturb the status quo of the Tenements the subject of the Apex Agreement without first providing 14 business days prior written notice to the Company and Apex, or until further order of the Court.

The trial of the legal proceedings commenced on 20 April 2026 before Justice Beach in the Federal Court. On 23 April 2026, the proceedings were adjourned part heard. The proceedings resumed for four days commencing 1 June 2026 for the purpose of undertaking cross examination of the Respondents' witnesses and the expert witnesses. Following closing arguments on 15 and 16 June 2026, the Court has reserved judgment.

Zeus tenements (equity interest 100%)

The Company is in discussions with multiple groups for the purchase of its Tanzanian uranium assets, which include the South-West Corner, Mtyona, Likuyu North and Foxy prospects within the Mkuju Uranium Project region in south-west Tanzania. Discussions are ongoing but have yet to lead to any firm offers and shareholders are cautioned that no transaction may eventuate.

In September 2025, the Company provided an update on fieldwork and analytical interpretation of the Likuyu South target which is on the large Mkuju Project area. The work included geological work and a ground radiometric survey over areas of limited historical drilling. The Company concluded that there is an extensive redox front, along which localized surface uranium is found and that there is potential for a roll-front deposit, possibly significantly offset from the surface mineralisation. 2009 and 2012 drill holes were too few but included intervals such as follows, at the 'Frontal' and 'Western' targets. Full details are provided in the Company's announcement dated 25 August 2025. New drilling on extensive 'fence lines' to cross a potential roll-front is required.

- 17.2 m with an average grade of 43ppm eU308 from a depth of 13.4m (in LSAC004),
- 20.7m with an average grade of 38ppm eU308 from a depth of 3.0m (in LSAC003),
- 4m with an average grade of 167ppm U3O8 from a depth of 4m (in MKRC093), and
- 3m with an average grade of 156ppm U3O8 from a depth of 11m (in MKRC097).

Grades with the prefix 'e' are equivalent uranium based on gamma-ray logging which may be subject to 'radiogenic disequilibrium' which can lead to overstatement or understatement of grade.

Lilombe project

In October 2025, the Company was awarded a Prospecting Licence over an area in the Lindi District of southeast Tanzania considered by the directors to be potentially prospective for rare earth elements. During the December 2025 quarter, the Company carried out initial reconnaissance work. To date the work undertaken has not revealed any material findings and the Company is presently evaluating whether to undertake further exploration activities on the tenement.

For the 2026 financial year, the Company expended and capitalised \$202,546 on exploration and evaluation activities. The Zeus tenements have yet to reach a stage of development where a final determination of the technical feasibility or commercial viability can be assessed. In these circumstances, whether there is any indication that the asset has been impaired is a matter of judgement, as is the determination of the quantum of any required impairment adjustment. For the year ended 30 June 2026, the directors have fully impaired exploration and evaluation expenditure of \$202,546. The impairment was recognised not as a result of the assets losing commercial value, but in compliance with an interpretation of the requirements of AASB 6, due to the absence of an independent valuation to support the carrying value at balance date.

The board is evaluating exploration programs to be undertaken on the tenements.

Federal Court of Australia Proceedings Against Andrew John Price

As previously reported, the Company commenced legal proceedings by filing a statement of claim in the Federal Court of Australia (Proceedings) against Andrew John Price (Andrew Price). The Company alleges that since late-2023, Andrew Price has made numerous false and malicious statements via the X Platform (formerly Twitter) concerning the Company (the Statements), with the intention or with reckless disregard as to whether the Statements would injure the Company. The Company also alleges that Andrew Price's Statements were misleading or deceptive or likely to mislead or deceive or alternatively, false and misleading for the purposes of the Corporations Act 2001 (Cth). The Company seeks to recover damages from Andrew Price as the Statements have prevented the Company from pursuing commercial and business opportunities. The Board strongly condemns these targeted and malicious actions and intends to pursue all appropriate legal remedies available to it to protect the interests of the Company and its shareholders.

During the 2026 financial year, the Company continued to undertake pre-trial activities. In November 2025, the Company provided a bank guarantee, backed by a term deposit, in the amount of \$200,000 as security in the event a costs order is awarded against the Company. In the event no costs order is awarded against the Company, the bank guarantee will be surrendered and the funds released from the term deposit.

Share capital

In September 2025 the Company completed a placing of 55,555,556 shares to professional and sophisticated investors at \$0.018 per share raising \$1 million, before costs.

In December 2025 the Company completed a placing of 150 million shares to professional and sophisticated investors at \$0.01 per share raising \$1.5 million, before costs (the December Placement).

In conjunction with the December Placement, the Company agreed to issue 150 million options, exercisable at \$0.015 per share and expiring 31 March 2029. In addition, the Company agreed to issue 50 million options to consultants for services rendered in relation to the December Placement, exercisable at \$0.015 per share and expiring 31 March 2029.

In May 2026 the Company completed a placing of 50 million shares to professional and sophisticated investors at \$0.02 per share raising \$1 million, before costs (the May Placement).

In conjunction with the May Placement, the Company agreed to issue 25 million options to consultants for services rendered in relation to the May Placement, exercisable at \$0.025 per share and expiring 26 May 2029.

Borrowings

The Company remains debt free.

Going concern

The consolidated entity is involved in the exploration, evaluation, development and exploitation of mineral tenements. Further expenditure will be required upon these tenements to ascertain whether they contain economically recoverable reserves that can be commercially and profitably developed and exploited.

For the year ended 30 June 2026, the consolidated entity reported a net loss of \$4,348,888 (2025: \$4,290,596) and net operating cash outflows of \$3,259,508 (2025: \$974,117). The operating cash outflows have been funded by existing cash holdings and by cash inflows from equity raisings, before costs, of \$3,500,000. As at 30 June 2026, the consolidated entity had net current assets of \$314,172 (2025: \$585,393), including cash reserves of \$302,641 (2025: \$678,507).

The balance of these cash reserves may not be sufficient to meet the consolidated entity's planned expenditure, including its evaluation and development budget, for the 12-month period to 30 September 2027. To fully implement its strategy, the consolidated entity will require additional funding.

These conditions indicate the existence of a material uncertainty that may cast significant doubt on the consolidated entity's ability to continue as a going concern, as described in AASB 570 Going Concern.

Under AASB 570, where such material uncertainties exist, entities must assess the appropriateness of the going concern basis and disclose all relevant information.

The consolidated entity has prepared a cash flow forecast extending 12 months from the date of signing these financial statements. The forecast indicates the Group will have sufficient funds to meet its obligations, based on the following key assumptions:

- Closing the transaction executed in September 2026 for the transfer of the Zeus uranium tenements and the receipt of US\$1 million on closing;
- Controlled exploration and evaluation expenditure, aligned with available funding and specific project objectives;
- A minimal expenditure profile, including for operating and investing activities.

The Directors have carefully considered the assumptions underpinning the cash flow forecast and the Group's ability to manage its expenditures and financing options. Notwithstanding the financial losses incurred and the funding requirements identified, the Directors have no intention to liquidate the Company or cease operations. Based on their assessment, they believe it remains appropriate to prepare the financial statements on a going concern basis, in accordance with AASB 570.

However, should the assumptions not be realised as planned, and further funding not be secured as required, there exists a material uncertainty that may result in the Group being unable to continue as a going concern. In such circumstances, the Group may be required to realise assets and settle liabilities other than in the normal course of business, and at amounts that differ from those stated in the financial report. No adjustments have been made to reflect this potential outcome.

Board

During the year ended 30 June 2026, the Company appointed Mr Avi Geller and Mr Mark Gray as independent non-executive directors.

Avi brings extensive U.S. capital markets, U.S. government relations, corporate governance, and litigation experience to the board. Avi is the Founder and Chief Investment Officer of Leonite Capital, a New Jersey based family office active across real estate and capital markets. Avi also serves as a non-executive director of Nova Minerals Limited (ASX: NVA).

Mark has more than 20 years experience in c-suite roles in the mining industry across many commodities including metallurgical coal, uranium and diamonds, and across many jurisdictions including Australia, Botswana, Tanzania, BC Canada and the US. Mark is now a professional director with three current non-executive appointments including in respect of a metallurgical coal development company based in BC Canada, and two separate investment funds based in New Zealand. Prior to working in the mining sector Mark practised corporate and banking law for 15 years in New Zealand, Australia and the UK. Mark holds an LLB and a MA (with distinction) from Victoria University of Wellington, NZ.

Mr. Andrew Pedley tendered his resignation effective 12 December 2025 to pursue other opportunities. The Company thanks Andrew for his contributions to the Company and wishes him all the very best in his future endeavours.

Trading results

The loss for the consolidated entity after providing for income tax amounted to \$4,348,888 (30 June 2025: \$4,290,596).

Significant changes in the state of affairs

Significant changes in the state of the consolidated affairs during the current year are reflected under the operating and financial review above.

Matters subsequent to the end of the financial year

In September 2026, the Company entered into an agreement with Bradda Head Lithium (BHL), which company is listed on the London Stock Exchange AIM market, for the transfer of the following PLs (Licences): PL11708/2021, PL11705/2021, PL11704/2021, PL12354/2023, PL11703/2021 and PL11709/2021. The Licences being transferred relate to the Mkuju, Foxy and Eland Projects. The Company will retain its 100% interest in PL13571/2025 being the Lilombe Project. BHL has agreed to

undertake preliminary exploration work on the Licences within 12 months of Completion. BHL has paid an exclusivity fee of US\$120,000 to be applied to renewal fees on the Licences which shall be repayable in the event Completion does not occur by 15 October 2026. If the exclusivity fee is not repaid when due, BHL may elect to convert the exclusivity fee into shares in the Company at the 30 day VWAP on the date of such election. Any portion of the exclusivity fee not utilised to satisfy annual rent payments is to be repaid at Completion. The Transaction is subject to customary closing conditions, including receipt of applicable Tanzanian regulatory approvals. The Company has provided warranties and indemnities considered standard for transactions of this type. The consideration for the transfer of the Licences is as follows:

- (a) US\$1,000,000 to be satisfied in cash on the Completion Date.
- (b) US\$300,000 to be satisfied in cash or by the issue of Consideration Shares on BHL confirming either an Indicated or Measured (or a combination of both) mineral resource of at least 25,000,000 pounds of U308, in accordance with NI 43-101.
- (c) US\$500,000 to be satisfied in cash or by the issue of Consideration Shares on completion of a definitive feasibility study on the Licences in accordance with NI 43-101 and BHL making a formal decision to build an operating uranium mine sourcing U308 from any one of the Licences.

Any Consideration Shares to be issued shall be valued by reference to the 30 day VWAP of BHL's shares on the trading day immediately prior to the satisfaction of the conditions.

Likely developments and expected results of operations

The consolidated entity intends progressing exploration and development of the Zeus tenements as reflected under the operating and financial review above, and undertaking exploration and evaluation activities in relation to the US REE tenements, once procured.

Risk relating to future prospects

The Group operates in the mineral exploration sector. There are many factors, both specific to the Group and to the mineral exploration industry in general, that may individually or in combination affect the future operating and financial performance of the Group, its prospects and/or the value of the Company. Many of the circumstances giving rise to these risks are beyond the control of the Company's Directors and its management. The major risks believed to be associated with investment in the Company are as follows.

Additional requirements for capital

The Company expects to require further financing in order to progress its business, being exploration for economic quantities of mineral resources. For the foreseeable future, it is expected that this funding will be obtained from traditional financing sources. Any equity financing undertaken will dilute existing shareholders.

Debt financing agreements or other financing re-arrangements that may be entered into by the Company may contain covenants, undertakings and other such provisions which, if breached, may entitle lenders to accelerate repayment of loans and there is no assurance that the Company would be able to repay those loans in the event of an acceleration. Enforcement of any security granted by the Company could also result in the loss of assets, the impact of which may have a materially adverse impact on the Company.

There is no guarantee that the Company will be able to secure any additional funding or will be able to secure funding on terms that are favourable or acceptable to the Company. If the Company is unable to obtain additional financing as needed or is unable to obtain it on acceptable terms (whether or not due to the Company's circumstances or economic and share market conditions or both), it may be necessary to reduce the scope of the Company's operations and scale back its activities. This could have a material adverse effect on the Company's activities.

Commodity price volatility and exchange rate risks

The price of minerals fluctuates and is affected by many factors beyond the control of the Company. Such factors include supply and demand fluctuations for precious and base and industrial metals; technological advancements; forward selling activities, and other macro-economic factors such as inflation expectations, interest rates and general global economic conditions.

Further, international prices for various commodities are denominated in United States dollars whereas the income and expenditure of the Company may be undertaken in a number of other currencies. This

exposes the Company to the fluctuations and volatility of the rate of exchange between the United States dollar and currencies relevant to the Company's operations.

If the price of commodities fluctuates this could have an adverse effect on the Company's exploration and evaluation activities, development and possible processing activities, as well as its ability to fund these activities, which may no longer be profitable.

Licence risk

The operations and proposed activities of the Group are subject to Tanzanian prospecting licence conditions. The licences include conditions and obligations pertaining to, inter alia, local content. The Group reports to the Tanzanian Mining Commission on activities and believes on a reasonable basis that its licences are presently all in good standing. There can however be no assurance that new operating licencing conditions or stricter enforcement policies, if implemented, will not oblige the Company to incur significant expenses and/or undertake significant investments in compliance, or, feasibly, result in the cancellation of all or some of the Company's licences.

Environmental risk

The operations and proposed activities of the Company are subject to Australian and foreign (especially Tanzanian) State, Territory and Commonwealth laws and regulations concerning the environment. As with most exploration, mining and materials processing industries, the Company's activities are expected to have an impact on the environment, particularly if development proceeds. Future legislation and regulations, including future amendments governing exploration, development and possible production as well as materials recycling may impose significant environmental obligations on the Company.

Although the Company believes that it is in compliance in all material respects with all applicable environmental laws and regulations, there can be no assurance that new environmental laws, regulations or stricter enforcement policies once implemented will not oblige the Company to incur significant expenses and undertake significant investments in compliance.

Mineral resource and ore reserve estimates

Mineral resource and ore reserve estimates are a subjective process based on drilling results, past experience with mining properties and modifying factors, knowledge, industry practice and many other factors. Estimates which are valid when made may change substantially when new information becomes available. Ore reserve estimation is an interpretive process based on a limited amount of geological data pursuant to JORC standards and similar applicable regimes and interpretations and thus estimations may prove to be inaccurate.

Key personnel

The Group's future success depends on the continued services of its key personnel. The Group could be adversely affected if any of the key management team ceased to actively participate in the management of the Group or ceased employment with the Group. The Company has in place long-term incentive arrangements aimed at managing this risk.

Global Pandemic

Any future pandemic may have a material adverse impact on the operations and financial performance of the Company. Local, national and international events of this nature are not within the control of the Company including impacts of government and regulatory restrictions that have or may be implemented including as to travel, employment, operational matters and imports of good/services.

Climate change risk

Climate change is a risk the Company has considered, particularly related to its potential operations in both the mining and materials processing industries. The climate change risks particularly attributable to the Company include:

- Changes in policy, technological innovation and consumer or investor preferences could adversely impact the Company's business strategy or the value of its assets particularly in the event of a transition, which may occur in unpredictable ways to a lower carbon economy.
- the emergence of new or expanded regulations associated with the transitioning to a lower-carbon economy and market changes related to climate change mitigation. The Company may be impacted by changes to local or international compliance regulations related to climate change

mitigation efforts, or by specific taxation or penalties for carbon emissions or environmental damage. These examples sit amongst an array of possible restraints on industry that may further impact the Company and its results of operations. While the Company will endeavour to manage these risks and limit any consequential impacts, there can be no assurance that the Company will not be impacted by these occurrences; and

- climate change may cause certain physical and environmental risks that cannot be predicted by the Company, including events such as increased severity of weather patterns and incidence of extreme weather events and longer-term physical risks such as shifting climate patterns. All these risks associated with climate change may significantly change the industry in which the Company operates.

Occupational health and safety

The Group's operations are subject to a variety of industry-specific health and safety laws and regulations which are formulated to improve and to protect the safety and health of employees. Mining operations are potentially hazardous, and the management of safety and health risks is essential.

The Group seeks to implement best practice procedures in occupational health and safety and meet compliance with government regulations. The safety regime in Tanzania is different to Australia. The occurrence of any industrial accidents, workplace injuries or fatalities may result in workers' compensation claims, related common law claims and potential occupational health and safety prosecutions.

Information technology risks

There is a risk that the Company's core systems and technologies could be exposed to damage or interruption from systems failures, computer viruses, cyber-attacks, power or telecommunications providers' failures, fire, natural disasters, terrorist acts, war or human error. Cyber-attacks may include computer hacking, data theft, system disruption or security breaches and viruses and malware. These situations might include, among others, a breach of sensitive commercial information, loss of Company assets or negative publicity.

Insurance risks

Exploration and evaluation activities, mining and processing activities involve hazards and risks that could result in the Company incurring losses or liabilities that could arise from its operations.

If the Company incurs losses or liabilities which are not covered by its insurance policies, the funds available for exploration will be reduced and the value and/or title to the Company's assets may be at risk. The Company insures its operations in accordance with industry practice. However, in certain circumstances the Company's insurance may not be of a nature or level to provide adequate insurance cover. The occurrence of an event that is not covered or fully covered by insurance could have a material adverse effect on the business, financial condition and results of the Company.

Insurance against all risks is not always available and, where available, the costs can be prohibitive or not adequate to cover all claims.

Environmental regulation

National and local environmental laws and regulations in jurisdictions in which the Company operates affect the Company. These laws and regulations set various standards regulating certain aspects of health and environmental quality, provide for penalties and other liabilities for the violation of such standards and establish, in certain circumstances, obligations to remediate current and former facilities and locations where operations are or were conducted. The Company minimises the potential impact of these laws and regulations by taking steps to ensure compliance with environmental regulations and, where possible, by carrying appropriate insurance.

Notes to the financial statements

30 June 2026

Note 1. General Information

The financial statements cover US1 Critical Minerals Limited as a consolidated entity consisting of US1 Critical Minerals Limited and its subsidiaries.

US1 Critical Minerals Limited is a listed public company whose shares are publicly traded on the Australian Securities Exchange, limited by shares, incorporated and domiciled in Australia. Its registered office and principal place of business is:

A description of the nature of the consolidated entity's operations and its principal activities are included in the directors' report, which is not part of the financial statements.

The principal accounting policies adopted in the preparation of the financial statements are set out below.

Going concern

The consolidated entity is involved in the exploration, evaluation, development and exploitation of mineral tenements. Further expenditure will be required upon these tenements to ascertain whether they contain economically recoverable reserves that can be commercially and profitably developed and exploited.

For the year ended 30 June 2026, the consolidated entity reported a net loss of \$4,348,888 (2025: \$4,290,596) and net operating cash outflows of \$3,259,508 (2025: \$974,117). These operating cash outflows were funded by equity raisings during the year of \$3,500,000 (2025: \$nil). As at 30 June 2026, the consolidated entity had net current assets of \$314,172 (2025: \$585,393), including cash reserves of \$302,641 (2025: \$678,507).

The balance of these cash reserves may not be sufficient to meet the consolidated entity's planned expenditure, including its evaluation and development budget, for the 12-month period to 30 September 2027. To fully implement its strategy, the consolidated entity will require additional funding.

These conditions indicate the existence of a material uncertainty that may cast significant doubt on the consolidated entity's ability to continue as a going concern, as described in AASB 570 Going Concern. Under AASB 570, where such material uncertainties exist, entities must assess the appropriateness of the going concern basis and disclose all relevant information.

The consolidated entity has prepared a cash flow forecast extending 12 months from the date of signing these financial statements. The forecast indicates the Group will have sufficient funds to meet its obligations, based on the following key assumptions:

- Closing the transaction executed in September 2026 for the transfer of the Zeus uranium tenements and the receipt of US\$1 million on closing;
- Controlled exploration and evaluation expenditure, aligned with available funding and specific project objectives;
- A minimal expenditure profile, including for operating and investing activities.

The Directors have carefully considered the assumptions underpinning the cash flow forecast and the Group's ability to manage its expenditures and financing options. Notwithstanding the financial losses incurred and the funding requirements identified, the Directors have no intention to liquidate the Company or cease operations. Based on their assessment, they believe it remains appropriate to prepare the financial statements on a going concern basis, in accordance with AASB 570.

Notes to the financial statements

However, should the assumptions not be realised as planned, and further funding not be secured as required, there exists a material uncertainty that may result in the Group being unable to continue as a going concern. In such circumstances, the Group may be required to realise assets and settle liabilities other than in the normal course of business, and at amounts that differ from those stated in the financial report. No adjustments have been made to reflect this potential outcome.

Basis of Preparation

The financial report is a general-purpose financial report, which has been prepared in accordance with the requirements of the *Corporations Act 2001*, Australian Accounting Standards and interpretations and complies with other requirements of the law.

Accounting policies are selected and applied in a manner which ensures that the resulting financial information satisfies the concepts of relevance and reliability, thereby ensuring that the substance of the underlying transactions or other events is reported.

The accounting policies detailed below have been consistently applied to all of the years presented unless otherwise stated. The financial statements are for the Group consisting of US1 Critical Minerals Limited and its subsidiaries.

Historical cost convention

The financial statements have been prepared on a historical cost basis, except for identifiable assets and liabilities acquired through a business combination.

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the consolidated entity's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 3.

New and Amended Accounting Policies Adopted by the Group

Australian Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory have not been early adopted by the consolidated entity for the annual reporting period ended 30 June 2026. The consolidated entity's assessment of the impact of the more significant of these is set out below.

AASB 18 Presentation and Disclosure in Financial Statements

AASB 18 replaces AASB 101 *Presentation of Financial Statements* and applies to annual reporting periods beginning on or after 1 January 2027. It will therefore first apply to the consolidated entity for the year ending 30 June 2028, with restated comparative information required for the year ending 30 June 2027. AASB 18 does not change the recognition or measurement of any item, but it introduces:

- a requirement to classify income and expenses into three new categories — operating, investing and financing — together with two newly defined subtotals, 'operating profit or loss' and 'profit or loss before financing and income taxes';
- enhanced requirements for the aggregation and disaggregation of information, including a principle that line items are labelled in a way that faithfully represents their characteristics; and
- disclosure of management-defined performance measures, being subtotals of income and expenses used in public communications outside the financial statements, in a single note reconciled to the most directly comparable subtotal specified by Australian Accounting Standards.

The consolidated entity currently presents its expenses as a single list by nature without subtotals. The directors expect AASB 18 to change the structure of the statement of comprehensive loss — in particular the presentation of interest income, exploration expenditure impairment and the costs of the Federal Court proceedings — and to require additional disclosure, but not to change the reported loss, net assets or total equity. The directors are continuing to assess the detailed effects and expect to complete that assessment before the comparative period ends on 30 June 2027.

Sustainability reporting

Statement of Compliance

Parent entity information

In accordance with the *Corporations Act 2001*, these financial statements present the results of the consolidated entity only. Supplementary information about the parent entity is disclosed in note 24.

Note 2. Significant accounting policies

Principles of consolidation

The consolidated financial statements incorporate the assets and liabilities of all subsidiaries of US1 Critical Minerals Limited ('Company' or 'parent entity') as at 30 June 2026 and the results of all subsidiaries for the year then ended. US1 Critical Minerals Limited and its subsidiaries together are referred to in these financial statements as the 'consolidated entity'.

Subsidiaries are all those entities over which the consolidated entity has control. The consolidated entity controls an entity when the consolidated entity is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the consolidated entity. They are de-consolidated from the date that control ceases.

Intercompany transactions, balances and unrealised gains on transactions between entities in the consolidated entity are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the consolidated entity.

The acquisition of subsidiaries is accounted for using the acquisition method of accounting. A change in ownership interest, without the loss of control, is accounted for as an equity transaction, where the difference between the consideration transferred and the book value of the share of the non-controlling interest acquired is recognised directly in equity attributable to the parent.

Where the consolidated entity loses control over a subsidiary, it derecognises the assets including goodwill, liabilities and non-controlling interest in the subsidiary together with any cumulative translation differences recognised in equity. The consolidated entity recognises the fair value of the consideration received and the fair value of any investment retained together with any gain or loss in profit or loss.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. When the inflow of consideration is deferred it is treated as the provision of financing and is discounted at a rate of interest that is generally accepted in the market for similar arrangements. The difference between the amount initially recognised and the amount ultimately received is interest revenue.

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

The consolidated entity is principally engaged in the business of mineral exploration, particularly uranium. Revenue from contracts with customers is recognised when control of the goods is transferred to the customer at an amount that reflects the consideration to which the consolidated entity expects to be entitled in exchange for those goods. The consolidated entity has generally concluded that it is the principal in its revenue contracts because it typically controls the goods before transferring them to the customer.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is current when: it is expected to be realised or intended to be sold or consumed in the normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is current when: it is expected to be settled in the normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Deferred tax assets and liabilities are always classified as non-current.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Trade and other receivables

Prepayments and other receivables are recognised at amortised cost, less any provision for impairment.

Investments and other financial assets

Investments and other financial assets are initially measured at fair value. Transaction costs are included as part of the initial measurement, except for financial assets at fair value through profit or loss. They are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on the purpose of the acquisition and subsequent reclassification to other categories is restricted.

Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the consolidated entity has transferred substantially all the risks and rewards of ownership.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are carried at amortised cost using the effective interest rate method. Gains and losses are recognised in profit or loss when the asset is derecognised or impaired.

Impairment of financial assets

The consolidated entity assesses at the end of each reporting period whether there is any objective evidence that a financial asset or group of financial assets is impaired. Objective evidence includes significant financial difficulty of the issuer or obligor; a breach of contract such as default or delinquency in payments; the lender granting to a borrower concessions due to economic or legal reasons that the lender would not otherwise do; it becomes probable that the borrower will enter bankruptcy or other financial reorganisation; the disappearance of an active market for the financial asset; or observable data indicating that there is a measurable decrease in estimated future cash flows.

The amount of the impairment allowance for loans and receivables carried at amortised cost is the difference between the asset's carrying amount and the present value of estimated future cash flows,

discounted at the original effective interest rate. If there is a reversal of impairment, the reversal cannot exceed the amortised cost that would have been recognised had the impairment not been made and is reversed to profit or loss.

Property, plant, and equipment

Property, plant and equipment is stated at fair value on acquisition (for assets acquired as part of a business combination) or at historical cost at the date of acquisition, less accumulated depreciation and accumulated impairment losses, if any. Historical cost includes expenditure that is directly attributable to the acquisition of the items and costs incurred in bringing the asset into use.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item flow to the consolidated entity and the cost of the item can be measured reliably.

Mine development costs are capitalised to property, plant and equipment only once a decision to mine is made and the development is fully funded. Mine development expenditure represents the cost incurred in preparing mines for commissioning and production, and also includes other attributable costs incurred before production commences. These costs are capitalised to the extent they are expected to be recouped through successful exploitation of the related mining project. Once production commences, these costs are amortised over the estimated economic life of the mine. Mine development costs are written off if the mine property is abandoned. Development costs incurred to maintain production are expensed as incurred against the related production.

At each reporting date, the entity assesses whether there is any indication that an asset may be impaired. Where an indicator of impairment exists, the entity makes a formal assessment of recoverable amount. Where the carrying amount of an asset exceeds its recoverable amount the asset is considered impaired and is written down to its recoverable amount. Recoverable amount is the greater of fair value less costs of disposal and value in use.

Depreciation

Depreciation is provided on a straight-line basis on all plant and equipment commencing from the time the asset is held ready for use. Major depreciation periods are:

- Equipment – 4 to 5 years

An item of property, plant and equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the Statement of Comprehensive Loss when the asset is derecognised.

The assets' residual values, useful lives and depreciation methods are reviewed at each reporting period and adjusted prospectively, if appropriate.

Leases

Right of use asset

The Group recognises right-of-use assets at the commencement date of the lease (i.e. the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any re-measurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Unless the Group is reasonably certain to obtain ownership of the leased asset at the end of the lease term, the recognised right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term. Right-of-use assets are subject to impairment.

Lease Liabilities

At the commencement date of the lease, the Group recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate. The variable lease payments that do not depend on an index or a rate are recognised as expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the in-substance fixed lease payments or a change in the assessment to purchase the underlying asset.

The Group recognises the lease payments as an expense on a straight-line basis over the lease term.

The Group has elected not to recognise right of use assets and lease liabilities for short term leases and low value assets.

Intangible assets

Intangible assets acquired as part of a business combination, other than goodwill, are initially measured at their fair value at the date of the acquisition. Intangible assets acquired separately are initially recognised at cost. Indefinite life intangible assets are not amortised and are subsequently measured at cost less any impairment. Finite life intangible assets are subsequently measured at cost less amortisation and any impairment. The gains or losses recognised in profit or loss arising from the de-recognition of intangible assets are measured as the difference between net disposal proceeds and the carrying amount of the intangible asset. The method and useful lives of finite life intangible assets are reviewed annually. Changes in the expected pattern of consumption or useful life are accounted for prospectively by changing the amortisation method or period.

Impairment of non-financial assets

Goodwill and other intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Trade and other payables

These amounts represent liabilities for goods and services provided to the consolidated entity prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Borrowings

Loans and borrowings are initially recognised at the fair value of the consideration received, net of transaction costs. Subsequent to initial recognition, borrowings are stated at amortised cost with any difference between cost and redemption being recognised in the Statement of Comprehensive Loss over the period of the borrowings on an effective interest basis.

Where there is an unconditional right to defer settlement of the liability for at least 12 months after the reporting date, the loans or borrowings are classified as non-current.

Finance costs

Finance costs attributable to qualifying assets are capitalised as part of the asset. All other finance costs are expensed in the period in which they are incurred, including interest on short-term and long-term borrowings.

Foreign currency translation

The functional and presentation currency of US1 Critical Minerals Limited and its Australian subsidiaries is Australian dollars (A\$). Foreign currency transactions are translated into the functional currency using the exchange rates ruling at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are retranslated at the rate of exchange ruling at the end of the financial reporting period. Foreign exchange gains and losses resulting from settling foreign currency transactions, as well as from restating foreign currency denominated monetary assets and liabilities, are recognised in profit or loss.

Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when fair value was determined.

The functional currency of the overseas subsidiaries is United States dollars (US\$) and Tanzanian Shillings (TZS). At the reporting date, the assets and liabilities of the overseas subsidiaries are translated into the presentation currency of US1 Critical Minerals Limited at the closing rate at the end of the financial reporting period and income and expenses are translated at the weighted average exchange rates for the period. All resulting exchange differences are recognised as other comprehensive income or expense and in a separate component of equity (foreign exchange translation reserve). On disposal of a foreign entity, the cumulative exchange differences recognised in foreign currency translation reserves relating to that particular foreign operation is recognised in profit or loss.

Derivatives at fair value through profit or loss

Derivative financial instruments are used to manage economic exposure to market risks relating to commodity prices. Policies and procedures are in place with respect to required documentation and approvals for the use of derivative financial instruments. Where specific financial instruments are executed, the Company assesses, both at the time of purchase and on an ongoing basis, whether the financial instrument used in the particular transaction is effective in offsetting changes in fair values or cash flows of the transaction. Derivative financial instruments are measured at fair value through profit or loss ("FVTPL") unless designated for hedge accounting.

Provisions

Provisions are recognised when the consolidated entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Employee benefits

Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled within 12 months of the reporting date are recognised in current liabilities in respect of employees' services up to the reporting date and are measured at the amounts expected to be paid when the liabilities are settled.

Other long-term employee benefits

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are recognised in non-current liabilities, provided there is an unconditional right to defer settlement of the liability. The liability is measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

Superannuation expense

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

Share-based payments

Equity-settled and cash-settled share-based compensation benefits may be provided to employees.

Equity-settled transactions are awards of shares, or options over shares, that are provided to employees in exchange for the rendering of services. Cash-settled transactions are awards of cash for the exchange of services, where the amount of cash is determined by reference to the share price.

The cost of equity-settled transactions is measured at fair value on grant date. Fair value is independently determined using either the Binomial or Black-Scholes option pricing model that takes into account the exercise price, the term of the option, the impact of dilution, the share price at grant date and expected price volatility of the underlying share, the expected dividend yield and the risk free interest rate for the term of the option, together with non-vesting conditions that do not determine whether the consolidated entity receives the services that entitle the employees to receive payment. No account is taken of any other vesting conditions.

The cost of equity-settled transactions is recognised as an expense with a corresponding increase in equity over the vesting period. The cumulative charge to profit or loss is calculated based on the grant date fair value of the award, the best estimate of the number of awards that are likely to vest and the expired portion of the vesting period. The amount recognised in profit or loss for the period is the cumulative amount calculated at each reporting date less amounts already recognised in previous periods.

The cost of cash-settled transactions is initially, and at each reporting date until vested, determined by applying either the Binomial or Black-Scholes option pricing model, taking into consideration the terms and conditions on which the award was granted. The cumulative charge to profit or loss until settlement of the liability is calculated as follows:

- during the vesting period, the liability at each reporting date is the fair value of the award at that date multiplied by the expired portion of the vesting period.
- from the end of the vesting period until settlement of the award, the liability is the full fair value of the liability at the reporting date.

All changes in the liability are recognised in profit or loss. The ultimate cost of cash-settled transactions is the cash paid to settle the liability.

Market conditions are taken into consideration in determining fair value. Therefore any awards subject to market conditions are considered to vest irrespective of whether or not that market condition has been met, provided all other conditions are satisfied.

If equity-settled awards are modified, as a minimum an expense is recognised as if the modification has not been made. An additional expense is recognised, over the remaining vesting period, for any

modification that increases the total fair value of the share-based compensation benefit as at the date of modification.

If the non-vesting condition is within the control of the consolidated entity or employee, the failure to satisfy the condition is treated as a cancellation. If the condition is not within the control of the consolidated entity or employee and is not satisfied during the vesting period, any remaining expense for the award is recognised over the remaining vesting period, unless the award is forfeited.

If equity-settled awards are cancelled, it is treated as if it has vested on the date of cancellation, and any remaining expense is recognised immediately. If a new replacement award is substituted for the cancelled award, the cancelled and new award is treated as if they were a modification.

Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interest. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Issued capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

Business combinations

The acquisition method of accounting is used to account for business combinations regardless of whether equity instruments or other assets are acquired.

The consideration transferred is the sum of the acquisition-date fair values of the assets transferred, equity instruments issued or liabilities incurred by the acquirer to former owners of the acquiree and the amount of any non-controlling interest in the acquiree. For each business combination, the non-controlling interest in the acquiree is measured at either fair value or at the proportionate share of the acquiree's identifiable net assets. All acquisition costs are expensed as incurred to profit or loss.

On the acquisition of a business, the consolidated entity assesses the financial assets acquired and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic conditions, the consolidated entity's operating or accounting policies and other pertinent conditions in existence at the acquisition-date.

Where the business combination is achieved in stages, the consolidated entity remeasures its previously held equity interest in the acquiree at the acquisition-date fair value and the difference between the fair value and the previous carrying amount is recognised in profit or loss.

Contingent consideration to be transferred by the acquirer is recognised at the acquisition-date fair value. Subsequent changes in the fair value of contingent consideration classified as an asset or liability is recognised in profit or loss. Contingent consideration classified as equity is not remeasured and its subsequent settlement is accounted for within equity.

The difference between the acquisition-date fair value of assets acquired, liabilities assumed and any non-controlling interest in the acquiree and the fair value of the consideration transferred and the fair value of any pre-existing investment in the acquiree is recognised as goodwill. If the consideration transferred and the pre-existing fair value is less than the fair value of the identifiable net assets acquired, being a bargain purchase to the acquirer, the difference is recognised as a gain directly in profit or loss by the acquirer on the acquisition-date, but only after a reassessment of the identification and measurement of the net assets acquired, the non-controlling interest in the acquiree, if any, the consideration transferred and the acquirer's previously held equity interest in the acquirer.

Business combinations are initially accounted for on a provisional basis. The acquirer retrospectively adjusts the provisional amounts recognised and also recognises additional assets or liabilities during the measurement period, based on new information obtained about the facts and circumstances that existed at the acquisition-date. The measurement period ends on either the earlier of (i) 12 months from the date of the acquisition or (ii) when the acquirer receives all the information possible to determine fair value.

Earnings per share

Basic earnings per share

Basic earnings per share is calculated by dividing the profit attributable to the owners of US1 Critical Minerals Limited, excluding any costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the financial year.

Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares and the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

Note 3. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant

risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Exploration and evaluation asset

The consolidated entity capitalises expenditure relating to exploration and evaluation where it is considered likely to be recoverable or where the activities have not reached a stage that permits reasonable assessment of the existence of reserves.

The ultimate recoupment of capitalised expenditure in relation to each area of interest is dependent on the successful development and commercial exploitation or, alternatively, sale of the respective areas the results of which are still uncertain.

The Zeus project has yet to reach a stage of development where a determination of the technical feasibility or commercial viability can be finally assessed. Whilst the project is not currently generating cash flow, the consolidated entity is of the view that the area of interest will contribute significant value in the future and that this value will be in excess of the current value of the capitalised costs. In these circumstances, whether there is any indication that the asset has been impaired is a matter of judgement, as is the determination of the quantum of any required impairment adjustment. For the year ended 30 June 2026, the directors have fully impaired exploration and evaluation expenditure of \$202,546. The impairment was recognised not as a result of the assets losing commercial value, but in compliance with a change in the interpretation of the requirements of AASB 6, due to the absence of an independent valuation to support the carrying value at balance date (refer to note 10).

Share-based payment transactions

The consolidated entity measures the cost of equity-settled transactions with employees by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by using either the Binomial or Black-Scholes model taking into account the terms and conditions upon which the instruments were granted. The accounting estimates and assumptions relating to equity-settled share-based payments would have no impact on the carrying amounts of assets and liabilities within the next annual reporting period but may impact profit or loss and equity.

Income tax

The benefit of the tax losses has not been brought to account at 30 June 2026 because the directors do not believe it is appropriate to regard realisation of the deferred tax asset as being probable at this point in time. These tax losses are also subject to final determination by the Taxation authorities when the consolidated entity derives a taxable income. The benefits will only be realised if:

- the Company and its subsidiaries derive future assessable income of a nature and of an amount sufficient to enable the benefit of the deduction for the losses to be realised;
- the Company and its subsidiaries continue to comply with the conditions for the deductibility imposed by law; and
- no changes in the tax legislation adversely affect the Company and its subsidiaries in realising the benefit of the losses.

Australian tax losses are subject to further review by the consolidated entity to determine if they satisfy the necessary legislative requirements under the Income Tax legislation for the carry forward and recoupment of tax losses.

Note 4. Segment reporting

Operating segments are presented using the 'management approach', where the information presented is on the same basis as the internal reports provided to the Chief Operating Decision Makers ('CODM'). The CODM, which is the Board of Directors, is responsible for the allocation of resources to operating segments and assessing their performance.

The principal business and geographical segment of the consolidated entity is the acquisition, exploration, evaluation, development and exploitation of mineral tenements within Tanzania. The consolidated entity has its head office in Australia.

Impairment

Ultimate recovery of deferred exploration and evaluation costs is dependent upon the success of pre-feasibility studies, exploration and evaluation or sale or farm-out of the exploration interest. Broadly, the consolidated entity has two cost centres, Corporate and Exploration. Where identifiable, costs associated with the Exploration cost centres are capitalised. These costs are annually reviewed for impairment and a charge is made direct to the statement of profit or loss and other comprehensive income of the consolidated entity where an impairment is identified. The consolidated entity has reviewed all of its tenements and has only carried forward the expenses on the tenements that give rise to a potential economic benefit to the consolidated entity through development or exploration.

Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the consolidated entity. Of the increase, \$577,500 was recognised as share-based payment expense in profit or loss (comprising the 60,000,000 and 3,000,000 option tranches) and \$817,218 in respect of the 50,000,000 and 25,000,000 option tranches granted in connection with the December 2025 and May 2026 placements was recorded within issued capital as a cost of those placements. The option reserve of \$1,500,553 is significant in the context of the Group's net assets of \$373,798. Management determined the fair value of each tranche using the Black-Scholes option pricing model, applying a GARCH-based volatility forecast, risk-free rates of 3.301%, 3.60% and 4.616% stated to be Australian Government bond yields of a tenor matching the expected life of each tranche, a nil dividend yield and the full contractual term to expiry as the expected life.	- Agreeing the opening and closing option reserve balances to the general ledger and the lead schedule, and agreed each option's quantity, exercise price and expiry date to the valuation reports; - Recalculating the 3,000,000 and 50,000,000 option values in our own model. Our results of \$0.0025 and \$0.0095 per option agreed with the Group's valuations once the 100x input scaling in the December 2025 output was taken into account. The measurement of the options is inherently judgemental and sensitive to the volatility, risk-free rate, grant date spot price and expected life assumptions. The market price of the Company's shares during the year was low (\$0.008 to \$0.024) and highly volatile, and the valuation inputs applied are not directly observable in the market. In addition, the valuations are produced by a third-party add-in using model inputs that are scaled in the application, which gives rise to a risk of arithmetic and input-scaling error in the fair value attributed to individual tranches, and to a risk that grants are measured without a corresponding valuation output.

We therefore considered this matter to be of most significance in our audit.

- Agreeing the 3.301% rate to the RBA two-year bond yield at 13 August 2025, and assessed the 3.60% and 4.616% rates for the December 2025 and May 2026 grants given each option's life.
- Comparing the volatility forecasts with our own historical volatility calculation, which gave about 115% to 126% over one and two years, and considered the nil dividend and expected life assumptions against AASB 2;
- Recalculating the \$577,500 expense and agreed the lapse of the 20,000,000 options on 31 December 2025, and we considered how sensitive the values are to changes in volatility, expected life and share price; and
- Assessing whether the share-based payment disclosures, including the option terms and the fair value inputs, are adequate.

Impairment of Exploration and Evaluation Assets – refer to Note 10 Exploration and Evaluation Assets

At 30 June 2026 the Group recognised no carrying amount for exploration and evaluation (E&E) assets on its Tanzanian licences. The assets were fully impaired to nil at 30 June 2025 following an audit adjustment recommended by us and recorded by management, so the opening carrying amount at 1 July 2025 was nil. FY26 capitalised E&E expenditure of \$202,725 was also fully impaired to nil at 30 June 2026 on the same basis — the absence of an independent valuation to support the carrying value at balance date.

The assessment of recoverability is highly judgemental. Under AASB 6, E&E assets must be tested when facts and circumstances suggest the carrying amount may exceed recoverable amount; AASB 136 defines recoverable amount as the higher of fair value less costs of disposal and value in use.

Our procedures included:

- Evaluating management's assessment of impairment indicators and the decision to fully impair the assets under AASB 6, due to the absence of an independent valuation to support the carrying value at balance date;
 - Reviewing documentation confirming rights to tenure over the Group's areas of interest;
 - Testing a sample of current year exploration-related expenditures to supporting documents to assess consistency with the Group's accounting policy and AASB 6;
 - Reviewing documentation supporting rights to tenure, and considering the impact of the going concern position (Note 1) and the expected disposal proceeds on the funding assumptions;
 - Assessing the adequacy of disclosures in Note 10 and the subsequent events disclosure, including the basis of the impairment, the Group's intentions for the tenements, and the terms and conditionality of the disposal;
 - Obtaining written representations on the impairment assessment, the information provided on recoverability and the disposal, and management's intentions for the tenements.

Subsequent to the reporting date, the Group entered into a sale and purchase agreement with third parties to dispose of its interest in several of its mineral exploration licences, for consideration payable in cash (or shares) in stages, a portion of which remains contingent on the satisfaction of specified technical and development milestones. An exclusivity fee was deposited on execution, in addition to the consideration, and is repayable if completion does not occur within the agreed initial period or to the extent it exceeds the amounts actually applied. Completion is conditional, including due diligence, receipt of the regulatory consents, entry into completion documents, no material adverse change, and evidence of payment of amounts due to the relevant authorities. If the conditions are not satisfied by the agreed long-stop date, the agreement terminates automatically.

With the assets fully impaired to nil, and subject to agreement of the FY26 capitalised amount and impairment amount to the final trial balance and signed financial statements and to adequate disclosure, we did not identify a material misstatement in relation to the carrying amount of the E&E assets. We considered whether our inability to set an independent recoverable amount parameter required modification of our opinion under ASA 705 and concluded that it did not, as no E&E asset carrying amount remains recognised at 30 June 2026 and the disclosures are adequate.

The sale and purchase agreement is an event after the reporting period that also provides audit evidence relevant to recoverable amount at 30 June 2026 — evidence of fair value less costs of disposal for the licences it covers, and of the Group's intention to dispose of, rather than continue exploring, those licences. The matter was of most significance because of the amounts written off, the judgement applied by management, the absence of sufficient appropriate evidence to support an independent recoverable amount for the licences outside the agreement or for the contingent consideration, and the linkage between the impairment conclusion and the Group's ability to raise funding.

The directors are responsible for the other information. The other information comprises the information included in the Group's annual report for the year ended 30 June 2026, but does not include the financial report and our auditor's report thereon.
