Dear Fellow Shareholder

During the past year, Cullen initiated exploration at the Yardilla gold project, a major addition to its exploration portfolio, and saw increased drilling activity by its JV partners focused on gold at Killaloe in Western Australia and copper-gold at Killero in Finland. At Mt Eureka, JV Manager High-Tech Metals achieved its 75% Eureka equity interest and is planning exploration of gold targets across its Mt Fisher - Mt Eureka projects.

Cullen has two new exciting projects, both of which are focussed in granite-gneissic terrain along the Yilgarn Craton boundary and importantly are guided by significant ore deposit models. The Yardilla Project lies along trend from Tropicana, a world-class gold deposit hosted in high-grade metamorphic gneissic rocks. Cullen's first-pass aircore drilling program, recently completed at Yardilla in May, successfully confirmed and extended historical gold anomalies at the Cleanthes and Lila prospects, intersecting prospective, altered and foliated gneisses. Follow-up drilling at both prospects is a priority.

The second new project comprises recently granted tenure in granite-greenstone of the Archaean Marymia Dome, strategically adjacent to Catalyst's Hermes gold deposits. Cullen proposes to target geochemical anomalies and favourable geological settings identified from previous historical exploration, with geological mapping and geochemical sampling programs planned to prioritise drill targets.

Other Cullen wholly owned projects include several targets for follow-up drilling. At Wongan Hills, IP and VTEM anomalies at the Wongan prospect, supported by positive geological, geochemical and other geophysical data, were drill tested with some encouragement and remain under investigation. At North Tuckabianna, near Cue in Western Australia, a geophysical survey and/or a diamond drilling program is proposed, targeting favourable structures where shear-related, low-grade gold mineralisation has been discovered to date.

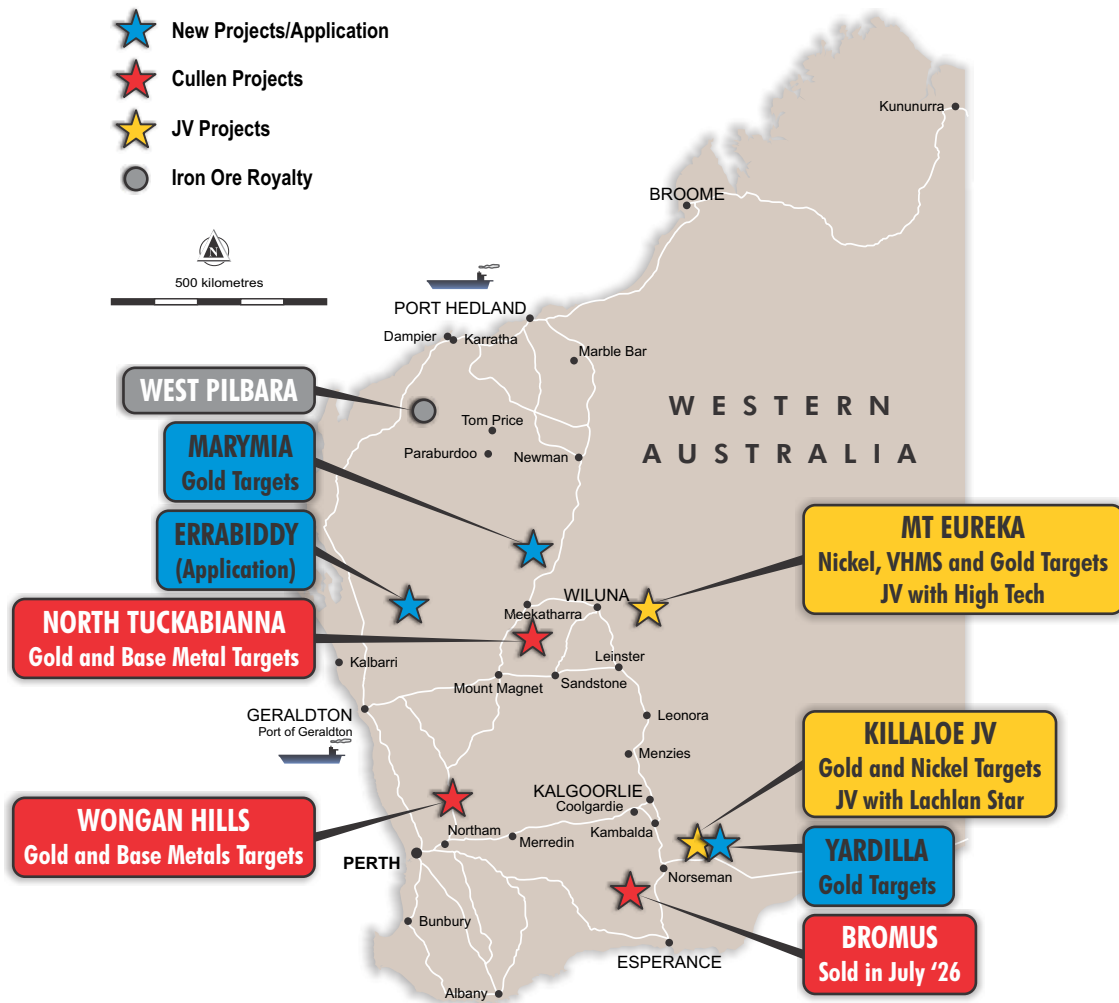
In last year's Chairman's Report, I signalled that the commencement and advancement of mining at Mineral Resources' Onslow Iron project (WA) during the year, had brought the spotlight onto Cullen's two West Pilbara Iron Ore Royalties, over resources very close to Onslow Iron. Of these, the royalty at Wyloo, was sold during the year for \$1.5M, following a decision to monetise this asset. Cullen currently retains its West Pilbara Iron Ore Royalty over the Catho Well Deposit.

I am pleased to report that Cullen has maintained and advanced its projects with a small but efficient team, and I look forward to the next round of exploration programmes. Finally, I would like to acknowledge the work of Managing Director Dr Chris Ringrose, my fellow director Mr Wayne Kernaghan, and our consultants and contractors for their valuable contributions throughout the year.

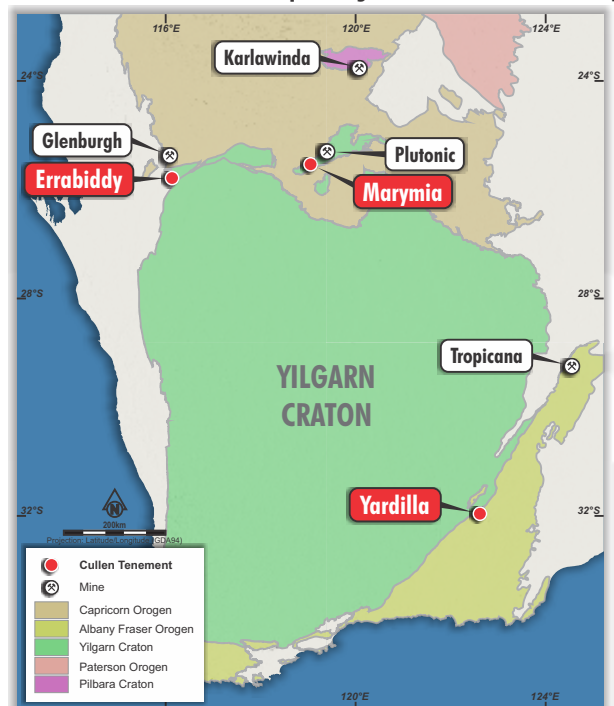
WESTERN AUSTRALIA | Project Location Map



FINLAND | Project Location Map



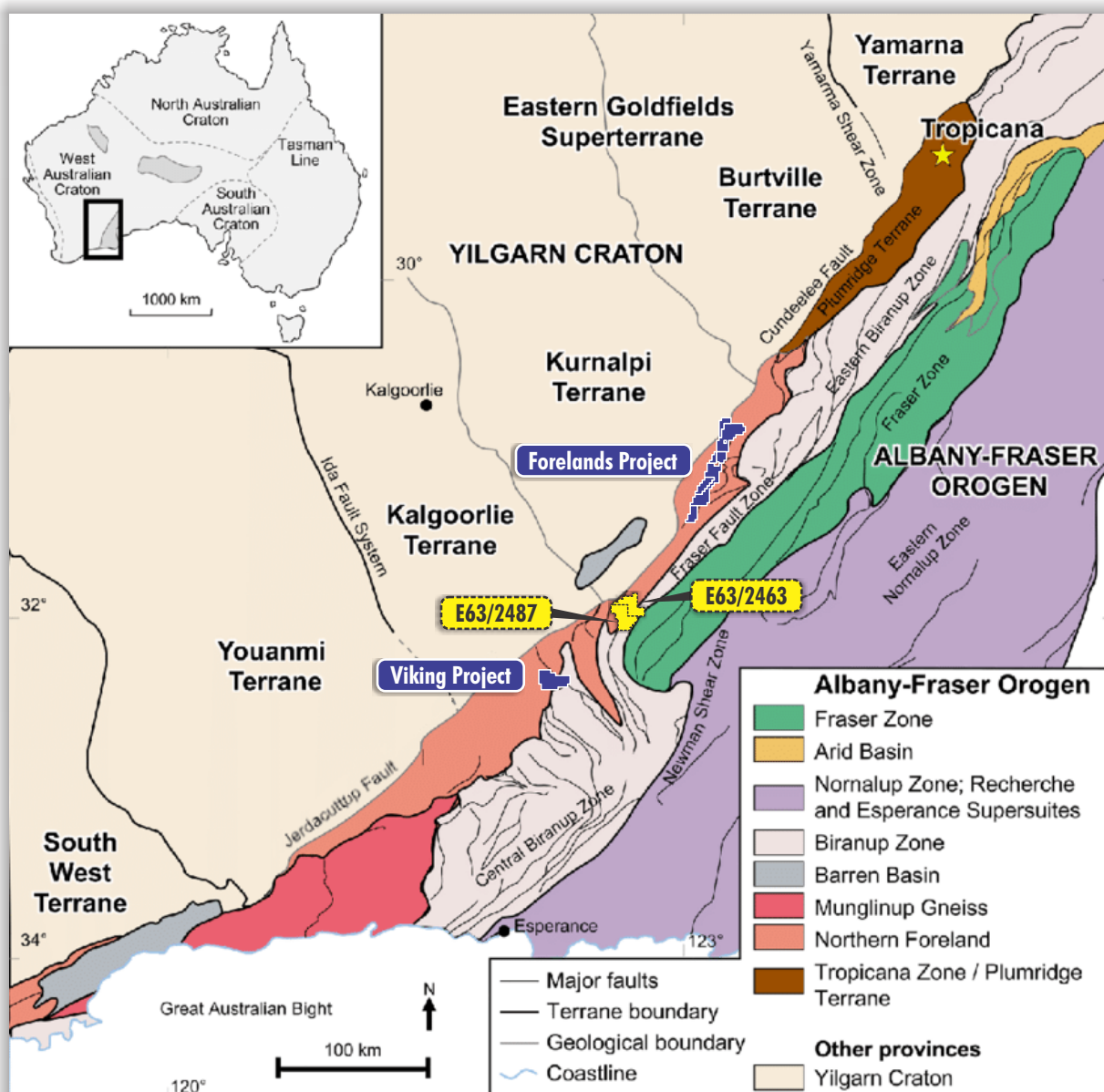
YILGARN CRATON | Project Location Map



YARDILLA PROJECT - Cullen 90% - 100%

Yilgarn Craton Margin - Gold

Cullen Metals Pty Ltd, a wholly owned subsidiary of Cullen Resources Limited, has an Option to Purchase up to a 90% interest in Exploration Licence Application **E63/2463** (~ 150 sq. km) in the Eastern Goldfields of Western Australia. Cullen Exploration Pty Ltd, a wholly owned subsidiary of Cullen Resources Limited, holds granted licence **E63/2487** (100%), to create a substantial combined land package of ~ 325 sq. km - the **Yardilla Project**, centered about 90 km east of Norseman. These tenements will form a exploration focus going forward, with several substantial geochemical anomalies to be drill tested.

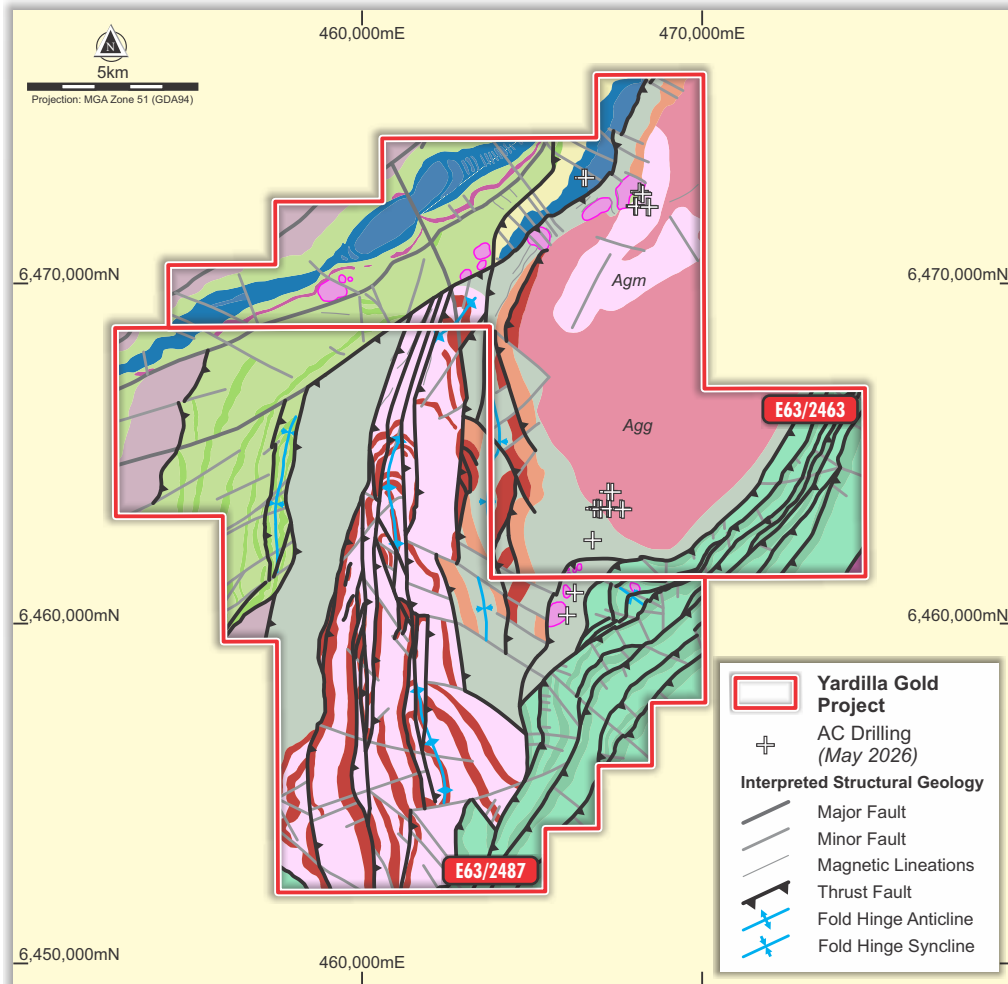

During the year Cullen commissioned consultants **Terra Resources** to integrate and interpret all available geophysical, surface mapping, geochemical and drilling data. The results of this study will assist in interpretation of assay data, and for further target prioritisation.

YARDILLA PROJECT

Yilgarn Craton Margin

Yardilla includes two substantial gold prospects “**Lila**” and “**Cleanthes**”, defined by gold-in-calcrete soil anomalies up to **5 x 1km at >14 to 86 ppb Au** from historical, systematic, high standard exploration. Other historical exploration outlined gold soil anomalies at **Lila and Lila West**, using an MMI assaying technique, and at Ten Mile Rocks using BLEG (Bulk Leach Extractable Gold) assaying of drainage samples (ASX: CUL; 16-1;28-1; 6-2-2025). Historical RAB drilling has only tested the **Lila and Cleanthes Prospects** in the regolith but intersected multiple zones greater than 0.1g/t Au and several greater than 1g/tAu, with anomalous Cu, Ag and W.

The **Lila, Lila West, Ten Mile Rocks and Cleanthes Prospects** combined form a target trend of ~25km of imbricate thrust sheets and cross-cutting faults/thrusts.

The **Mordicus PGE-Ni Prospect** lies on a differentiated, ovoid-shaped mafic intrusion (in plan) on the Jimberlana dyke with historical rock chip results up to: **50-56% Fe; 582ppb Pd, 115 ppb Pt, and 5277 ppm Ni**.

Further exploration at Yardilla will focus on these shallowly-tested gold prospects and further investigation of the Mordicus mafic intrusion and its structural setting where previous chip sampling has been limited.

During the year, Cullen completed **first pass, reconnaissance air core drilling following heritage surveying to test** better historical, shallow, gold drill anomalies at the **Cleanthes and Lila Gold Prospects** and sampled their stratigraphic settings (ASX: CUL;10-6-2026).

This program returned best assays of:

- **10m @ 0.14 g/t Au** (YAAC014 from 30m) and **10m @ 0.18 g/t Au** (YAAC015 from 25m) at **Cleanthes Prospect**, and;
- **5m @ 0.14 g/t Au** (YAAC007 from 45m) and **1m at 0.19 g/t Au** (YAAC 006 from 50m to EoH) at the **Lila Prospect**.

The drilling supports the current bedrock interpretation: at **Lila**, the granite margin is interlayered with mafic gneisses; at **Cleanthes**, mafic gneisses occur in gneissic granite in contact with metapelites. Foliated to gneissic, mafic and/or felsic, sericitic and/or biotitic rocks with trace to 5% pyrite were intersected in this first round of drilling.

At **Lila**, further AC and/or RC drilling is planned to test down dip of recent anomalies and to complete a drill traverse across a complex structural and lithological section that hosts the regional Cundeelee Fault/Shear Zone, which has never been drilled at this position . At **Cleanthes**, further drilling is planned to test down dip of current historical/Cullen anomalies and along the undrilled contact of foliated gneissic granite with greenstone bands close to Archaean metapelite, muscovite schist. Although the orientation of Cullen's gold drill anomalies at **Lila and Cleanthes** suggests a westerly dip, further drilling is required to understand structural controls.

WONGAN HILLS PROJECT - Cullen 90%

~200km Northeast of Perth

This project hosts substantial laterite and soil base metal geochemical anomalies in a greenstone belt considered prospective for Volcanic Hosted Massive Sulphide (VHMS) mineralisation. Cullen's exploration to date has included: project wide VTEM, follow-up ground EM; and, 2D DDIP (Two-dimensional Dipole-Dipole Induced Polarisation and Resistivity) surveying with air core and RC drilling of various targets. Significant geochemical anomalies remain largely unexplained. Underlying, felsic intrusions may have generated Cu-Au-(Zn-Ag) mineralisation along faults, and further drill testing of this model is warranted.

The Wongan Prospect, on the western side of the Wongan Hills Greenstone Belt, (WHGB) hosts a trend of VTEM anomalies lies within a ~ 4 x 1km target area comprising: Ag-in-BLEG, hydrothermally altered adamellite with trace chalcopyrite (Cullen drilling), and is marginal to historical copper occurrences in small diggings. The nearest deep drilling is Cullen's **WHDDH001**, ~400m NE of the chargeability anomaly, which intersected minor **chalcopyrite-pyrite, sphalerite and pyrrhotite clasts in a hydrothermally-altered metasediment/mafic sequence**. Follow up drilling of this mineralisation is warranted.

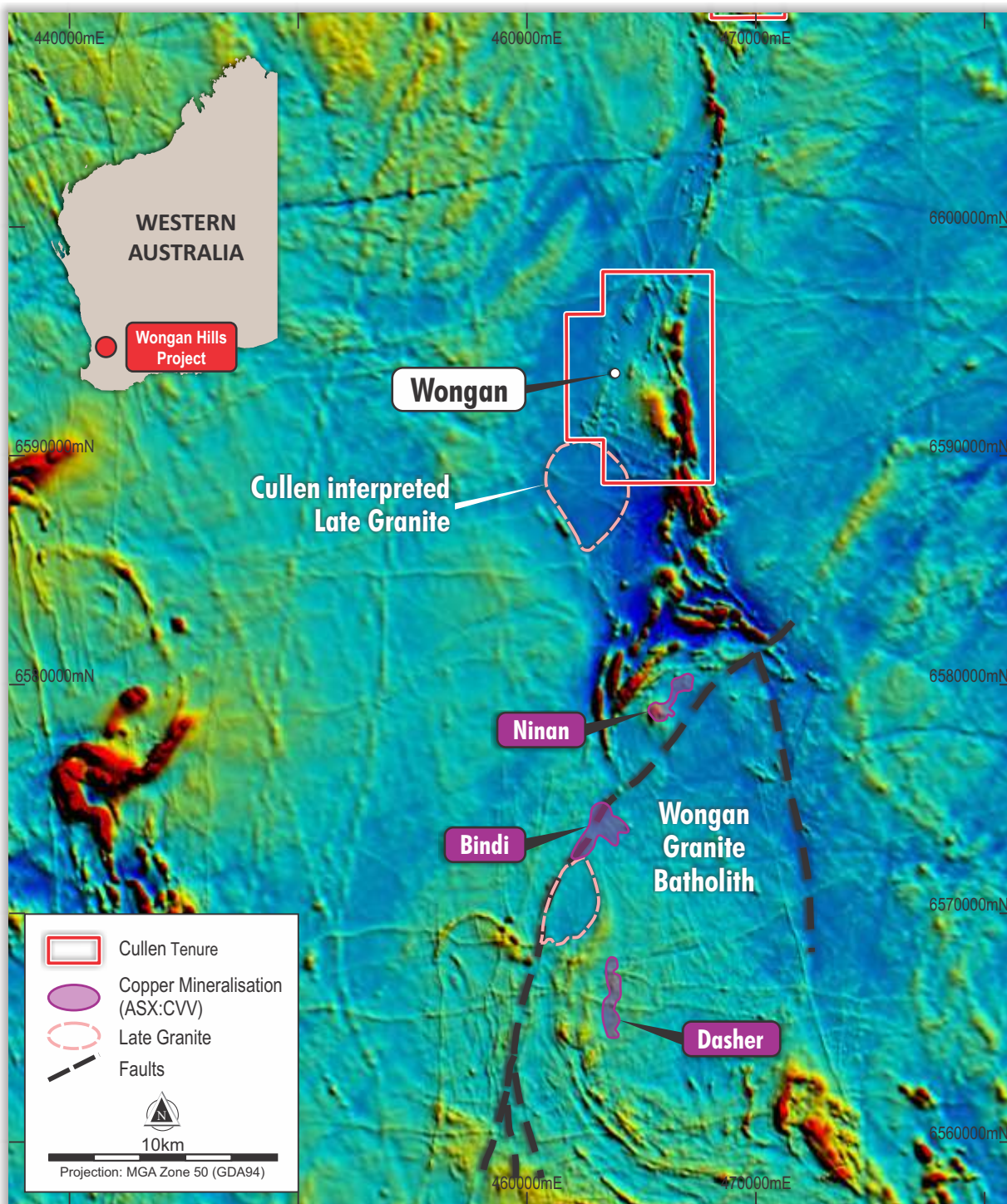

WONGAN HILLS PROJECT

Gold and Base Metals

The **Wongan Prospect** is ~15km north of the Bindi copper resource (ASX:CVV) in a similar geological setting for copper mineralisation of this type viz: high strain zones; late-stage granites; fault zones as fluid conduits (as in WHDDH001); and broad areas of geochemical anomalies including Cu, Ag, Sb, and As, as seen in Cullen's surface sampling and drilling. These anomalies are potentially indicators of a mineralising system.

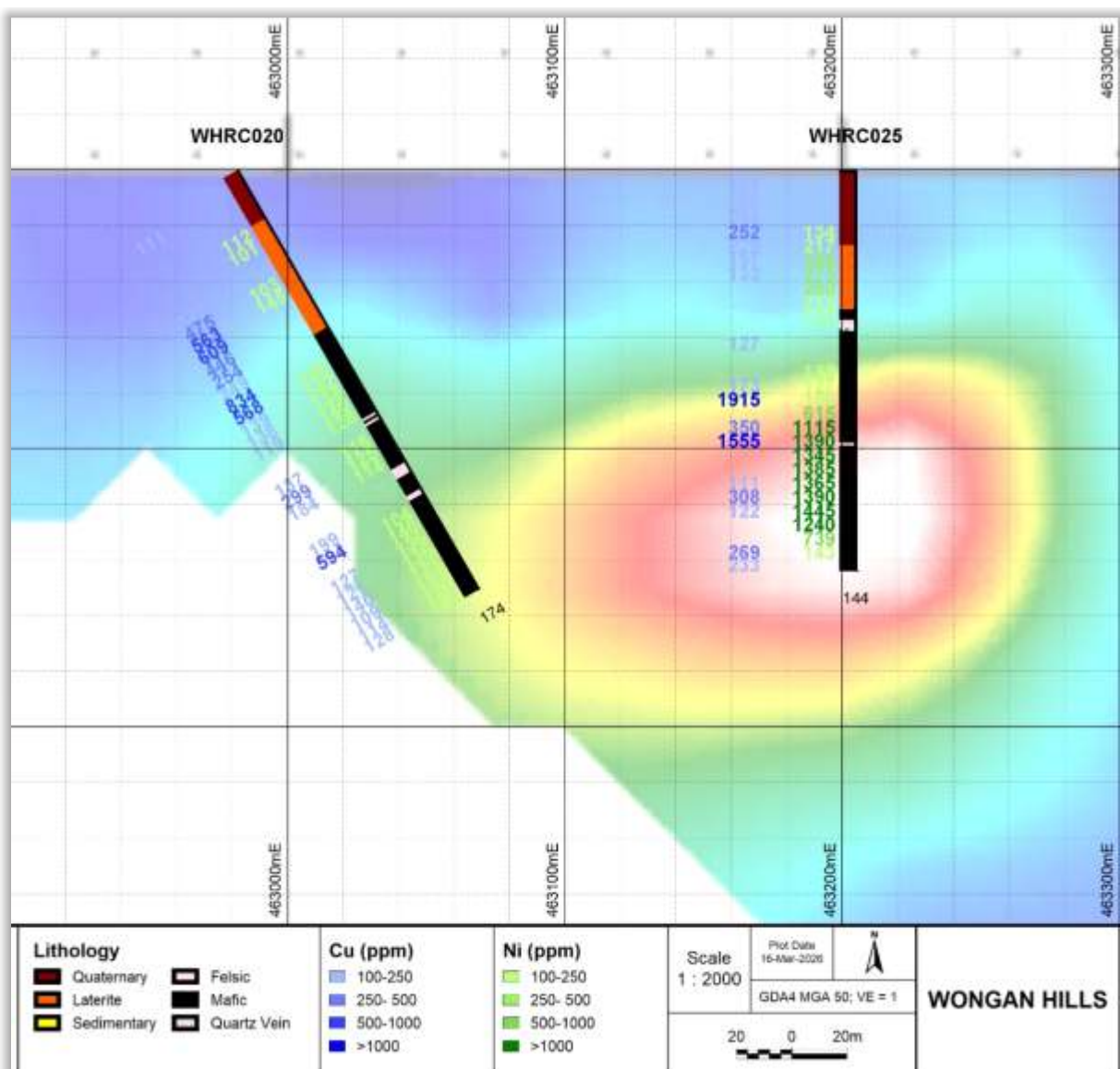

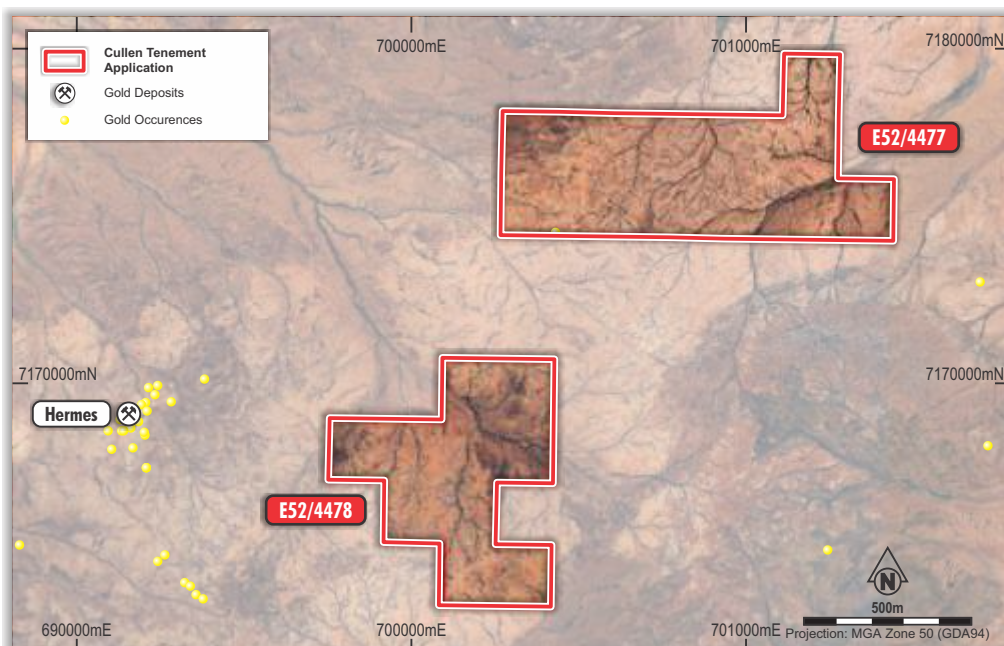
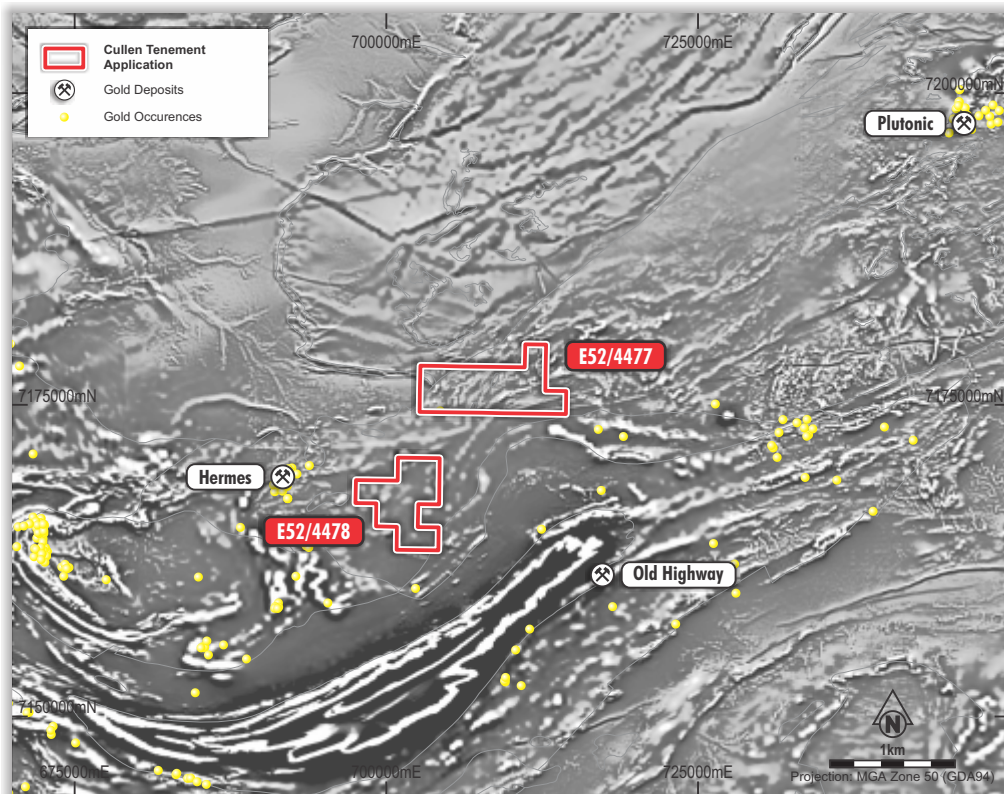
During the year, four reconnaissance, “slimline” RC drill holes were completed at the **Wongan Prospect to test IP**, geochemical, structural and air core anomalies, for copper and base metals. Drill hole WHRC025 testing an IP anomaly, returned anomalous copper (**5m @ 1915 ppm from 80m; and 5m @ 1555 ppm from 95m**) at the contact ultramafic hosted by basalt. These are the highest copper assays from Cullen’s drilling beyond the area of the laterite anomaly (ASX:CUL; 18-3-2026). Other ultramafic contacts at Wongan, mapped by aeromagnetic data interpretations, north of WHRC025 are a focus for follow-up drilling for copper, especially where strata are folded and/or faulted and have associated VTEM anomalies.

MARYMIA PROJECT - Cullen 100% Gold

Cullen's underexplored Exploration Licences (EL's 52/4477 and 4478, ~ 75 sq. km in total) are centered ~120km north of Meekatharra and ~50km southwest of the Plutonic Mine in the granite-greenstone terrane of the Marymia Inlier. At the Hermes gold deposit, Catalyst Metals Ltd has reported some very significant gold intersections below three of the deposits (including: **13m @ 11.4 g/t Au, Hawkeye pit; and 16m @ 10.6 g/t Au, Klinger pit**, see ASX:CYL; 23-5-25). These deeper anomalies suggest a significant-mineralising system. Cullen's evaluation of historical data continues with Cullen's upcoming initial exploration to include: field investigations, soil sampling, and mapping to generate drill targets (see Air mag and air photo image below).



KILLALOE JV - Cullen 20% FCI to DTM

Gold and Nickel

The Killaloe Project is located approximately 20 km north-east of the Norseman mining centre in Western Australia's Eastern Goldfields. The project sits within a highly prospective greenstone belt that forms the southern extension of the Kambalda Domain.

In July 2025, JV Manager Lachlan Star reported significant high-grade intercepts and broader zones of strong gold mineralisation at the Duke Main prospect (ASX: LSA; 28-7-2025) including:

- 9m @ 2.11g/tAu from 81m, incl. 2m @ 8.60g/tAu from 83m (KRC007)
- 24m @ 0.70g/tAu from 8m, incl. 4m @ 1.39g/tAu from 28m (KAC0039)
- 22m @ 0.65g/tAu from 8m, incl. 2m @ 1.28g/tAu from 28m (KAC0050)
- 10m @ 0.70g/tAu from 32m, incl. 2m @ 1.50g/tAu from 40m (KAC0051)

In January 2026, drilling identified the western down-dip continuation of the shallow gold system at the Duke Main prospect, with results including:

- 13m @ 0.52g/tAu from 25m (KRC026); and,
- 19m @ 0.24g/tAu from 41m (KRC027)

Follow-up drilling to test broad gold intercepts returned from previous drilling at Duke East and Duchess Prospects is planned, and Lachlan Star has been awarded up to \$118,000 in co-funded drilling support under the Western Australian Government's Exploration Incentive Scheme (EIS), supporting planned diamond drilling of key structural positions (ASX:LSA; 29-1-2026).

BROMUS SOUTH PROJECT - Cullen 100%

Gold and Lithium-in-Pegmatites

Since the end of the year, Cullen's Bromus tenements (**E63/2216 and E63/1894**) were sold to Sinclair Gold Ltd, ASX:SGC) for a total of \$350,000 in SGC shares and \$100,000 in cash.

BARLEE PROJECT - Cullen 100%

Cullen relinquished two remaining tenements within this project following assessment of portfolio priorities.

MT EUREKA JV - Cullen 25% FCI to PFS

Gold and Base Metals

Rox Resources Limited sold its 51% interest in the Mt Eureka Project to High-Tech Metals Ltd (ASX:RXL; 24-2-2025; ASX:HTM; 26-2-2025). High-Tech Metals has subsequently completed a review of the exploration potential within Mt Eureka, expanded its exploration footprint to test significant targets, and earned its 75% equity. The company outlined plans to commence exploration and resource-extension drilling across the Mt Fisher–Mt Eureka projects, (ASX:HTM; 10-4-2025; ASX:RXL; 30-5-2025).

High-Tech Metals has also reported that the Mt Eureka Project, the northern portion of the broader Mt Fisher–Mt Eureka greenstone belt, hosts multiple advanced gold prospects, including Mt Eureka, Southern-Galway and Taipan. Mt Eureka Project remains an important component of High Tech Metals broader growth strategy. Activities during the year have focused on: target generation and technical review; prioritisation of drill-ready targets and, integration into the broader production pipeline strategy (ASX:HTM; 30-7-2026).

FINLAND JV - Cullen 20% FCI to PFS

Copper - Gold

Cullen Finland Oy (**Capella Minerals Limited 80%; Cullen 20%**) holds five granted exploration permits in the Central Lapland Greenstone Belt (CLGB), and Capella has granted its strategic partner, Tümad, a gold producer in Western Türkiye, earn-in rights over its 80% interest in Cullen Finland Oy.

During the year, Capella Minerals Limited (TSX-V: CMIL), as JV Manager, completed a maiden diamond drill program at the Killero E. gold-copper project and initiated reconnaissance Base-of-Till (“BoT”) geochemical sampling programs over the Seisunselka and Jolhikko orogenic-style gold targets.

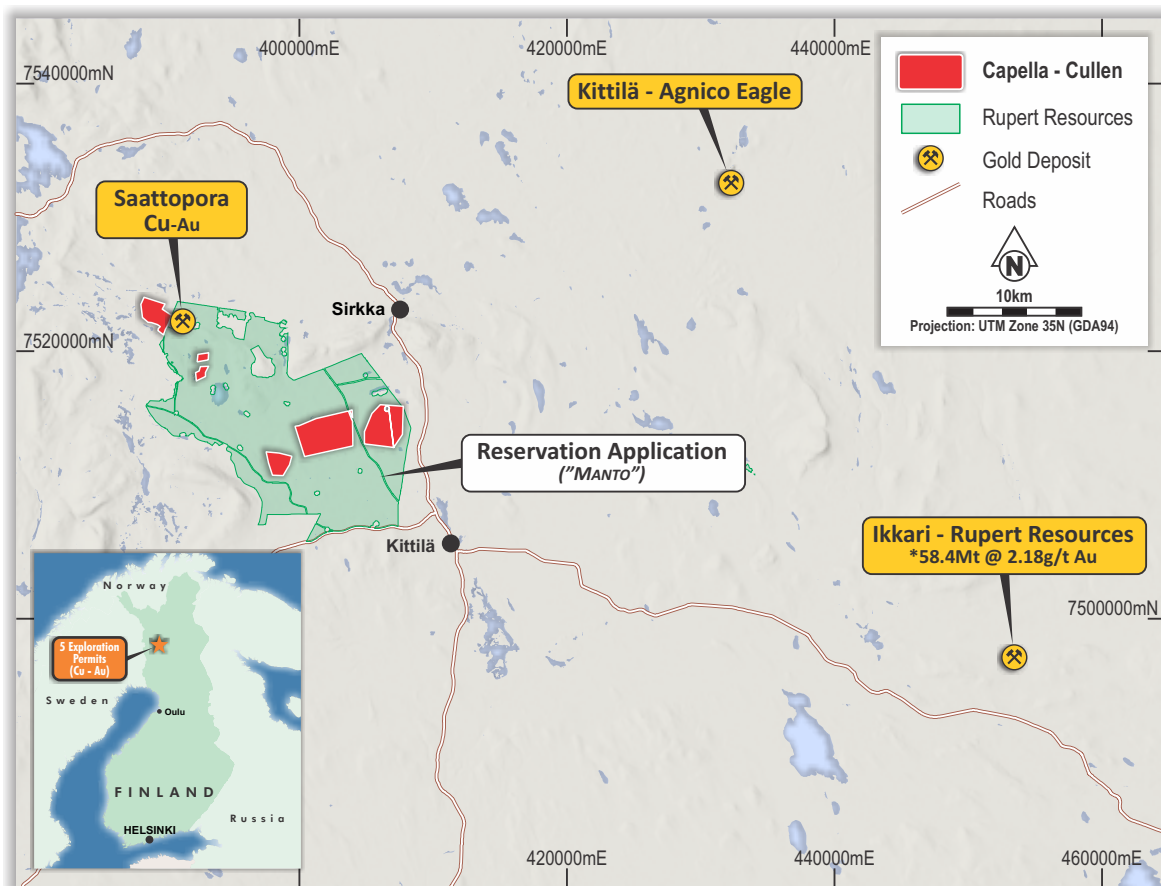
Diamond drilling at Killero E. comprised nine holes for 2,008m and targeted historical Base-of-Till (“BoT”) copper-gold anomalies. The program intersected up to 40m downhole of quartz-carbonate ± tourmaline veining in fine-grained meta-gabbro and mafic meta-volcanic rocks (ASX:CUL; 29-6-2026). Best results included:

- KE-001A: 0.76m @ 3.7% Cu + 19.6 g/tAg from 182.83m
- KE-003: 0.55m @ 0.6% Cu + 5 g/tAg from 181.15m
- KE-006: 0.70m @ 1.5% Cu + 7 g/tAg from 114.2m
- KE-004: 5m @ 0.4% Zn + 0.2% Cu + 2 g/tAg from 36.5m

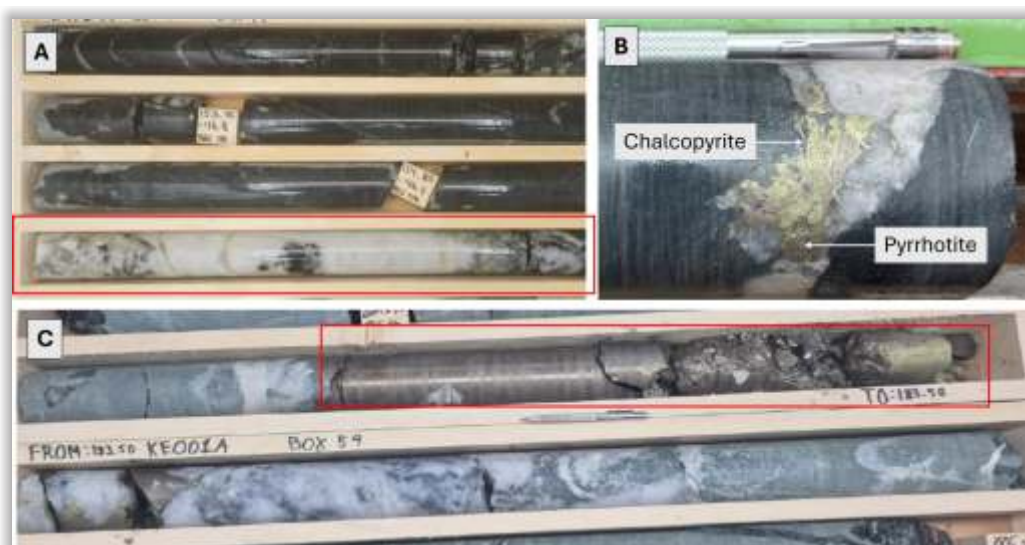

Copper - Gold

Reconnaissance diamond drilling has commenced at Killero W., targeting gold-copper anomalies (ASX:CUL; 6-7-2026), and further exploration is proposed to test possible extensions to Outokumpu Oy's former Saattopora gold-copper mining operation within the Saattopora W. permit area.

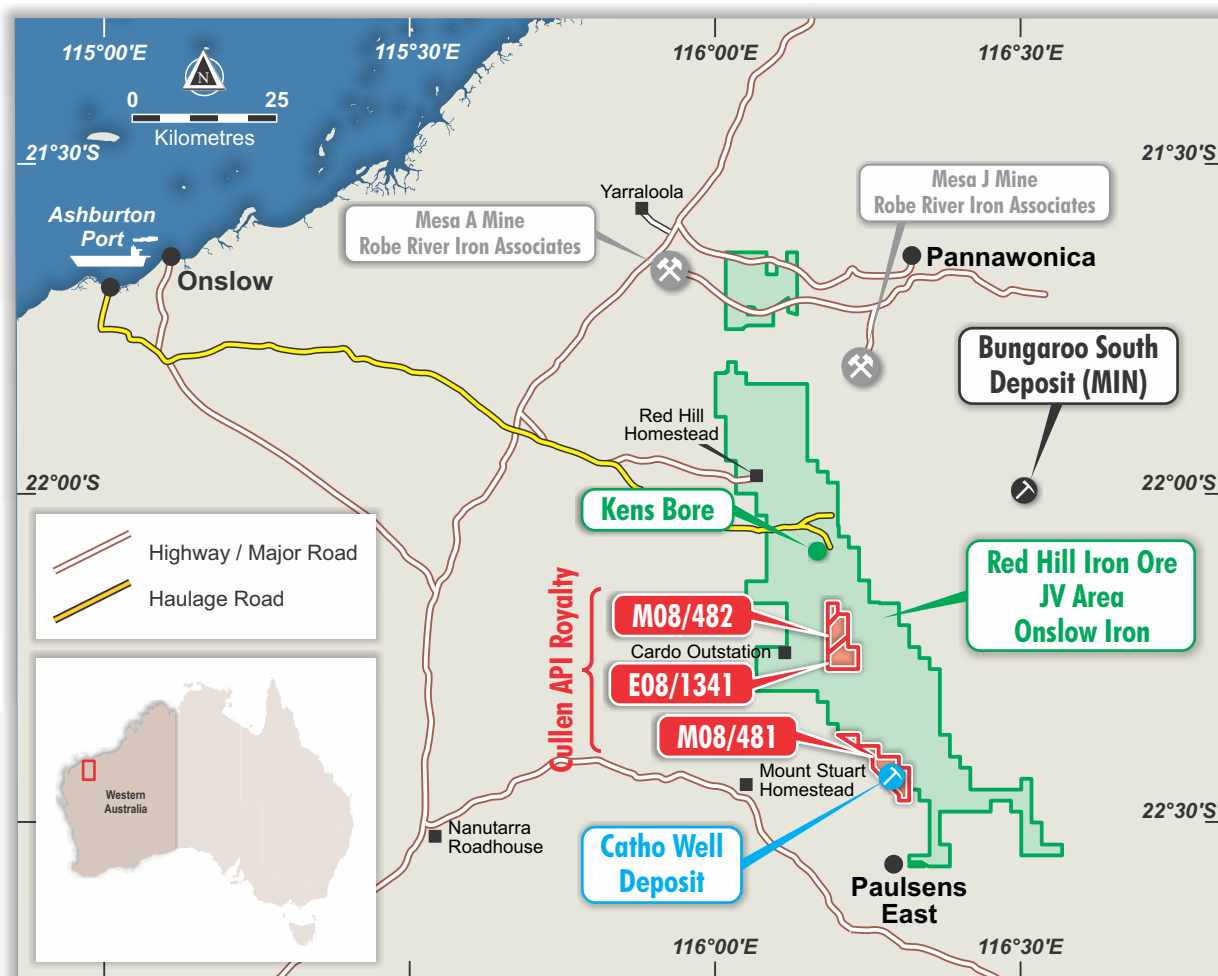

WEST PILBARA - IRON ORE ROYALTIES

Cullen Exploration Pty Ltd, a wholly-owned subsidiary of Cullen Resources Limited, holds a **1% F.O.B. royalty** over any production from the **Catho Well Channel Iron Deposit*** which adjoins **Onslow Iron** at its southern boundary (ASX: MIN). A **1% F.O.B. royalty** also applies to any iron ore production from the former **Mt Stuart Iron Ore JV tenements** (ASX: CUL; 4-4-2017) - the Payer of any royalty is API Management Pty Ltd. Cullen will also receive \$1M upon any Final Investment Decision.

***Catho Well** has an in situ, Mineral Resource estimate of **161Mt @ 54.40% Fe** (ASX: CUL 10-3-2015).



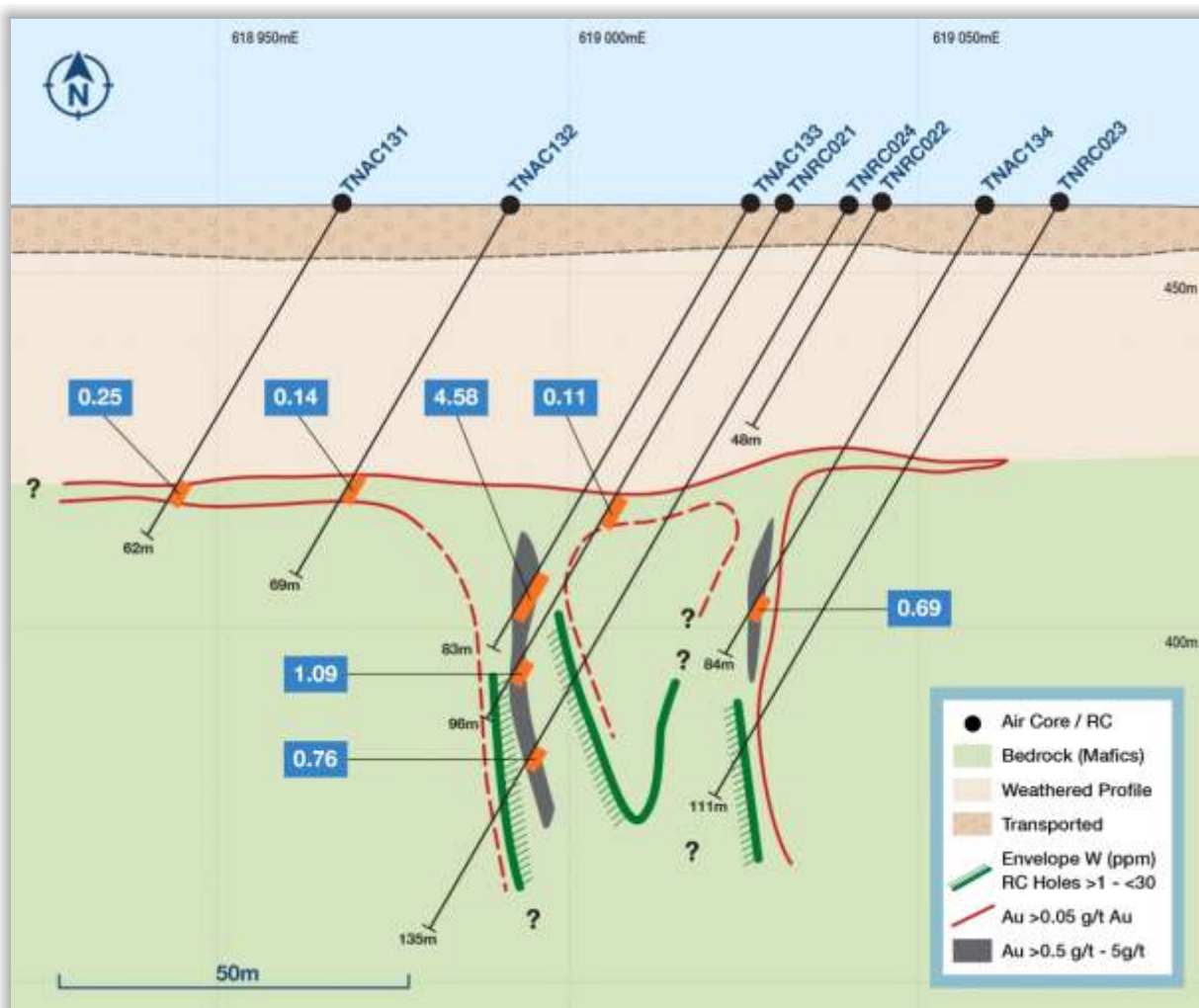
Location of Cullen's iron ore royalty tenements, West Pilbara, W.A. – none of which are part of **Onslow Iron**.

In August 2025, Cullen Resources Limited signed a binding Royalty Sale and Purchase Agreement (**RSPA**) among its wholly owned subsidiary, Cullen Exploration Pty Ltd, Cullen and Vox Royalty Australia Pty Ltd (**Vox**), a wholly owned subsidiary of Vox Royalty Corp. (NASDAQ & TSX:VOXR), for the sale of the Wyloo Royalty for **A\$1.5M cash** (ASX:CUL;25-8-2025). Cullen retains its prior disclosed rights to a **\$900,000** cash payable by FMG when any decision is made to commence mining on a commercial basis at Wyloo (ASX:CUL;3-8-2015).

NORTH TUCKABIANNA PROJECT - Cullen 100% Gold

Cullen's reconnaissance aircore drilling programs through 2022 and 2023, and historical drilling have shown the potential for higher grade gold mineralisation below the bedrock interface along prospective structures and lithological contacts. This generally sparse drilling has been too shallow to penetrate beneath transported cover or limited by first drill refusal depth.

Slimline RC drilling (TNRC021-025, 491m) in January 2023 testing below these air core anomalies defined deeper gold anomalies and a zone of elevated tungsten that defined a target trend for further drilling of section 6972400mN in this highly prospective geological region. At year's end, Cullen was seeking a suitable drill rig for a proposed program.

Mr John Horsburgh, a graduate of the Royal School of Mines, has over 40 years industry experience including 11 years with Solomon Pacific Resources NL. Prior to this he gained extensive experience in Australia and overseas with Getty Oil Development Co., Billiton and RTZ Group. Mr Horsburgh was a co-founder and Non-Executive Chairman of AIM and TSX listed public company Mariana Resources Limited, prior to its takeover by Sandstorm Gold Ltd. Mr Horsburgh has had no other directorships of ASX listed companies in the last three years.

- **Dr Chris Ringrose BSc, PhD, MBA, MAIMM, MAICD (Managing Director) (Appointed 19 June 2003)**

Dr Chris Ringrose has been an exploration geologist based mainly in Western Australia since he completed his geology degrees in Scotland in 1982. His career has included experience with EZ, Chevron and Aztec, and prior to joining Cullen, he was Exploration Manager with Troy Resources Limited for nine years. Dr Ringrose has also completed an MBA at Deakin University and brings to the Company significant management, exploration and project evaluation experience gained both in Australia and overseas. Principal Activities

The principal activity for the Consolidated Entity comprising Cullen Resources Limited ("the Company") and its controlled entities (together "the Consolidated Entity") during the course of the financial year was mineral exploration. There was no significant change in the nature of the Consolidated Entity's activities during the year.

Results

The profit attributable to the Consolidated Entity for the financial year was \$ 340,251(2025: loss \$902,321). No income tax was attributable to this result (2025: \$Nil).

Dividends

The directors do not recommend the payment of a dividend for this financial year. No dividend has been declared or paid by the Company since the end of the previous financial year.

Significant Changes in the State of Affairs

In the opinion of the directors there were no significant changes in the state of affairs of the Consolidated Entity that occurred during the financial year under review not otherwise disclosed in this report or the consolidated financial statements.

Review of Operations

Cullen is a mineral exploration company focused on the exploration of gold and base metals, either independently, or through Joint Ventures managed by partners companies.

During the year under review, the Company's exploration activities included project generation, database reviews, field mapping and prospecting, and drilling programs. Field activities were primarily focused on gold exploration at Yardilla, where air-core drilling was undertaken, and on base metal exploration at Wongan Hills, where reverse circulation (RC) drilling was completed.

The Company has farmed out its Finnish interests to Capella Minerals Limited. Subsequently, Capella entered into an earn-in agreement with Turkish mining company Tümad concerning its 80% ownership interest in Cullen Finland Oy. The Company's exploration activities, including joint venture projects, are focused in Western Australia and Finland.

The Company's principal projects and joint ventures are:

- Wongan Hills: gold, base metals, rare-element pegmatites and Ni-Cu-PGE prospects in the Wheatbelt region of Western Australia.
- North Tuckabianna: copper and gold project in the Murchison region of Western Australia.
- Bromus South: gold and rare-element pegmatite project in the Eastern Goldfields of Western Australia.
- Yardilla: gold project in the Eastern Goldfields of Western Australia (new project).
- Hermes: gold project in the Marymia Dome region of Western Australia (new project).
- Mt Eureka JV: gold, VHMS and nickel project in the Northeastern Goldfields of Western Australia.
- Killaloe JV: gold and nickel project in the Eastern Goldfields of Western Australia.
- Capella JV: copper-gold project in northern Finland.

A total of \$ 776,040 (2025: \$617,949) was spent on exploration by Cullen during the year, with joint venture partners contributing additional exploration funding across Cullen tenements. Cullen will continue to identify and evaluate both advanced and grass-roots opportunities throughout Australia and Finland. The portfolio remains under continual review, with a focus on projects considered likely to support the discovery of an economic mineral deposit.

During the year Cullen sold its 1.5% FOB royalty on up to 15Mt of iron ore production from Wyloo project tenements for \$1.5m to Vox Royalty Corp.

Material Business Risks

The Consolidated entity's activities have inherent risk and the Board is unable to provide certainty of the expected results of activities or that any or all of the intended activities will be achieved. No assurance can be given that the Consolidated Entity will achieve commercial viability through the successful exploration and/or mining of its tenement interests. Until the Consolidated Entity is able to release value from its projects, it is likely to incur ongoing operating losses. The material business risk that could influence the Consolidated Entity's future prospects, and the manner in which they are managed, are set out below.

Exploration and development risk

The tenements are at various stages of exploration. Mineral exploration and development are speculative and high-risk undertakings. The Consolidated Entity's operations may be affected by factors including failure to locate or identify mineral deposits, failure to achieve predicated grades, loss of skilled personnel and contractors, and insufficient or unreliable infrastructure.

Further capital requirements

The Consolidated Entity's projects will require additional funding to progress activities. There can be no assurances that additional capital or other financing will be available when needed, or that the terms of any such financing be favourable to the Consolidated Entity.

Corporate

At 30 June 2026 available cash totalled \$ 293,461 (2025: \$7,380). Refer note 1 (a) to the Financial Statements for discussion on going concern basis of preparation.

After Balance Date Events

There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the directors, to affect the operations of the Consolidated Entity, the results of those operations or the state of affairs of the Consolidated Entity in the subsequent financial years other than:

- The sale of the two Bromus tenements to Sinclair Gold Limited (ASX Code: SGC) for \$100,000 cash and \$350,000 in SGC shares which has been received.

Likely Developments and Future Results

Other than as referred to in this report, further information as to likely developments in the operations of the Consolidated Entity and the expected results of those operations would, in the opinion of the directors, be speculative and not in the best interests of the Consolidated Entity.

Environmental Regulation

The exploration activities of the Consolidated Entity in Australia are subject to environmental regulation under the laws of the Commonwealth and the States in which those exploration activities are conducted. The environmental laws and regulations generally address the potential impact of the Consolidated Entity's activities in the areas of water and air quality, noise, surface disturbance and the impact upon flora and fauna. The directors are not aware of any environmental matter which would have a materially adverse impact on the overall business of the Consolidated Entity.

Options

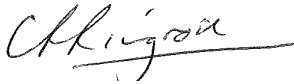

In recognising the need for the highest standards of corporate behaviour and accountability, the directors of Cullen Resources Limited have adhered to the principles of corporate governance and this statement outlines the main corporate governance practices in place throughout the financial year. The ASX Corporate Governance Council have released the fourth edition of Corporate Governance Principles and Recommendations. Having regard to the size of the Company and the nature of its enterprise, it is considered that the Company complies as far as possible with the spirit and intentions of the ASX Corporate Governance Council's Corporate Governance Principles and Recommendations. Board of Directors

When the need for a new director is identified, selection is based on the skills and experience of prospective directors, having regard to the present and future needs of the Company. Any director so appointed must then stand for election at the next Annual General Meeting of the Company.

Terms of Appointment as a Director

The constitution of the Company provides that a Director, other than the Managing Director, may not retain office for more than three calendar years or beyond the third annual general meeting following his or her election, whichever is longer, without submitting for re-election. One third of the Directors must retire each year and are eligible for re-election. The Directors who retire by rotation at each annual general meeting are those with the longest length of time in office since their appointment or last election.

Board Committees

In view of the size of the Company and the nature of its activities, the Board has considered that establishing formally constituted committees for audit, board nominations and remuneration would contribute little to its effective management. Accordingly audit matters, the nomination of new Directors and the setting, or review, of remuneration levels of Directors and senior executives are reviewed by the Board as a whole and approved by resolution of the Board (with abstentions from relevant Directors where there is a conflict of interest). Where the Board considers that particular expertise or information is required, which is not available from within their number, appropriate external advice may be taken and reviewed prior to a final decision being made by the Board.

Remuneration

Remuneration and other terms of employment of executives, including executive directors, are reviewed periodically by the Board having regard to performance, relevant comparative information and, where necessary, independent expert advice. Remuneration packages are set at levels that are intended to attract and retain executives capable of managing the Company's operations.

The terms of engagement and remuneration of executive directors is reviewed periodically by the Board, with recommendations being made by the non-executive directors. Where the remuneration of a particular executive director is to be considered, the director concerned does not participate in the discussion or decision making.

Make Timely and Balanced Disclosure

The board has in place written policies and procedures to ensure the Company complies with its obligations under the continuous disclosure rule 3.1 and other ASX Listing Rule disclosure requirements.

Independent Professional Advice

Directors have the right, in connection with their duties and responsibilities as directors, to seek independent professional advice at the Company's expense. Prior approval of the Chairman is required, which will not be unreasonably withheld.

Code of Conduct

In view of the size of the Company and the nature of its activities, the Board has considered that an informal code of conduct is appropriate to guide executives, management and employees in carrying out their duties and responsibilities.

Diversity Policy

The Company is in the process of establishing a diversity policy having regard to the size of the company and the nature of its business.

As at 30 June 2026, 100 % (2025: 100%) of the workforce is male with no females at board or senior management level. There is only one employee who is male.

Communication to Market & Shareholders

The Board of Directors aims to ensure that the shareholders, on behalf of whom they act, are informed of all information necessary to assess the performance of the directors and the Company. Information is communicated to shareholders and the market through:

- the Annual Report which is available to all shareholders;
- other periodic reports which are lodged with ASX and available for shareholder scrutiny;
- other announcements made in accordance with ASX Listing Rules;
- special purpose information memoranda issued to shareholders as appropriate;
- the Annual General Meeting and other meetings called to obtain approval for board action as appropriate; and,
- The Company's website.

Share Trading

Dealings are not permitted at any time whilst in the possession of price sensitive information not already available to the market. In addition, the Corporations Act 2001 prohibits the purchase or sale of securities whilst a person is in possession of inside information.

External Auditors

The external auditor is In.Corp Audit & Assurance Pty Ltd. The external auditors are invited to attend the annual general meeting and be available to answer shareholder questions about the conduct of the audit and the preparation and content of the auditor's report.

Notes to the Financial Statements

1. MATERIAL ACCOUNTING POLICY INFORMATION

(a) Basis of preparation

The financial statements of Cullen Resources Limited ("Consolidated Entity" or "The Company") are general purpose financial statements, which have been prepared in accordance with the requirements of the Corporations Act 2001, and Australian Accounting Standards. The financial statements have also been prepared in accordance with the historical cost convention using the accounting policies described below.

The financial report of Cullen Resources Limited for the year ended 30 June 2026 was authorised for issue in accordance with a resolution of the directors on 24 September 2026.

Cullen Resources Limited is a for profit company limited by shares incorporated in Australia whose shares are publicly traded on the Australian Stock Exchange.

Going Concern

The accounts have been prepared on the going concern basis, which contemplates continuity of normal business activities and the realisation of assets and liabilities in the normal course of business.

The Directors are aware that the Group's ability to continue as a going concern, and its ability to pay its debts as and when they fall due, is largely dependent on successfully managing its short to medium term liquidity position.

As at 30 June 2026 the Consolidated Entity had current assets of \$314,403 and cash and cash equivalents of \$ 293,461. The directors acknowledge that continued exploration and development of the Consolidated Entity's mineral exploration projects will necessitate further capital raisings.

The Consolidated Entity remains dependent on its ability to raise funding in volatile capital markets. However, the directors continue to believe that the going concern basis of accounting by the Consolidated Entity is appropriate as the Consolidated Entity successfully completed a capital raising during the year to 30 June 2025, notwithstanding the challenging conditions in equity markets.

Since the end of the financial year the Consolidated Entity sold the two Bromus tenements for \$100,000 cash and \$350,000 of shares in Sinclair Gold Limited.

In consideration of the above matters, the directors have determined that it is reasonably foreseeable that the Consolidated Entity will continue as going concern and that it is appropriate that the going concern method of accounting be adopted in the preparation of the financial statements. In the event that the Consolidated Entity is unable to continue as a going concern (due to inability to raise future funding requirements), there is a material uncertainty that the Consolidated Entity will be able to continue as a going concern, and therefore, it may be required to realise its assets at amounts different to those currently recognised, settle liabilities other than in the ordinary course of business and make provisions for other costs which may arise as a result of cessation or curtailment of normal business operations.

Accordingly, the financial statements do not include adjustments relating to the recoverability and classification of assets amount or to the amounts and classification of liabilities that might be necessary if the Consolidated Entity does not continue a going concern.

(b) Statement of compliance

The financial statements comply with Australian Accounting Standards as issued by the Australian Accounting Standards Board and International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB).

(c) Accounting policies and disclosures

The Consolidated Entity has adopted all new and amended Australian Accounting Standards and AASB interpretations, which were applicable as of 1 July 2025. Adoption of other new and amended Australian Accounting Standards and AASB interpretations did not have any effect on the financial position or performance of the Consolidated Entity.

The Consolidated Entity has not elected to early adopt any new standards or amendments.

(d) Exploration and Evaluation Expenditure

(i) Expenditure is written off

Expenditure on exploration and evaluation is expensed through the Statement of Profit or Loss and Other Comprehensive income unless it is capitalised in accordance with d(ii) below.

(ii) Expenditure is deferred

Expenditure on exploration and evaluation is accounted for in accordance with the 'area of interest' method. Exploration and evaluation expenditure is capitalised provided the rights to tenure of the area of interest is current (or in the process of being re-applied for) and either:

- the exploration and evaluation activities are expected to be recouped through successful development and exploitation of the area of interest or, alternatively, by its sale; or
- exploration and evaluation activities in the area of interest have not at the reporting date reached a stage that permits a reasonable assessment of the existence or otherwise of economically recoverable reserves, and active and significant operations in, or relating to, the area of interest are continuing.

When the technical feasibility and commercial viability of extracting a mineral resource have been demonstrated then any capitalised exploration and evaluation expenditure is reclassified as capitalised mine development. Prior to reclassification, capitalised exploration and evaluation expenditure is assessed for impairment.

Impairment

The carrying value of capitalised exploration and evaluation expenditure is assessed for impairment at the area of interest level whenever facts and circumstances suggest that the carrying amount of the asset may exceed its recoverable amount.

An impairment exists when the carrying amount of an area of interest exceeds its estimated recoverable amount. The area of interest is then written down to its recoverable amount. Any impairment losses are recognised in the Consolidated Statement of Profit or Loss and Other Comprehensive Income.

(e) Intangible Assets

The Consolidated Entity's intangible assets represent the deferred consideration payable by the acquirer on the unconditional final investment decision to proceed and royalties on all iron ore extracted from the area of the tenements of the Mt Stuart Iron Ore Joint Venture.

These, although entitling the Consolidated Entity to cash upon the unconditional final investment decision to proceed and the commencement of production, are not considered to fall within the definition of financial assets in accordance with AASB 9 *Financial Instruments* ("AASB 9"). The Consolidated Entity considers, amongst the characteristics listed in AASB 9 that they do not contain an absolute right to receive cash as the Consolidated Entity cannot force the owner to make the investment decision to proceed and to produce and, furthermore, the counterparty can avoid the payment of cash by deciding not to proceed.

The useful life of the intangible assets will be determined by reference to planned development schedule and mine life on commencement of mining and the cost of the royalty contract will be amortised on a systematic basis over the life of the mine. Amortisation rates are adjusted on a prospective basis for all changes to estimates of the life of mine. At 30 June 2026, the decision to proceed has not been made and hence the assets remain unamortised.

(f) Revenue

Other revenue includes interest revenue on short term deposit received. Interest revenue is brought to account using the effective interest rate method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Revenue from Joint Venture agreements is brought to account when the funds are received.

(g) Joint Operations

The Consolidated Entity undertakes a number of activities through joint arrangements. A joint arrangement is an arrangement over which two or more parties have joint control. Joint control is the contractually agreed sharing of control over an arrangement which exists only when the decisions about the relevant activities (being those that significantly affect the returns of the arrangement) require the unanimous consent of the parties sharing control. The Consolidated Entity's joint arrangements are in the form of joint operations.

A joint operation is a type of joint arrangement in which the parties with joint control of the arrangement have rights to the assets and obligations for the liabilities relating to the arrangement.

The Consolidated Entity recognises in relation to its joint operations:

- Assets, including its share of any assets held jointly

- Liabilities, including its share of any liabilities incurred jointly
- Revenue from the sale of its share of the output arising from the joint operation
- Share of the revenue from the sale of the output by the joint operation
- Expenses, including its share of any expenses incurred jointly

(h) Share based payments

At each subsequent reporting date until vesting, the cumulative charge to the Consolidated Statement of Profit or Loss and Other Comprehensive Income is the product of:

- (i) The grant date fair value of the option.
- (ii) The current best estimate of the number of options that will vest, taking into account such factors as the likelihood of employee turnover during the vesting period and the likelihood of non-market performance conditions being met.
- (iii) The expired portion of the vesting period.

The charge to the Consolidated Statement of Profit or Loss and Other Comprehensive Income for the period is the cumulative amount as calculated above less the amounts already charged in previous periods. There is a corresponding entry to equity.

The company may also issue options that do not have any vesting conditions.

Until an option has vested, any amounts recorded are contingent and will be adjusted if more or fewer options vest than were originally anticipated to do so. Any option subject to a market condition is considered to vest irrespective of whether or not that market condition is fulfilled, provided that all other conditions are satisfied.

If the terms of an equity-settled option are modified, as a minimum an expense is recognised as if the terms had not been modified. An additional expense is recognised for any modification that increases the total fair value of the share-based payment arrangement, or is otherwise beneficial to the employee, as measured at the date of modification.

If an equity-settled option is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the option is recognised immediately. However, if a new option is substituted for the cancelled option and designated as a replacement option on the date that it is granted, the cancelled and new option are treated as if they were a modification of the original option, as described in the previous paragraph.

The dilutive effect, if any, of outstanding options is reflected as additional share dilution in the computation of diluted earnings per share.

2. SIGNIFICANT ACCOUNTING ESTIMATES AND ASSUMPTIONS

In applying the Consolidated Entity's accounting policies management continually evaluates estimates and assumptions based on experience and other factors, including expectations of future events that may have an impact on the Consolidated Entity. All estimates and assumptions made are believed to be reasonable based on the most current set of circumstances available to management. Actual results may differ from the estimates and assumptions. Significant estimates and assumptions made by the management in the preparation of these financial statements are outlined below.

Significant accounting estimates and assumptions

The carrying amounts of certain assets and liabilities are often determined based on estimates and assumptions of future events. The key estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of certain assets and liabilities within the next annual reporting period are:

(a) Impairment of capitalised exploration and evaluation expenditure

The future recoverability of capitalised exploration expenditure is dependent on a number of factors, including whether the Consolidated Entity decides to exploit the related lease itself or, if not, whether it successfully recovers the related exploration and evaluation asset through sale. Factors that could impact the future recoverability include the level of reserves and resources, future technological changes, which could impact the cost of mining, future legal changes (including changes to environmental restoration obligations) and changes to commodity prices. To the extent that capitalised exploration and evaluation expenditure is determined not to be recoverable in the future, profits and net assets will be reduced in the period in which this determination is made. In addition, exploration and evaluation is capitalised if activities in the area of interest have not yet reached a stage that permits a reasonable assessment of the existence or otherwise of economically recoverable reserves. To the extent it is determined in the future that this capitalised expenditure should be written off, profits and net assets will be reduced in the period in which this determination is made.

(b) Share-based payment transactions

The Consolidated Entity measures the cost of equity-settled transactions with employees by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by an external valuer using either a binomial or Black-Scholes model, with the assumptions detailed in Note 16. The accounting estimates and assumptions relating to equity-settled share-based payments would have no impact on the carrying amount of assets and liabilities within the next annual reporting period but may impact expenses and equity.

(c) Intangibles

The recoverable amount of intangible assets is estimated on the basis of the discounted value of future cash flows. The estimates of future cash flows are based on significant assumptions including:

- timing of the unconditional investment decision to proceed;
- estimates of the quantities of ore reserves and mineral resources for which there is a high degree of confidence of economic extraction and the timing of access to these reserves and resources;
- future iron ore prices and exchange rates based on forecasts by a range of recognized economic forecasters as well as recent spot prices and rates;
- construction and production timetable and production rates; and
- the discount rate used.

As discussed in the Directors Report, during the financial year, the Company continued its mineral exploration activities including: project generation, database reviews, field mapping, geochemical surveying, and drilling programmes. Company exploration activities, including joint operations, were focused in Western Australia with additional activities in Finland.

A total of \$776,040 (2025: \$617,949) of exploration expenditure was capitalised by Cullen during the year. The Directors have reviewed all exploration projects for indicators of impairment in light of approved budgets. Where substantive expenditure is neither budgeted nor planned the area of interest has been written down to its fair value less costs to dispose. In determining fair value less cost of disposal the Directors had regard to the best evidence of what a willing participant would pay in an arms length transaction (Level 3 fair value hierarchy). Where no such evidence was available, areas of interest were written down to nil pending the outcome of any future farm-out arrangement. This resulted in a write off of \$794,113 (2025: \$600,771). The Company will continue to look to attract farm-in partners and/or recommence exploration should circumstances change.

The ultimate recoupment of the book value of deferred costs relating to areas of interest in the exploration and evaluation phase is dependent upon the successful development and commercial exploitation or, alternatively, sale of the respective areas of interest and the Consolidated Entity's ability to continue to meet its financial obligations to maintain the areas of interest.

On 12 April 2017, the consolidated entity sold its 30% contributing interest in the Mt Stuart Iron Ore Joint Venture and all of its other rights and interests in the Joint Venture tenements. Part of the consideration includes:

- (a) A deferred consideration of \$1 million payable on the making of an unconditional final investment decision to proceed with the development of an iron ore mine on the tenements which were previously the Mt Stuart Joint Venture.
- (b) An uncapped 1% FOB royalty on all iron ore extracted from the area of the Joint Venture tenements.

At the disposal date, the above consideration was recognised as an intangible asset. Its carrying value was determined based on a Net Present Value calculation using a discounted cash flow model with a number of assumptions including timing of unconditional investment decisions to proceed, future iron ore prices, exchange rate, timing for the development and production, future product volumes and discount rates (Level 3 fair value hierarchy).

As at 30 June 2026, the directors have adopted a similar Net Present Value calculation with updated key assumptions to reflect changes in the market environment to determine the recoverable amount of the intangible asset as part of their impairment assessment of the carrying value of the asset. In the directors opinion, this assessment supports the carrying value of the assets and supports the conclusion that no impairment of the intangible asset is required as at 30 June 2026.

In July 2015 the Consolidated Entity sold its interest in the Wyloo project tenements to its partner Fortescue Metals Group Limited and the deferred consideration is a 1.5 % F.O.B. royalty up to 15 Mt of iron ore production from Wyloo project tenements, and will receive \$900,000 cash if and when a decision is made to commence mining on a commercial basis – E47/1649, 1650, ML 47/1490, and ML 08/502. No value had been brought to account in respect to this royalty.

During the financial year the Consolidated Entity sold its 1.5 % F.O.B. royalty on up to 15 Mt of iron ore production from Wyloo project tenements, for \$1.5m to Vox Royalty Corp. The Consolidated Entity is still entitled to the cash payment \$900,000 if and when a decision is made to commence mining on a commercial basis. No value in respect to this payment has been brought to account.

In estimating the recoverability of these assets as at 30 June 2026, the directors used a discounted cash flow model with a number of assumptions as to the timing and quantum of future cash flows. The directors have determined that the discounted cash flow model supports the carrying value of these assets.

For the audit of the Group's financial report for the year ended 30 June 2026, we have been unable to obtain sufficient appropriate audit evidence to assess the reasonableness of the directors' assumptions adopted in determining the carrying value of these assets. Consequently, we are unable to determine the accuracy and appropriateness of the carrying value of these assets, their classification and related disclosures as disclosed in the financial report.

The Group's audit report for the year ended 30 June 2025 was similarly qualified in relation to this matter.
