### **REQUEST FOR TRADING HALT**

xReality Group Limited (ASX: XRG) (the **Company**) requests an immediate halt to the trading of the Company's securities (ASX: XRG) quoted on the Australian Securities Exchange (**ASX**) in accordance with ASX Listing Rule 17.1.

The trading halt is requested pending an announcement by the Company to the market in relation to revisions to the Company's previously reported preliminary financial results for the year ended 30 June 2026, the lodgement of an amended Appendix 4E, and the timing to finalise and lodge its audited annual report by the ASX reporting deadline of 30 September 2026. (Stated Purpose).

In accordance with ASX Listing Rule 17.1, the Company provides the following information in relation to the request:

1. The trading halt is necessary to assist the Company in managing its continuous disclosure obligations under ASX Listing Rule 3.1 prior to the Company making an announcement to the market in relation to the Stated Purpose above. The Company has identified adjustments to the financial information contained in the Appendix 4E for the year ended 30 June 2026 given to ASX on 31 August 2026 which are material and which have not yet been notified to the market.
2. As a consequence of those matters, the audit of the Company's financial report for the year ended 30 June 2026 is ongoing. The Company has identified a material risk that it may not be in a position to finalise and lodge its audited annual report by the ASX reporting deadline of 30 September 2026, being the date required under ASX Listing Rule 4.5.
3. The Company requests that the trading halt remains in place until the earlier of the commencement of normal trading on Tuesday, 29 September 2026, or when the announcement regarding the Stated Purpose is released to the market.
4. The Company expects to make the announcement to the market before the commencement of normal trading on Tuesday, 29 September 2026.
5. The Company is not aware of any reason why the trading halt should not be granted or of any further information necessary to inform the market about the trading halt.
